- 1 A BILL FOR AN ACT relating to holidays; to amend sections 25-2221 and
- 2 62-301, Revised Statutes Cumulative Supplement, 2022; to establish
- 3 El-Hajj Malik El-Shabazz, Malcolm X Day; to change provisions
- 4 relating to holidays; and to repeal the original sections.
- 5 Be it enacted by the people of the State of Nebraska,

LB53 2023

- 1 Section 1. (1) May 19 of each year shall be El-Hajj Malik El-
- 2 Shabazz, Malcolm X Day, and shall be set apart for holding suitable
- 3 exercises in the schools of the state in recognition of the sacrifices of
- 4 the late Nebraska Hall of Fame inductee El-Hajj Malik El-Shabazz, Malcolm
- 5 X and his contributions to the betterment of society.
- 6 (2) The Governor shall, prior to May 19 of each year, issue a
- 7 proclamation inviting and urging the people of the State of Nebraska to
- 8 <u>observe El-Hajj Malik El-Shabazz, Malcolm X Day in schools and other</u>
- 9 suitable places with appropriate ceremony and fellowship.
- 10 (3) The State Department of Education is directed to make, within
- 11 the limits of funds available for such purpose, information available to
- 12 the schools and all people of this state regarding El-Hajj Malik El-
- 13 <u>Shabazz, Malcolm X Day and the observance thereof.</u>
- 14 Sec. 2. Section 25-2221, Revised Statutes Cumulative Supplement,
- 15 2022, is amended to read:
- 16 25-2221 Except as may be otherwise more specifically provided, the
- 17 period of time within which an act is to be done in any action or
- 18 proceeding shall be computed by excluding the day of the act, event, or
- 19 default after which the designated period of time begins to run. The last
- 20 day of the period so computed shall be included unless it is a Saturday,
- 21 a Sunday, or a day during which the offices of courts of record may be
- 22 legally closed as provided in this section, in which event the period
- 23 shall run until the end of the next day on which the office will be open.
- 24 All courts and their offices may be closed on Saturdays, Sundays,
- 25 days on which a specifically designated court is closed by order of the
- 26 Chief Justice of the Supreme Court, and these holidays: New Year's Day,
- 27 January 1; Birthday of Martin Luther King, Jr., the third Monday in
- 28 January; President's Day, the third Monday in February; Arbor Day, the
- 29 last Friday in April; <u>Birthday of El-Hajj Malik El-Shabazz, Malcolm X,</u>
- 30 May 19; Memorial Day, the last Monday in May; Juneteenth National
- 31 Independence Day, June 19; Independence Day, July 4; Labor Day, the first

- 1 Monday in September; Indigenous Peoples' Day and Columbus Day, the second
- 2 Monday in October; Veterans Day, November 11; Thanksgiving Day, the
- 3 fourth Thursday in November; the day after Thanksgiving; Christmas Day,
- 4 December 25; and all days declared by law or proclamation of the Governor
- 5 to be holidays. Such days shall be designated as nonjudicial days. If any
- 6 such holiday falls on Sunday, the following Monday shall be a holiday. If
- 7 any such holiday falls on Saturday, the preceding Friday shall be a
- 8 holiday. Court services shall be available on all other days. If the date
- 9 designated by the state for observance of any legal holiday pursuant to
- 10 this section, except Veterans Day, is different from the date of
- 11 observance of such holiday pursuant to a federal holiday schedule, the
- 12 federal holiday schedule shall be observed.
- 13 Sec. 3. Section 62-301, Revised Statutes Cumulative Supplement,
- 14 2022, is amended to read:
- 15 62-301 (1) For the purposes of the Uniform Commercial Code and
- 16 section 62-301.01, the following days shall be holidays: New Year's Day,
- 17 January 1; Birthday of Martin Luther King, Jr., the third Monday in
- 18 January; President's Day, the third Monday in February; Arbor Day, the
- 19 last Friday in April; Birthday of El-Hajj Malik El-Shabazz, Malcolm X,
- 20 May 19; Memorial Day, the last Monday in May; Juneteenth National
- 21 Independence Day, June 19; Independence Day, July 4; Labor Day, the first
- 22 Monday in September; Indigenous Peoples' Day and Columbus Day, the second
- 23 Monday in October; Veterans Day, November 11, and the federally
- 24 recognized holiday therefor, or either of them; Thanksgiving Day, the
- 25 fourth Thursday in November; the day after Thanksgiving; and Christmas
- 26 Day, December 25. If any such holiday falls on Sunday, the following
- 27 Monday shall be a holiday. If the date designated by the state for
- 28 observance of any legal holiday enumerated in this section, except
- 29 Veterans Day, is different from the date of observance of such holiday
- 30 pursuant to a federal holiday schedule, the federal holiday schedule
- 31 shall be observed.

- 1 (2) Any bank doing business in this state may, by a brief written
- 2 notice at, on, or near its front door, fully dispense with or restrict,
- 3 to such extent as it may determine, the hours within which it will be
- 4 open for business.
- 5 (3) Any bank may close on Saturday if it states such fact by a brief
- 6 written notice at, on, or near its front door. When such bank will, in
- 7 observance of such a notice, not be open for general business, such day
- 8 shall, with respect to the particular bank, be the equivalent of a
- 9 holiday as fully as if such day were listed in subsection (1) of this
- 10 section, and any act authorized, required, or permitted to be performed
- 11 at, by, or with respect to such bank which will, in observance of such
- 12 notice, not be open for general business, acting in its own behalf or in
- 13 any capacity whatever, may be performed on the next succeeding business
- 14 day and no liability or loss of rights on the part of any person shall
- 15 result from such delay.
- 16 (4) Any bank which, by the notice provided for by subsection (3) of
- 17 this section, has created the holiday for such bank may, without
- 18 destroying the legal effect of the holiday for it and solely for the
- 19 convenience of its customers, remain open all or part of such day in a
- 20 limited fashion by treating every transaction with its customers on such
- 21 day as though the transaction had taken place immediately upon the
- 22 opening of such bank on the first following business day.
- 23 (5) Whenever the word bank is used in this section it includes
- 24 building and loan association, savings and loan association, credit
- 25 union, savings bank, trust company, investment company, and any other
- 26 type of financial institution.

- 28 Cumulative Supplement, 2022, are repealed.
