AN ACT to amend section 51-202, Revised Statutes Supplement, 1972, relating to a city or village library; to provide for election or appointment of members and their terms of office; to provide no compensation for members of the board; and to repeal the original section.

Fe it enacted by the people of the State of Nebraska,

Section 1. That section 51-202, Revised Statutes Supplement, 1972, he amended to read as follows:

51-202. When any city council or village board shall have decided by ordinance to establish and maintain a public library and reading room under sections 51-201 to 51-219, it-shall-elect a library board of five members to shall be chosen elected or appointed from the citizens at large, of which board neither the mayor nor any member of the city council or village toard shall be a member. The directors <u>members</u> first elected <u>or appointed</u> shall hold their office, three for terms of four years, and two for terms of two years from the first day of July following their <u>appointment</u> or election, and successors shall serve four-year terms; <u>Provided</u>. their that the city council or village board may by ordinance make the terms of members of the library board for a period of two years.

The term of membership on the board which is to expire in 1971 is hereby extended to 1972. At the election in 1972, two members shall be elected for four-year terms. The term of membership on the board which is to expire in 1973 is hereby extended to 1974. At the election in 1974 and every fourth year thereafter, two members shall be elected or appointed for four-year terms. The term of membership on the board which is to expire in 1975 is hereby extended to 1976. At—the election—in In 1976, and every fourth year thereafter, three members shall be elected or appointed for four-year terms. In cases of vacancies by resignation, removal, or otherwise, the city council or village board shall fill such vacancy for the unexpired term. Cities having home rule charters shall have the power to fix by crdinance

the number of members and length of terms of members of such library boards. No director member shall receive any pay or compensation for any services rendered as a member of the board.

The city council of village heard at its regular meeting in January of every even-numbered year shall by crdinance adort the manner in which the library leard of five members is to be chosen. If the city council of village heard by ordinance provides for appointment of the members to the library leard, such library beard members shall be appointed by a majority vote of the members of the city council or village heard. If the municipal election is to be held in conjunction with the statewide primary, the election shall be held as provided in Chapter 32.

If the toard members are to be elected, the city council or village board shall give public notice of such election after the adortion of such ordinance naming the offices to be filled, the length of terms, and the filling deadline for the placing of names of candidates on the ballot.

Sec. 2. That original section 51-202, Revised Statutes Supplement, 1972, is repealed.
