AN ACT to amend section 72-1249, Revised Statutes Supplement, 1976, relating to the state investment officer; to eliminate a cash fund; and to repeal the original section, and also section 72-1249.01, Revised Statutes Supplement, 1976.

Be it enacted by the people of the State of Nebraska,

Section 1. That section 72-1249, Revised Statutes Supplement, 1976, be amended to read as follows:

72-1249. Any expenses with respect to the purchase, sale, or exchange of any security shall be charged to the fund or funds on behalf of which such purchase, sale, or exchange was made. All-expenses incurred-in-the-management-of-long-term-investment-funds shall-be-paid-from-the-State-Investment-Officer's-Gash Fund--established--by--section--72-1249:01. All other expenses of the state investment officer shall be paid out of appropriations from-the-General--Fund for the office of the state investment officer.

Sec. 2. That original section 72-1249, Revised Statutes Supplement, 1976, and also section 72-1249.01, Revised Statutes Supplement, 1976, are repealed.
