Sec. 78. Revolving Funds.

The receipts for the period of July 1, 1983, to June 30, 1984, inuring to the several revolving funds, together with any amounts held in account by the State Treasurer on June 30, 1983, are hereby credited to each of the funds respectively. Expenditure revolving funds appropriated in this act shall limited to the amount shown by program except when specific exceptions are made. The amounts appropriated in this act include the following funds:
