## LEGISLATIVE BILL 369

Approved by the Governor April 11, 1988

AN ACT relating to cities and villages; to amend sections 18-1201, 18-1202, and 18-1708, Reissue Revised Statutes of Nebraska, 1943; to change provisions relating to the use of certain revenue; to eliminate a restriction on the location of fire engine houses or stations; to harmonize provisions; and to repeal the original sections, and also section 18-1710, Reissue Revised Statutes of Nebraska, 1943.

Be it enacted by the people of the State of Nebraska,

Section 1. That section 18-1201, Reissue Revised Statutes of Nebraska, 1943, be amended to read as follows:

18-1201. All cities and villages, organized under the laws of the State of Nebraska, shall have the power and authority to may levy a special tax each year of not more than three and five-tenths cents on each one hundred dollars upon the actual value of all the taxable property in such city or village, except intangible property, for the special purposes set forth herein in this section. Such special levy shall be made by the same officers or board and be levied in the same manner general city or village taxes. Revenue raised by such a special levy may be used only for the purposes of purchasing and maintaining <u>public safety</u> equipment, including, but not limited to, vehicles or rescue or emergency first-aid equipment for a fire or police department of such city or village, for purchase of purchasing real estate for fire or police station quarters or facilities, for fire station quarters, or facilities, for fire station quarters, or repairing of fire or police station quarters or facilities, or repairing of fire or police station quarters or facilities, or for purchasing, installing, and equipping a fire an emergency alarm or communication system. system, or the payment of for paying off bonds authorized by section 18-1202. Such revenue may be accumulated in a sinking fund or sinking funds to be

used for any such purpose.

Sec. 2. That section 18-1202, Reissue Revised Statutes of Nebraska, 1943, be amended to read as follows:

18-1202. Any city or village which has levied or intends to levy a tax as authorized by section 18-1201 for the purposes stated in such section may anticipate the collection of such taxes, including the anticipation of collections from levies to be made in future years, and for such purpose may issue tax anticipation bonds, which shall be payable in not exceeding twenty years and may bear interest, payable annually or semiannually, at such rate or rates as the mayor and council or ehairman chairperson and board of trustees may determine. The total of principal and interest payable on such bonds in any calendar year shall not exceed ninety percent of the anticipated tax collection for such calendar year on the assumption that the actual valuation for such city or village in all succeeding years shall be the same as the actual valuation most recently determined prior to passage of the ordinance authorizing such bonds and applying the levy made or agreed to be made by the city or village, but not exceeding three and five-tenths cents on each one hundred dollars, and using tax due and delinquency dates in effect at the time of passage of the bond ordinance. The city or village may agree in such bond ordinance to make and to continue to make a levy under section 18-1201 until such bonds and interest thereon are fully paid. Such bonds shall be secured by such tax so assessed and levied, and shall be payable only out of the funds derived from such tax. It shall be the duty of such city or village on receipt of such taxes to hold the same as a separate fund to the amount of the bonds so issued and the interest thereon, for the purpose of paying or redeeming such bonds.

Sec. 3. That section 18-1708, Reissue Revised Statutes of Nebraska, 1943, be amended to read as follows:

18-1708. All municipal employees serving outside the corporate limits of the municipality as authorized in sections 18-1706 to 18-1719 18-1709 shall be considered and held as serving in their regular line of duties as fully as if they were serving within the corporate limits of their own municipality.

Sec. 4. That original sections 18-1201, 18-1202, and 18-1708, Reissue Revised Statutes of Nebraska, 1943, and also section 18-1710, Reissue Revised Statutes of Nebraska, 1943, are repealed.
