LB 1092 is the Online Age Verification Liability Act. It aims to regulate the distribution of material harmful to minors on the internet by requiring commercial entities to implement reasonable age verification methods. It defines terms such as "commercial entity," "digitized identification card," "material harmful to minors," and outlines the responsibilities of commercial entities to prevent minors' access to harmful material. The act allows for civil action against entities that violate its provisions, specifying possible relief including damages and litigation costs. It exempts news-gathering organizations and internet utilities that do not create harmful content from its requirements.

The Supreme Court estimates minimal fiscal impact to provide judicial education.
