LB 845 focuses on the Uniform Residential Landlord and Tenant Act. It amends existing statutes to prohibit the eviction of certain tenants during the school year. The bill sets out specific conditions under which a tenant, particularly those with children or those employed by schools, cannot be evicted during the academic year.

## Expenditures:

The Supreme Court would have to make modifications to subsystems to the Judicial Branch case management system (JUSTICE) for a \$10,000 one-time Cash Fund for FY24-25.
