LB 1045 amends legislative intent behind the Jury Selection Act amendment. The bill includes provisions relating to peremptory challenges and prohibits discrimination based on group membership, such as race, color, religion, sex, national origin, or economic status, in the jury selection process.

Expenditures:

LB 1045 requires a transcription of voir dire be produced in certain trials. Presently, court reporters are compensated for creating a transcript of court proceedings. Yet, LB1045 does not specify who will be responsible for this payment, further information will be needed to assess any fiscal impact accurately.

Additionally, education for judicial and court staff will be required, which the agency expects to have a minimal fiscal impact.

Explanation of Estimate:

Section 3 of LB1045 requires a transcription be made of voir dire in certain trials. Currently, court reporters are entitled to compensation for producing a transcript of court proceedings. However, it is not clear from LB1045 who will make the payment. Therefore, more information is required before any fiscal impact can be determined.

Judicial and court staff education will also be required which will have minimal fiscal impact.
