LB 1159 amends Section 81-8150 to expand the list of offenses requiring victim notification. This list includes crimes such as manslaughter, motor vehicle homicide, first-degree false imprisonment, assault by strangulation or suffocation, and domestic assault. It also covers crimes involving technology and vulnerable individuals, like child enticement via electronic communication, sexual abuse by school employees, and sexual abuse of protected individuals. Additionally, the bill addresses threats and trafficking, encompassing terroristic threats, sex and labor trafficking, and their corresponding offenses involving minors.
