LB1273 amends §79-215 & §29-2, 136 to change provisions relating to the admission of students & to require each school board to allow certain students that are not residents of the school district to participate in extracurricular activities.

School boards will admit a student who is also enrolled in a private, denominational, or parochial school or in a school which elects not to meet accreditation or approval requirements without charge for part-time enrollment in the school district for purposes of participation in extracurricular activities if that student or at least one parent of the student resides in a neighboring school district & the school district where the student or that student's parent resides does not offer the extracurricular activity that the student desires to participate in through part-time enrollment.

There could be an impact at the school district level but that cannot be determined at this time.
