LB 1293 amends provisions related to the Office of Public Counsel, Office of the Inspector General of Nebraska Child Welfare, and the Office of Inspector General of the Nebraska Correctional System. The bill lists findings of the Legislature related to the constitutional and inherent powers of the Legislature. The bill amends provisions related to appointment of the Public Counsel and the Inspectors General to allow appointment by the Executive Board, rather than by a vote of the Legislature or by the Public Counsel, respectively. The bill eliminates the six-year term for the Public Counsel and the five-year terms of appointment for each Inspector General position. LB 1293 also includes a new section, containing provisions related to the process of issuing subpoenas by the Executive Board and the Public Counsel.
