#### PRESIDENT SHEEHY PRESIDING []

PRESIDENT SHEEHY: Good morning, ladies and gentlemen. Welcome to the George W. Norris Legislative Chamber for the third day, One Hundredth Legislature, First Special Session. Our chaplain for today is Senator Dierks. Would you all please rise. []

SENATOR DIERKS: (Prayer offered.) []

PRESIDENT SHEEHY: Thank you, Senator Dierks. I call to order the third day of the One Hundredth Legislature, First Special Session. Senators, please record your presence by roll call. Please record, Mr. Clerk. []

CLERK: I have a quorum present, Mr. President. []

PRESIDENT SHEEHY: Are there corrections for the Journal? []

CLERK: I have no corrections. []

PRESIDENT SHEEHY: Messages, reports, or announcements? []

CLERK: Mr. President, an Attorney General's Opinion (re LB3) addressed to Senator Flood to be inserted in the Legislative Journal; an amendment to be printed to LB1 by Senator Langemeier. That's all that I have at this time. (Legislative Journal pages 43-50.) [LB3 LB1]

PRESIDENT SHEEHY: Thank you, Mr. Clerk. We will move to the first item on the agenda, introduction of new bills. Mr. Clerk, do you have items for introduction? []

CLERK: At this time, Mr. President, I have no new bills for introduction. []

PRESIDENT SHEEHY: Thank you, Mr. Clerk. Senators, we will stand at ease while we wait for introduction of new bills. Senator Chambers, you are recognized for a point of order. []

SENATOR CHAMBERS: Thank you. Mr. President, members of the Legislature, I would like to take a point of personal privilege. Saturday, former State Senator Bernice Labedz died. She served during the years of 1976 to 1992. Senator Labedz and I had a maybe-love/maybe-not relationship. We had collisions; we had collaboration, Senator Aguilar. Our collisions were Titanic; our collaborations were virtually divine. When she and I collaborated on something, it was about a cinch to go through. She died of congestive heart failure, which proves something that I can now say. I used to wonder if

both of us was without a heart. This proves she had what I still don't have and that is a heart, so you all may not be rid of me ever. What I found out was Senator Labedz's age, which was 89. When I was a youngster like the rest of you, 89 seemed like a long way off. But now that if I sneeze I'll be right there, it doesn't seem a long way off at all. I would have ordinarily said she had a long life. She had a relatively long life, but in these days 89 is not that long a period of time. And in keeping with her character, she left here when she did because her husband was in failing health and she had a set of priorities, and one of them was to take care of that person to whom she had promised to become one flesh. Some people might see her as the steel fist in the velvet glove, but I prefer the imagery of the peach. On issues that she felt strongly about, she was as hard and unyielding as the stone in the center of that peach. But, Senator Schimek, on other issues she was as soft, tender, and sweet as the flesh of that peach. Unfortunately, I probably got the stone more than I did the flesh. They had called Senator Labedz "Mamma Labedz" because, as the paper pointed out, she had a maternal warmth about her, but there was something else. She could be Mamma when the circumstances called for such, or she could be Medusa, who with a look could turn you to stone. Since brevity is the soul of wit and I would like to be known as a witty person, I have completed what I had to say. But I do want to extend to her family, on behalf of the Legislature, our sincere condolences. And that's all I have. Thank you, Mr. President. []

I would encourage you to stay close to your Internet tonight so that you can see it electronically once it's been posted, but I will have to wait until the Judiciary Committee does take action and notifies my office of the action that they've taken before I can schedule for tomorrow.
