After further review, LB143 does not represent the goals or the intent of where I was headed with that piece of legislation. At this time I would ask for your vote to withdraw it. SENATOR LATHROP: Thank you, Mr. Chair, and I appreciate the fact that Senator Langemeier is withdrawing LB143, and I don't have any objection to that. I would just like to address a concern I had with where the bill was referenced in the first place. The bill contains various criminal and civil immunities. I thought it was properly referenced in Judiciary Committee. And this is actually an accommodation of my concern about where it was referenced, and I just want to make sure that we don't establish a precedence with a bill that is now being withdrawn, that immunities, civil and criminal, go somewhere other than the Judiciary Committee. And with that, I would certainly support his motion to withdraw the bill. [LB143]

SENATOR NELSON: Thank you, Senator. Are there any others wishing to speak? Senator Langemeier, you're recognized to close. Senator Langemeier waives closing.
