Mainly because at the end of the day yesterday on the bracket motion we had a basic stalemate with somewhere in the 20s to bracket and somewhere in the 20s not to, which means there wasn't enough to move forward, there wasn't enough to stop it at that point. I did want to clear up a few things that we had questions on while we're moving along here. According to our bill and according to the people I visited with and the questions that were asked yesterday, the bonding authority was not mandatory, it's an option. A city or the county chooses whether or not to approve such bonding authority in the establishment of that district. Also, as far as the property owners, their renters, renters move and they are not invested in the property, so it's an appropriate action to have the vote be by the property owners and not the business owners. Because even though property owners may reside outside the district, or even outside the state, they are the invested parties in the district. We had some questions about the power and light district in Kansas City. It actually is not a CID, but it's an entertainment district. And as far as debts are incurred, the city chose to invest in that and take on that debt along with them. So it's kind of a combination. It's a little different, but it's an example of what can be done. Also, upon ordinance it's not just a yea or nay in black and white. They can approve the district with a specific request and at the same time have some authority to cooperative agreements if they request, but this would not impose indebtedness upon them. I think what we can do is we can go have a hearing on this. And whether it comes back or not, that is irrelevant to the fact that we weren't able to move it on yesterday. But I think we can at least keep the idea alive long enough to discuss some things with Senator Cornett and the Revenue

Committee and Senator McGill and the Urban Affairs Committee and those interested parties. So I do support this motion. I look forward to the continued discussion about this, this year, and if need be, in the future years to come. Thank you, Mr. President. [LB381]

PRESIDENT SHEEHY: Thank you, Senator Rogert. Senator Stuthman, you're recognized. [LB381]

SENATOR STUTHMAN: Thank you, Lieutenant Governor and members of the body. First of all. I would just like to mention to the members of the body, I think we had fairly good debate yesterday, discussion. But the question and the concern that I have is the fact that...I want to give you a little background on this bill. This bill was referenced to the Government Committee on January 21 of '09, page 220 in the Journal. On January 23 of '09 the Reference Committee rereferenced it to the Urban Committee. So there was attention drawn to this bill, LB381, at that time. It was originally referenced to the Government Committee, then it was rereferenced to the Urban Committee. Why didn't it get referenced to the Revenue Committee at that time, if that's where this bill was supposed to go? Now we're trying to set an example and say, you know, it should have went there. We dealt with it on January 23, the Reference Committee, chaired by Senator Wightman, rereferenced this bill to the Urban Affairs Committee. That bill had a hearing, February 24 of '09. And this year, on February 19, 2010, it was advanced to General File. All of a sudden now we bring up the issue it went to the wrong committee. And the question that I have and the real concern that I have is the process here. The process that the Chair and the Reference Committee approved the fact of rereferencing it to the Urban Affairs Committee. If that wasn't the right place at that time, why wasn't the issue drawn to the attention of the people on the Reference Committee to reference it to the Revenue Committee? They must have in good faith felt that it was going to the right committee. If they moved, if they took a vote, which they did, and rereferenced it to the Urban Affairs Committee and it had a hearing, and all of a sudden when it gets put out on General File then the flags were thrown up. And I would like to ask Senator Wightman a question. [LB381]

PRESIDENT SHEEHY: Senator Wightman, would you yield to Senator Stuthman? [LB381]

SENATOR WIGHTMAN: Yes, I will. [LB381]

SENATOR STUTHMAN: Senator Wightman, I hope you've been listening to my discussion here. Can you tell me, you know, the fact that it was referenced to one committee and then was rereferenced, did the committee take real consideration as to should it be rereferenced to Urban Affairs or what did you do? Then there was a request that it be rereferenced to Urban Affairs and it was rereferenced after that to Urban Affairs. But there was considerable discussion on this, Senator Stuthman. [LB381]

SENATOR STUTHMAN: Okay. If there was considerable discussion on it at that time and members of the Referencing Committee decided that the proper place to go with it, with a decision of Government or Revenue at that time, they decided to put it to Government. Then, then it was decided to be rereferenced to Urban Affairs. Can you give me the vote as far as... [LB381]

PRESIDENT SHEEHY: Senator, you're into your next five minutes. [LB381]

SENATOR STUTHMAN: Okay, thank you, Lieutenant Governor. I want to...I would like to continue with the discussion with Senator Wightman, if he would respond. [LB381]

PRESIDENT SHEEHY: Senator Wightman, would you yield to Senator Stuthman? [LB381]

SENATOR WIGHTMAN: Yes. At the time the rereferencing committee was to Urban Affairs, it was a unanimous vote. [LB381]

SENATOR STUTHMAN: It was a unanimous vote. So in other words, in other words, the discussion and the debate on the initial referencing from either/or Government or Revenue, the vote was to go to Government. Then when an individual decided to have it rereferenced to Urban Affairs it was a unanimous vote, it was a unanimous vote of the Referencing Committee, not even considering the fact that Revenue was in consideration of the first determination of where it should go. But when it got requested to be rereferenced to the Urban Affairs Committee, it was unanimous. That is the issue

that I have a real, real concern with of what is happening here. The direction set by the Executive...well, it wasn't the Executive Board, it was the members of the Referencing Committee that they didn't even consider going back to the Revenue Committee what we're attempting to do here a year and a couple of months later. And it is a real concern of mine. And the fact that we're this late in the session, maybe it should have gone to Revenue Committee. They have a tendency to kill those bills, I have the experience of that happening. I just feel that we are setting a precedence of an issue that somebody says, oh my gosh, I think that should have went someplace else, and it gets considered and it heads there. Is this what this legislative body is about? I think we had fair debate yesterday. And it doesn't bother me a bit if it don't pass. But we had the debate, we gave it an opportunity. I just think that the fact that we are coming up at this time of the session when the hearings, as of today the hearings are officially over. We start full day debate next week. And now we're putting something back just because we have a group that feels it was referenced wrong. But I think we have a respectable group on the Referencing Committee that I think they did the right thing. It's upsetting to me to see what we're doing and what we're dealing with here right now. The fact of someone coming up and saying, you know, that went to the wrong committee, a year and a couple of months later. Why in the world didn't that take place a year ago? So I, you know, I know it really doesn't make a lot of difference to me if it gets rereferenced. I know it's not going to go anywhere. But I appreciate the fact that it did have an opportunity to get debated on the floor. And maybe it should have taken its licks and got either passed or voted down. I'm sure it would have been voted down because there was enough, you know, opposition to it that it wouldn't have passed. But now all of a sudden, let's just rereference it. Let's set another hearing date. [LB381]

PRESIDENT SHEEHY: One minute. [LB381]

SENATOR STUTHMAN: And that is very much a concern of mine. So I'm just...I know the Speaker can allow things to happen at his discretion. But in my opinion, it's a policy that we're setting here and the respect to the Referencing Committee on the judgment that they utilized and what they have decided a year or so ago. PRESIDENT SHEEHY: The motion is adopted. We will now proceed to the next item under General File, 2010 senator priority bills, White division, LB817. [LB381 LB817]

CLERK: LB817, a bill by Senator Rogert. (Read title.) The bill was introduced on January 8 of this year, at that time referred to the Judiciary Committee. The bill was advanced to General File. I do have committee amendments by the Judiciary Committee. (AM1964, Legislative Journal page 574.) [LB817]

PRESIDENT SHEEHY: Thank you, Mr. Clerk. Senator Rogert, you're recognized to open on LB817. [LB817]

SENATOR ROGERT: Thank you, Mr. President. Good morning, members of the body. Once again, in an attempt to grab as much publicity as I can this week, here we go, LB817. Today is going to become a fairly well amended bill. With the amendments, LB817 is a measure that combines several initiatives intended to improve Nebraska statutes concerning the possession, purchase, and use of firearms in the state. The essential provisions are as follows, some of these will be amendments, but I just wanted to make you aware of them. The 1,045 holders of Nebraska concealed handgun permits in Nebraska would be excused from the requirement to obtain a Nebraska handgun purchase permit in order to buy a handgun. The handgun purchase permit came into being prior to the initiation of our concealed carry legislation. Under federal legislation of the present National Instant Check System, the NICS, under this system any handgun purchaser, including concealed carry permitholders, both presently and after LB817 is enacted, completes a federal background questionnaire with the firearms dealer, then telephones an office of the FBI where the record check is performed prior to the purchase being authorized. Though the Legislature has previously considered repealing this state purchase permit, subsequent to the enactment of the National Instant Check System, the firearms community in Nebraska actually opposed the repeal as some private sellers use the Nebraska handgun purchase permit as proof of identity and evidence of a previous background check. With concealed permitholders, however, the use of the handgun purchase permit is totally obviated by the extensive background check such permitholders are subject to before being issued the permit. That background check includes a full set of fingerprints being submitted to the FBI for a federal background check, as well as a criminal background check conducted at the state level. Repealing the requirements for these individuals to apply for, pay for, and obtain a permit, which is significantly less rigorous than that required by the concealed

handgun permit, gives us a rare but welcome opportunity to provide just a little less government and expense for the group of citizens who are the folks who pay to play by the rules and follow the requirements. With the amendment, LB817 will also remove the requirement for the active duty law enforcement personnel to obtain state handgun purchase permit in order to buy a handgun. This came to me prior to the hearing, as the Sheriffs Association supported this measure in an attempt to lessen their workload and save some of the costs. And they in turn said, maybe we ought to have the same provision available, we've gone through probably more training than anybody, so we should be able to buy a handgun without a permit as well. Law enforcement officers have already undergone background checks far more extensive than the handgun permit (inaudible). Again, with the committee amendment, LB817 incorporates provisions of LB905 coming from the committee amendment which extends to first-class cities, prohibitions and penalties provisions designed to prevent drive-by shootings. Last year, when we had a...we moved forward the gun bill from the Judiciary Committee, what we did was we increased the penalty for shooting out of a vehicle in an attempt to deter drive-by shootings in our urban areas. Because we were concerned about hunters, we didn't want to put anybody in prison for life for shooting a coyote out of a vehicle. We excluded everything but a metropolitan and primary class. We were going to put in the first-class cities in this provision. Thanks to Senator Dubas, who has come to us in an attempt to solve issues out in the Grand Island area. In addition, provisions added to LB817 will give us, through the committee amendment, natural resource districts the authority to contract with public law enforcement agencies. Senator Ashford and some others will probably talk about that. Currently, NRDs are prohibited from contracting for security services under law. We have one more amendment coming that will say...it will remove anybody from state law provision, individual who is wholly and legally justified under state statute for the use of deadly force in defense of their own family members, from murder, rape or serious bodily harm for them to be sued civilly, for those legally justified actions. And, I believe, Senator Christensen will talk about those things. Mr. President, I will yield the rest of my time to Senator Fulton, if he would like, since this is his priority this morning. Thank you. [LB817 LB905]

PRESIDENT SHEEHY: Thank you, Senator Rogert. Senator Fulton, you're yielded 5 minutes 40 seconds. [LB817]

SENATOR FULTON: Thank you, Mr. President. Thank you, Senator Rogert. Indeed, on the last couple of days when considering priority bills, I approached Senator Rogert and this was one I had some interest in. The other bill that Senator Christensen had brought forward, I also had some interest in that. So I was able to work with Senator Rogert, Senator Christensen, the Judiciary Committee in order to get these bills put together. The bill, I believe, Senator Dubas had regarding that drive-by shooting in Grand Island only added to this bill and made me appreciate it more. So this really comes down to an issue of making our statutes more clear, more concise, and more understandable with respect to concealed carry which, incidentally, was my priority bill last year. It also adds

an element of public safety for which I thank Senator Dubas. So thank you, Senator Rogert, for bringing this bill. Thank you to the Judiciary Committee for putting it together. And I would ask my colleagues to support LB817 going forward. Thank you, Mr. President. [LB817]

PRESIDENT SHEEHY: Thank you, Senator Fulton. Thank you, Senator Rogert. Speaker Flood, you're recognized for an announcement. [LB817]

SPEAKER FLOOD: Thank you, Mr. President. Good morning, members. A quick note: On Monday we will have full-day debate. We will start Monday at 10:00 a.m. We will recess at noon, we will come back at 1:30 and we will work until 4:00 p.m. in the afternoon, giving committees like Appropriations some additional time to complete their committee work. Other committees and committee chairs are specifically encouraged to hold Exec Sessions at 4:00 p.m., giving you some extra time to process and consider and debate in committee some of the bills that have been referenced to your committee. Starting on Tuesday, we will begin at 9:00 a.m. and continue that for the rest of next week. On Thursday we will work through the noonhour. On Thursday, we will work through the noonhour and we'll give you a better understanding of when we will adjourn for the week on Thursday as we get to Wednesday of next week. So again, starting at 10:00 a.m. on Monday we begin full-day debate. Thank you, Mr. President. []

PRESIDENT SHEEHY: Thank you, Speaker Flood. You have heard the opening to LB817. As was noted, there is a Judiciary Committee amendment, AM1964. Senator Ashford, you're recognized to open. [LB817]

SENATOR ASHFORD: Thank you, Mr. Lieutenant Governor. The committee amendments are twofold. The first committee amendment or the first part of AM1964 would provide that a peace officer, a police officer would not be required or a peace officer is the statutory term, would not be required to obtain a permit to purchase a firearm. Again, the thinking, obviously I'm sure you can guess, was that police officers are thoroughly trained in the use of firearms and they have background checks which far surpass those that would take place with a permit to purchase. And therefore, we decided to, though no one asked us to do it, we decided to exclude peace officers from that requirement. The second part of AM1964 is a very important piece. And this comes to us from Senator Dubas and it involves drive-by shootings. Omaha is not the only city in the state that is plagued with drive-by shootings. And Senator Dubas has indicated that, and Senator Gloor that there are issues in Grand Island, for example, involving assault weapons and drive-by shootings that are very, very serious in their community. And as a result of that and other conversations, the committee decided to add to the provisions of LB63 of last year the crime or offense of drive-by shootings to apply to first-class cities as well as cities of the metropolitan class. Senator...and we won't get to it today, obviously, but Senator Council has an amendment to this amendment which is also, I believe, appropriate that would require that in order to bring a criminal action in

this matter, these types of drive-by shooting matters, that it would be required only that...would be required that there be a showing of recklessness. And there is some confusion in the language that you have before you that reckless was stricken from the committee amendment as you have it. Senator Council has discovered that and has an amendment that she will be bringing to us next week. The point there is that if it's a reckless firing of a firearm in a city, in an urban area, into a building or house that reckless endangerment of life is a sufficient standard to bring an action under AM1964. So on Monday when we look at this again, there will be an amendment from Senator Council regarding drive-by shootings and reckless endangerment of individuals by shooting into a house or building. Let me just conclude, since I have two minutes or so to do so, but I could conclude before that, I suppose, is to say that in the early nineties when I was here and we passed the permit to purchase law it was guite something. There was quite a bit of opposition to the idea of a permit to purchase. And what is interesting to me is that over the years the permit to purchase has become a way of life for law-abiding citizens who purchase handguns and has worked, I believe, to protect our state and the citizens of our state and is viewed by law-abiding citizens and gun owners as a form of protection, to make certain that it is, in fact, law-abiding citizens who are able to purchase handguns in our state. The concealed weapon law, obviously, has many, many more requirements to that permit application process than the permit to purchase had. And therefore it seems a matter of legitimate public policy, as Senator Rogert has said and argued and as the committee felt, that the concealed weapon permit is important and that it does indicate a degree of training that the permit to purchase does not require. Therefore, I wholeheartedly support the idea that a concealed weapon permitholder would not be required to receive...to obtain a permit to purchase a permit as well. There's a gap of two years, a permit to purchase is every three years, a concealed weapon is every five years. However, it's my belief that again the requirements for a concealed weapon permit are sufficient to justify this change in the law, and I wholeheartedly support it. Thank you, Mr. Lieutenant Governor. [LB817] LB63]
