SPEAKER FLOOD: Members, you've heard the motion. There are no members wishing to speak. Senator Langemeier, you're recognized to close. Members, you've heard the motion. All those in favor say aye. Those opposed say nay. The motion is successful. We now proceed to the election of the Urban Affairs Committee Chairperson. The floor is open for nominations. Senator Price, for what reason do you stand? []

SENATOR PRICE: Thank you, Mr. Speaker and members of the body. I humbly submit my name to be Chair of the Urban Affairs Committee. As Chair, I will focus on listening to all the points of view and communicating with you and your constituents. I will strive to maintain the integrity of the committee and this institution. Finally, I will collaborate with all interested parties to create good public policy and to address the issues before the committee. We live in a big state with many different challenges, but I believe we're all striving for the same things--to give our communities the tools they need to serve their citizens. I will take that responsibility seriously and I humbly ask for your vote in favor of my candidacy. Thank you. []

SPEAKER FLOOD: Thank you, Senator Price. Senator McGill, for what reason do you stand? []

SENATOR McGILL: Mr. President, members of the body, I stand to throw my hat into the ring to run as the Chairperson of the Urban Affairs Committee. I had the sincere pleasure of serving with Senator Friend on the Urban Affairs Committee for the last three years, not only as a member of the committee but as the Vice Chair for all three of those years. Under Senator Friend's guidance and leadership, I spent those years preparing to become Urban Affairs' Chair. Senator Friend taught me how to run a committee by encouraging open discussion and building consensus. I can proudly say that I had the support of all of the members of the Urban Affairs Committee. He taught me how to make differing parties come together to work out differences in bills or risk the Senator Friend style consequences. But most importantly, he taught me how you can be successful here in the Legislature by being yourself, speaking from your heart, and gaining the trust of your colleagues, committee, and interested parties through honesty and directness. A little about the committee, for those who haven't introduced a bill there. Last year we had 22 bills introduced into the committee and 13 passed here on the floor, 1 is currently sitting on Final Reading, and we have 3 that are sitting on General File. Whoever is the Chairman will have to guide those bills through discussion here on the floor. I was there for those hearings and those discussions. LB522 is a committee bill to clean up a statute we passed in 2008 dealing with the use of funds by volunteer fire departments. And LB525 and LB526 were bills introduced by Senator Friend dealing with economic development and the Local Option Municipal Economic Development Act, and the other being about strip annexation in Sarpy County. Besides those issues in Urban Affairs, we deal with a broad range of issues from TIF financing to SIDs, natural gas, annexation, weed length, and handicap parking. I have been the Vice

Chair of this committee for three years. I have worked with Senator Friend from the day that he resigned to ensure a smooth transition. I've worked with his staff and I've worked with members of the committee to select a new research analyst, who I'm prepared to offer that position to later today if I am elected Chair. I know the issues and the interested parties at play, and I've passed legislation that advanced from that committee, which came to the floor. We were able to work out some of the issues and look forward to bringing my own skills and knowledge to the position of Urban Affairs Chair. Thank you, Mr. President. []
