FOR AN ACT relating to agricultural lands; to amend sections 76-1507,
76-1516, and 76-1523, Reissue Revised Statutes of
Nebraska; to eliminate a duty of the county assessor
relating to information on certain trusts; to harmonize
provisions; to repeal the original sections; and to
outright repeal section 76-1517, Reissue Revised Statutes
of Nebraska.

- 6 Sec. 2. Section 76-1516, Reissue Revised Statutes of
- 7 Nebraska, is amended to read:
- 8 76-1516 Any trust, other than a family trust, authorized
- 9 trust, or testamentary trust, violating sections 76-1507 to 76-1517
- 10 76-1516 shall upon conviction, be punished by a fine of not more than
- 11 fifty thousand dollars and shall divest itself of any land acquired
- 12 in violation of sections 76-1507 to $\frac{76-1517}{76-1516}$ within one year
- 13 after conviction. The courts of this state may prevent and restrain
- 14 violations of this section through the issuance of an injunction. The
- 15 Attorney General or a county attorney shall institute suits on behalf
- 16 of the state to prevent and restrain violations of sections 76-1507

- 5 <u>Constitution of Nebraska.</u>
