### A BILL

1 FOR AN ACT relating to the Motor Vehicle Operator's License Act; to
2 amend sections 60-462, 60-4,112, and 60-4,122, Reissue
3 Revised Statutes of Nebraska; to provide requirements for
4 retaking the driving skills examination as prescribed; to
5 provide for and change provisions relating to electronic
6 issuance and renewal of operators' licenses and state
7 identification cards; to harmonize provisions; and to
8 repeal the original sections.

9 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 60-462, Reissue Revised Statutes of

- 2 Nebraska, is amended to read:
- 3 60-462 Sections 60-462 to 60-4,188 <u>and section 3 of this</u>
- 4 <u>act</u>shall be known and may be cited as the Motor Vehicle Operator's
- 5 License Act.
- 6 Sec. 2. Section 60-4,112, Reissue Revised Statutes of
- 7 Nebraska, is amended to read:
- 8 60-4,112 Sections 60-4,114, 60-4,116, and 60-4,118 to
- 9 60-4,130.05 and section 3 of this act shall apply to the operation of
- 10 any motor vehicle except a commercial motor vehicle.
- 11 Sec. 3. An applicant for a Class O or Class M license
- 12 that fails three successive tests of his or her ability to drive and
- 13 maneuver a motor vehicle safely as provided in subdivision (3)(b) of
- 14 section 60-4,114 may be issued an LPD-learner's permit. The applicant
- 15 shall not be eligible to reapply for the Class O or Class M license
- 16 and retake such test until he or she presents proof of successful
- 17 <u>completion of a department-approved driver training school or until</u>
- 18 he or she has held an LPD-learner's permit for at least ninety days.
- 19 Sec. 4. Section 60-4,122, Reissue Revised Statutes of
- 20 Nebraska, is amended to read:
- 21 60-4,122 (1) Except as otherwise provided in subsections
- 22 (2), (3), and (8) of this section, no original or renewal operator's
- 23 license shall be issued to any person until such person has
- 24 demonstrated his or her ability to operate a motor vehicle safely as
- 25 provided in section 60-4,114.

(2) Except as otherwise provided in this section and 1 2 section 60-4,127, any person who renews his or her Class O or Class M license shall demonstrate his or her ability to drive and maneuver a 3 motor vehicle safely as provided in subdivision (3)(b) of section 4 5 60-4,114 only at the discretion of department personnel, except that a person required to use bioptic or telescopic lenses shall be 6 7 required to demonstrate his or her ability to drive and maneuver a 8 motor vehicle safely each time he or she renews his or her license.

- 9 (3) Any person who renews his or her Class O or Class M
  10 license prior to or within one year after its expiration may not be
  11 required to demonstrate his or her knowledge of the motor vehicle
  12 laws of this state as provided in subdivision (3)(c) of section
  13 60-4,114 if his or her driving record abstract maintained in the
  14 computerized records of the department shows that such person's
  15 license is not impounded, suspended, revoked, or canceled.
- 16 (4) Except for operators' licenses issued to persons 17 required to use bioptic or telescopic lenses, any person who renews 18 his or her operator's license which has been valid for fifteen months 19 or less shall not be required to take any examination required under 20 section 60-4,114.
- 21 (5) Any person who renews a state identification card 22 shall appear before department personnel and present his or her 23 current state identification card or shall follow the procedure for 24 electronic renewal in subsection (9) of this section. Proof of 25 identification shall be required as prescribed in sections 60-484 and

- 1 60-4,181.
- 2 (6) A nonresident who applies for an initial operator's
- 3 license in this state and who holds a valid operator's license from
- 4 another state which is his or her state of residence may not be
- 5 required to demonstrate his or her knowledge of the motor vehicle
- 6 laws of this state if he or she surrenders to the examiner his or her
- 7 valid out-of-state operator's license.
- 8 (7) An applicant for an original operator's license may
- 9 not be required to demonstrate his or her knowledge of the motor
- 10 vehicle laws of this state if he or she has been issued a Nebraska
- 11 LPD-learner's permit that is valid or has been expired for no more
- 12 than one year. The written examination shall not be waived if the
- 13 original operator's license being applied for contains a class or
- 14 endorsement which is different from the class or endorsement of the
- 15 Nebraska LPD-learner's permit.
- 16  $\frac{(8)(a)}{(8)(a)}$  A qualified licensee as determined by the
- 17 department who is twenty-one years of age or older, whose license
- 18 expires prior to his or her seventy-second birthday, and less than
- 19 sixty five years of age and who has a digital image and digital
- 20 signature preserved in the digital system may renew his or her Class
- 21 O or Class M license once by electronic means in a manner prescribed
- 22 by the department using the preserved digital image and digital
- 23 signature without taking any examination required under section
- 24 60-4,114 if such renewal is prior to or within one year after the
- 25 expiration of the license, and if his or her driving record abstract

1 maintained in the records of the department shows that such person's

- 2 license is not <u>impounded</u>, suspended, revoked, or canceled, and if his
- 3 or her driving record indicates that he or she is otherwise eligible.
- 4 Every licensee must apply for renewal in person at least once every
- 5 ten years and have a new digital image and digital signature taken.
- 6 (b) In order to allow for an orderly progression through
- 7 the various types of operators' licenses issued to persons under
- 8 twenty-one years of age, a qualified holder of an operator's license
- 9 who is under twenty-one years of age and who has a digital image and
- 10 digital signature preserved in the digital system may apply for an
- 11 operator's license by electronic means in a manner prescribed by the
- 12 department using the preserved digital image and digital signature if
- 13 the applicant has passed any required examinations prior to
- 14 application, if his or her driving record abstract maintained in the
- 15 records of the department shows that such person's operator's license
- 16 is not impounded, suspended, revoked, or canceled, and if his or her
- 17 <u>driving record indicates that he or she is otherwise eligible.</u>
- 18 (9) Any person who is twenty-one years of age or older
- 19 and who has been issued a state identification card with a digital
- 20 image and digital signature may electronically renew his or her state
- 21 identification card once by electronic means in a manner prescribed
- 22 by the department using the preserved digital image and digital
- 23 signature. Every holder of a state identification card shall apply
- 24 for renewal in person at least once every ten years and have a new
- 25 digital image and digital signature taken.

- 1 (10) In addition to services available at driver license
- 2 offices, the department may develop requirements for using electronic
- 3 means for online issuance of operators' licenses and state
- 4 identification cards to qualified holders as determined by the
- 5 <u>department</u>.
