have a series of technical things that we have to add into the mainline budget bill. I'll just read them off as they are before me. The first one is to correct an error for reappropriation language which was omitted. This relates to the Legislative Council budget program, program evaluation. General Fund appropriations balances for the operating appropriations throughout state agencies were generally reappropriated. The second one is Department of Education, decrease Tax Equity and Educational Opportunities Support Act aid for 2011-2012 by \$2,809,152. Routinely in a long session, by late March and early April a final tabulation of insurance premium tax receipts is available which then impacts the level of General Funds for TEEOSA. In this case, a larger than anticipated amount for insurance premium tax allows for a lower General Fund obligation with a small offset of \$28,578 increase as a result of adjustments made by the State Department of Education. The next one is a change to descriptions of healthcare positions to harmonize with legislative change to licensure classification, changes the name of certain positions to conform with prior year legislation that changed position names. The next one is to change federal funding legislation for federally qualified health centers. We're doing this to maintain status guo for an additional year as a result of the minority health funding distribution change and because of minority census data for the 2010 Census. This is a subject that we're going to have to look at over the interim and figure out what we're going to do from that point on. The next one adds transfer language, adds the General Fund as a destination for transfer from the Department of Motor Vehicles Cash Fund. This destination fund was actually left out in the language. The next one is with the Indian Commission, is to increase the cash fund appropriations \$45,000 in the first year only, 2011-2012, and allow for a carryover of unspent cash fund balances related to Whiteclay. The addition of \$45,000 allows for the expenditure and anticipated grants and gifts that may occur in the forthcoming year. SENATOR NORDQUIST: Mr. President, I move LB502 to E&R for engrossing. [LB502]

PRESIDENT SHEEHY: You have heard the motion. All those in favor say aye. Opposed, nay. LB502 advances. (Visitors introduced.) Mr. Clerk, we'll move to the next item on the agenda, Final Reading, motions to return to Select File for a specific amendment. LB628. [LB502 LB628]

CLERK: Mr. President, I have two motions. Senator Bloomfield would, first of all, move to return LB628 to Select File for a specific amendment, the amendment being AM1263. [LB628]

PRESIDENT SHEEHY: Senator Bloomfield, you're recognized on your motion to return LB628 to Select File. [LB628]

SENATOR BLOOMFIELD: Thank you, Mr. President. Colleagues, I'm having circulated at this time an Opinion from the Attorney General that states that there are some constitutional questions involved with this bill as passed to this point. I, therefore, would like to bring it back to Select File to correct that problem with it. My amendment would simply remove the offending language. Thank you, Mr. President. [LB628]

PRESIDENT SHEEHY: Thank you, Senator Bloomfield. You've heard the opening on the motion to return LB628 to Select File. Member requesting to speak: Senator Cook. [LB628]

SENATOR COOK: Thank you, Mr. President, and good morning, colleagues. I am rising in opposition to this particular motion to return it for this particular amendment. The issue that Senator Bloomfield has mentioned will be addressed in an amendment that I will return the bill to Select File to ask for your adoption. So with that, colleagues, I ask that you vote no on this particular motion to return. Thank you, Mr. President. [LB628]

PRESIDENT SHEEHY: Thank you, Senator Cook. Senator Bloomfield. [LB628]

SENATOR BLOOMFIELD: Thank you, Mr. President. From what I have seen of Senator Cook's amendment, it does not necessarily clear up the issue that exists within the constitution. I would ask that you bring it back, let's take a look at it, you decide what you need to do with it. I don't intend to belabor this for a long, drawn-out affair. I don't believe that needs to be done, but I do think we should take a look at what we're doing. Thank you. [LB628]

PRESIDENT SHEEHY: Thank you, Senator Bloomfield. Senator Hansen. [LB628]

SENATOR HANSEN: Thank you, Mr. President, members of the Legislature. The senators in the back of the room haven't had a chance to look at the handout so I would ask, Senator Bloomfield and Senator Cook, just a little bit of time until we have time to look at that. I know we're all looking forward to adjournment but I think this is an important amendment and an important reason why Senator Bloomfield brought this amendment and we need to take a minute to look at this report. So I don't know how you want to handle that, Mr. President, but I would ask for a few minutes to do that. Thank you. [LB628]

PRESIDENT SHEEHY: Thank you, Senator Hansen. Members requesting to speak on the motion to return to Select File, we have Senator Cook, followed by Senator Krist and Senator McCoy and Senator Price. Senator Cook. [LB628]

SENATOR COOK: Thank you, Mr. President, and good morning colleagues. Again, I rise in opposition to the motion to return the bill to Select File for this amendment and eventually will be in opposition to this amendment. Senator Bloomfield has circulated, indeed, an Attorney General's Opinion. The amendment that I will offer, which is AM1400, has been vetted through the Attorney General's Office and does take care of the issues that have been brought up through that Attorney General's Opinion. Thank you, Mr. President. [LB628]

PRESIDENT SHEEHY: Thank you, Senator Cook. Senator Krist. [LB628]

SENATOR KRIST: Good morning, colleagues. And thank you, Mr. President. I was wondering if Senator Cook would yield to a question. [LB628]

PRESIDENT SHEEHY: Senator Cook, would you yield to Senator Krist? [LB628]

SENATOR COOK: Yes, I will. [LB628]

SENATOR KRIST: Based upon the process, we're looking at one amendment without really having an opportunity, so I guess I'm buying a little bit of time for those in the back to actually take a look at the Attorney General's words. But at the same time, I think it

would be helpful if you would let us know what your amendment actually does that you feel or that you have vetted through the Attorney General's Office that may solve this issue. [LB628]

SENATOR COOK: All right. Thank you very much, Senator Krist. AM1400, if you can find that on your machine, on page 5, line 25, "unless such donation is prohibited by law." Constitutionally, this state or any government organization is not permitted to gift a faith-based organization with property or cash. We do it through contracts, such as Boys Town and Catholic Charities and Lutheran Family Services and Salvation Army, etcetera, across the state, but that first line will take care of the concerns raised by the Attorney General's Office and cited in that case from 1960 which, incidentally, relates to \$60,000 cold cash money going to an organization that had a faith-based outreach as one of its functions. And then the second line is the amendment that was adopted by the body in the previous round of debate. Does that clarify, Senator Krist? [LB628]

SENATOR KRIST: I think it does and thank you for your answer. And then if Senator Bloomfield would yield to a question, please. [LB628]

PRESIDENT SHEEHY: Senator Bloomfield, would you yield? [LB628]

SENATOR BLOOMFIELD: Yes, I would. [LB628]

SENATOR KRIST: Senator, your amendment, in terms of differing from the following amendment that we're going to see, how do you feel that it actually solves the problem in more clarity, with more clarity? [LB628]

SENATOR BLOOMFIELD: Thank you, Senator Krist. My amendment simply removes the whole section where the offending language appears, leaving intact what was at one time the Lautenbaugh amendment which allows for interstate swapping of equipment but does not allow for the straight giveaway of government property. And I'm going to burn just a second of your time, if you don't mind, that Senator Cook's bill (sic) says, "unless donation is prohibited by law," that to me looks like we're still doing the same thing. I believe under the original Opinion of the Attorney General, that is prohibited by law and we've just gone back and said unless it's prohibited by law, and it appears to be. [LB628]

SENATOR KRIST: Okay. Thank you, both, for your candor and thank you, Mr. President, for the time. [LB628]

PRESIDENT SHEEHY: Thank you, Senator Krist. Senator Price. [LB628]

SENATOR PRICE: Thank you, Mr. President. Members of the body, if you remember, and just so we refresh your memories here, we had a multipart bill here. We had one,

as Senator Bloomfield brought up, we had the issue that Senator Lautenbaugh had and it was melded into this bill here, and then what Senator Cook has. And on all the rounds of debate so far, I brought up the concern of how are we going to know about the determined end-of-life use so we're going to be giving a property away, that there was a concern that there was no drafted limits. There were some limits in Lautenbaugh's, but there were no limits in this that a political subdivision...and conversation that was had on the floor was, well, if a political subdivision gives something away that the voters felt was too gracious, if you want to use those words, or had too much value, then those elected officials would be held accountable. So I think that that's where we came to an agreement, is that the local officials would be held accountable. But now we see through the Opinion of the Attorney General that there are some concerns, and what Senator Bloomfield is doing is just removing that whole section, I guess, and gutting the bill for the giving away and leaving Lautenbaugh's thing, his portion of it. And Senator Cook has said now that hers would take care of it. Would Senator Cook yield to a question, please? [LB628]

PRESIDENT SHEEHY: Senator Cook, would you yield? [LB628]

SENATOR COOK: Yes, I will. [LB628]

SENATOR PRICE: Thank you, Senator Cook. Can you spend a moment again, a little bit more time and that will give you...to address what Senator Bloomfield is saying, is that by putting a statement of what's allowed by law but currently is not allowed by law. I mean how does that...how do you reconcile those two? Would you take a moment, please? [LB628]

SENATOR COOK: This particular line, Senator Price, was added to clarify the points that were brought up in the Attorney General's Opinion. If you get that in front of you and look at the last paragraph and read that to yourselves, this is just an extra way, and it's been vetted through the Attorney General's Office, to ensure that a faith-based organization, which is currently constitutionally not allowed, that that's taken care of. So does that answer your question? [LB628]

SENATOR PRICE: I think it answers the question about faith-based. The question that I had that remains is the part about the language that says that's otherwise allowed by law. I mean if it's...or not allowed by law. That's what Senator Bloomfield has brought up. And I guess I would finish my commentary with the question, Senator Cook, are all the concerns, not just the faith-based one, but are all the concerns that are outlined in the Attorney General's Opinion, do you believe they all have been fully addressed with an amendment that you would propose? [LB628]

SENATOR COOK: Yes. [LB628]

SENATOR PRICE: Thank you very much, Senator Cook. And I would yield the balance of my time to Senator Bloomfield, if he wanted to use it. [LB628]

PRESIDENT SHEEHY: Senator Bloomfield, you're yielded 1 minute 30 seconds. [LB628]

SENATOR BLOOMFIELD: Thank you, Mr. President, Senator Price. I don't have a lot more to say on this other than I think it's clear we need to bring this back. Let's have a look at it. We've had a chance to read it a little bit. There's some question in my mind and apparently in other minds as to whether or not Senator Cook's amendment would take care of the constitutional issue. There is no doubt mine does. I would like to bring it back to the floor and let's have a vote on it. Let's see where we go, without spending all morning doing it. [LB628]

PRESIDENT SHEEHY: Thank you, Senator Bloomfield. Members requesting to speak on the motion to return legislative bill for a specific amendment, we have Senator Cook, followed by Senator Conrad and Senator Lautenbaugh. Senator Cook, this is your third time. [LB628]

SENATOR COOK: Thank you, Mr. President. And good morning again, colleagues. Again, I rise in opposition to this motion to return for this amendment. This amendment will not be necessary because my amendment takes care of the constitutional issue. It was vetted, as I said earlier, through the Attorney General's Office and takes care of the issue that you're seeing in the letter distributed from the Attorney General's Office. I would also like to mention that if you return for this motion and if you were to, by accident, do the wrong thing and adopt AM1263, then it removes my bill. At this point, you'd be left with Senator Lautenbaugh's bill. And I don't...I didn't work this hard to bring this bill this far just so that my great good buddy Senator Lautenbaugh could have his bill and that I am not going to have mine. So be mindful, please. I would ask if we're doing this, it's probably his motion, but I'm going to vote against this motion because we don't need to talk about this amendment anymore because my amendment takes care of everything that is outlined in that Attorney General's Opinion. Thank you very much, Mr. President. [LB628]

PRESIDENT SHEEHY: Thank you, Senator Cook. Senator Conrad. [LB628]

SENATOR CONRAD: Thank you, Mr. President. Good morning, colleagues. I was hoping that Senator Cook would yield for a question, please. [LB628]

PRESIDENT SHEEHY: Senator Cook, would you yield to Senator Conrad? [LB628]

SENATOR COOK: Yes. [LB628]

SENATOR CONRAD: Thank you, Senator Cook. And I know that from a process perspective there can be some confusion in terms of the fact that you've got an amendment pending that you would like to return the bill to Select for and then Senator Bloomfield, of course, has this motion and this amendment pending. So regardless, at some point you have...you do believe that we will need to move the bill from Final to Select today to address some technical issues. Is that correct? [LB628]

SENATOR COOK: Yes, Senator Conrad, and I have also filed a motion to return LB628 to Select File for a specific amendment, and my specific amendment is AM1400, and I've mentioned it before. It takes care of the Attorney General's Opinion, the issue brought out in that and... [LB628]

SENATOR CONRAD: Okay. [LB628]

SENATOR COOK: Yes. Thank you. [LB628]

SENATOR CONRAD: Thank you, Senator Cook. I just wanted to make sure that the members were clear about that... [LB628]

SENATOR COOK: Right. [LB628]

SENATOR CONRAD: ...and specifically your amendment that you filed specifically addresses the concerns because it's been drafted in cooperation and consultation with the Attorney General's Office. So really, that would vitiate any of the information provided in this Opinion. Is that correct? [LB628]

SENATOR COOK: Absolutely. It has been drafted in direct consultation with the Attorney General's Office and satisfies all of the issues brought up in the letter. [LB628]

SENATOR CONRAD: Okay. Thank you, Senator Cook. Would Senator Bloomfield please yield to a question? [LB628]

SENATOR BLOOMFIELD: Yes, I would. [LB628]

SENATOR CONRAD: Thank you, Senator Bloomfield. And have you had a chance to review that competing amendment that Senator Cook has filed? [LB628]

SENATOR BLOOMFIELD: Just the page that my aide brought me this morning. [LB628]

SENATOR CONRAD: Okay. And have you had a chance to visit about that with the Attorney General's Office? [LB628]

SENATOR BLOOMFIELD: I have not. I'm going to insert something here that I...if it's

wrong, I will ask to be excused on my freshman lack of knowledge. I made a point each time I filed an amendment to share it with Senator Cook. That courtesy was not reciprocated back to me. [LB628]

SENATOR CONRAD: Well, Senator Bloomfield, I think everyone operates in a different posture and sometimes, when it is possible, senators do like to share those in advance, and sometimes that's not possible for time purposes. But I do want to direct your attention to the very first page of the Attorney General's Opinion that you forwarded today quoting, "We are not aware of any specific provision in the Nebraska Constitution which expressly prohibits gift of government property to a private organization by a governmental subdivision." The remaining context and specifics in the Attorney General's Opinion are really more hypothetical and potential issues that could be addressed, and Senator Cook has addressed those in her amendment. So my specific question to you is your amendment is not intended to respond to the Attorney General's Opinion but, rather, to kill the bill. Is that correct? [LB628]

SENATOR BLOOMFIELD: No, that is not correct. If you would go to page 3 of what I had circulated, the last line of paragraph 2, "It is not what has been done but what can be done under a statute that determines its constitutionality." [LB628]

SENATOR CONRAD: Thank you, Senator Bloomfield. And again that if you look at the general direction on the first page, it then lays out potential specific instances of concern that will be addressed with Senator Cook's motion. So again, your amendment is indeed not intended to respond to the Attorney General's Opinion but, rather, to change the composition of the bill, which is in essence a kill motion. Is that correct? [LB628]

PRESIDENT SHEEHY: One minute. [LB628]

SENATOR BLOOMFIELD: No, that is not correct. The bill,... [LB628]

SENATOR CONRAD: Okay. [LB628]

SENATOR BLOOMFIELD: ...as amended with this one section gone, will stand. I'm not trying to kill the bill. [LB628]

SENATOR CONRAD: Thank you, Senator Bloomfield. Thank you, Mr. President. For one minute, Senator Cook, would you yield to a question? [LB628]

PRESIDENT SHEEHY: Senator Cook. [LB628]

SENATOR COOK: Yes, Mr. President. Yes. [LB628]

SENATOR CONRAD: Senator Cook, do you believe that this is a kill motion because...

SENATOR COOK: Absolutely. It specifically calls for the removal of Section 4 of this version of the bill, and that if you look at the green copy of my petite little LB628 before I so graciously permitted my great good friend Senator Lautenbaugh to amend into it, that is the language of the bill. My amendment, which you will return this bill from Final Reading to Select in my motion, which I'm going to bring, my amendment amends that section. So if you entertain this motion and if you entertain that... [LB628]

PRESIDENT SHEEHY: Time, Senator. [LB628]

SENATOR CONRAD: Thank you, Senator Cook. [LB628]

PRESIDENT SHEEHY: Time, Senator. [LB628]

SENATOR CONRAD: Thank you, Mister... [LB628]

PRESIDENT SHEEHY: Thank you, Senator Conrad. Members requesting to speak: Senator Lautenbaugh, followed by Senator Bloomfield and Senator Ken Haar. Senator Lautenbaugh. [LB628]

SENATOR LAUTENBAUGH: Thank you, Mr. President and members of the body. I appreciate Senator Cook's directness and clarity on this. I think Colonel Potter said subtlety doesn't feed the bulldog. She's been very clear--don't do the wrong thing, do the right thing. And I appreciate Senator Bloomfield's concerns on this and he has been active on this bill and I've understood where he's coming from on this, but I do believe that the amendment coming from Senator Cook will correct the issues that have been raised. And so I do have to vote against this motion to return to Select and support the next motion to return to from Select (sic) and that may be the last motion to return this bill from Select (sic). I'm not keeping track. But I think that Senator Bloomfield raised a valid concern and I think it is being addressed properly though, so I would urge you to, unfortunately, oppose this motion and support the next one. And I'll yield the rest of my time to Senator Cook. [LB628]

PRESIDENT SHEEHY: Senator Cook, you're yielded 4 minutes. [LB628]

SENATOR COOK: (Laugh) I think I'm going to waive. (Laughter) [LB628]

PRESIDENT SHEEHY: Thank you, Senator Cook. Thank you, Senator Lautenbaugh. Senator Bloomfield, this is your third time. [LB628]

SENATOR BLOOMFIELD: Mr. President, how do I follow that? (Laugh) Yeah. Senator Council just said God bless America. I believe that's how we follow that waving and

shaking action. Again, I believe this needs to come back. Let's have a good solid vote on it. Let's bring it back and discuss maybe, if we need to, whether or not this last Opinion apparently from the Attorney General, which I have not had the opportunity to discuss with them, does in fact take care of the issue. I believe Senator Cook's tiny little bill probably would not have survived as long as it did without the Lautenbaugh amendment. And am I trying to strike out a part where we're giving away public property? You bet I am. I'm the lowdown son of a Bloomfield that said, by golly, it's time we quit giving things away. Let's not hand away public property to people that will probably strip the wheels off of it, sell them, buy a few drugs, leave it sit on the road. Let's bring it back. Let's discuss it. PRESIDENT SHEEHY: Thank you, Senator Bloomfield. Senator Pahls. [LB628]

SENATOR PAHLS: Good morning, Mr. President. May I have a word or two with Senator Cook? [LB628]

PRESIDENT SHEEHY: Senator Cook, would you yield to Senator Pahls? [LB628]

SENATOR COOK: Yes, Mr. President. [LB628]

SENATOR PAHLS: Good morning. [LB628]

SENATOR COOK: Good morning, Senator Pahls. [LB628]

SENATOR PAHLS: Remember when I said that this bill would take a little bit of doing once it was in the Government Committee? [LB628]

SENATOR COOK: Uh-huh. [LB628]

SENATOR PAHLS: Okay. I think we're almost there, to be honest with you. [LB628]

SENATOR COOK: All right. [LB628]

SENATOR PAHLS: I support what you're trying to do and, I think, your amendment. You're telling me your amendment will clear up any of the issues that have been brought forth. [LB628]

SENATOR COOK: Yes, Senator Pahls. My amendment, which I understand is up on your gadget at this time, it's AM1400 to LB628, my amendment addresses the issues raised by the Attorney General's Office. Indeed, it was drafted in cooperation with the Attorney General's Office. It also includes the amendment that was adopted at the last round of debate. So it clarifies and it ensures that we are not adopting an

unconstitutional measure. [LB628]

SENATOR PAHLS: Okay. Okay. Again, I thank you for your effort, appreciate your answer. It seems to me that we are or eventually will have this cleared up. One thing I do need to bring forth, when this bill was brought to the committee...I see it as more as recycling as opposed to giving things away. And nowhere in any of the conversation did it come across to us that people are going to take these vehicles out and dispose of them in an unfair way. I support what Senator Cook is doing and I think if we can get to her amendment we should move forward. Thank you. [LB628]

PRESIDENT SHEEHY: Thank you, Senator Pahls. Senator Haar. [LB628]

SENATOR HAAR: Mr. President, members of the body, can I ask Senator Cook a question? [LB628]

PRESIDENT SHEEHY: Senator Cook, would you yield to Senator Haar? [LB628]

SENATOR COOK: Yes, Mr. President. [LB628]

SENATOR HAAR: Okay. Just once more to clarify, Senator Bloomfield's amendment, AM1263, would take the wheels off your amendment, get rid of it,... [LB628]

SENATOR HAAR: ...whereas your amendment will keep the idea of recycling the vehicles and take care of the constitutional... [LB628]

SENATOR COOK: Uh-huh. Thank you, Senator Haar. Indeed, if you were to vote in support of this motion, please don't, and if you were then to vote in support of this amendment, please don't, it would effectively strip the wheels and any other remarketable portions of the vehicle, called LB628, of its original purpose. SENATOR HAAR: Okay. Well, thank you very...so it's not just returning it to Select File but it strips your...basically your part out of it. [LB628]

SENATOR COOK: Well, with this motion, if you were to adopt it and if you were to consider and include AM1263, it eliminates the language my green copy, if you still have that available, my green copy of the bill is Section 4. [LB628]

SENATOR HAAR: Okay. [LB628]

SENATOR COOK: So my amendment amends Section 4 so it needs to be there. [LB628]

SENATOR NELSON: Thank you, Mr. President, members of the body. I'd like to yield some of my time to Senator Bloomfield, if he will keep his comments to 2 or 3 minutes so I can finish up. Senator Bloomfield. [LB628]

PRESIDENT SHEEHY: Senator Bloomfield. [LB628]

SENATOR BLOOMFIELD: Thank you, Senator Nelson. I, maybe with a little more passion than I should have, made some statements about the wheels being pulled off of vehicles and sold for the purchase of drugs. I did not intend that all poor people are going to rush out and strip the car that is given to them. I will also not say that it cannot happen, in certain opinions, and I don't believe that is our intent. This vehicle that we are giving away to a charity or to a nonprofit organization is at that point to be given to an individual. What that individual does with that vehicle, we have no control over it. Again, I did not intend to indict lower-income people. What I intended to do was to say that in some instances this vehicle, if given to an individual, is going to be improperly used. And bear in mind that even though these vehicles supposedly have reached their end of value, even at the iron yard they're worth \$300 to \$500. Thank you for the time, Senator Nelson. [LB628]

PRESIDENT SHEEHY: Senator Nelson, you still have 3 minutes 20 seconds. [LB628]

SENATOR NELSON: Thank you very much, Mr. President. I'd like to address a question to Senator Cook, if she will yield. [LB628]

PRESIDENT SHEEHY: Senator Cook, would you yield? [LB628]

SENATOR COOK: Yes, Mr. President, I'll yield. [LB628]

SENATOR NELSON: Thank you, Senator Cook. I'm looking at the first part of your proposed amendment, AM1400, and I think you indicated by adding, "unless such donation is prohibited by law," that this is going to solve the problem. My question is

this: How are we eventually going to decide whether that donation is prohibited by law? [LB628]

SENATOR COOK: I'm sorry, what did you say? How is who going to decide? [LB628]

SENATOR NELSON: Yeah, how...who's going to make that determination? I mean if you've got an organization that wants to give something away to a charitable organization, such as a vehicle, who's going to determine whether that donation is prohibited by law? [LB628]

SENATOR COOK: Well, Senator Nelson, thank you for asking that question. My bill proposal, the original one, the green one, merely permits a local subdivision, the elected officials of a subdivision, a city, a county, a public power board, it permits them to choose to donate to a charitable organization. This proposal does not automatically donate anything. It merely provides the language that if a governing board of a city, a county, or local subdivision chooses to donate a vehicle... [LB628]

SENATOR NELSON: Thank you, Senator Cook. I understand that, but the question still is we've got to make a determination and we've got an Opinion here by our Supreme...or by our Attorney General that there's some doubt about this. So aren't we going to be in the position that somebody, sooner or later, is going to have to file a lawsuit and say you can't do this and go to the court to make a decision, which may or may not be in accordance with the Opinion of the Attorney General? Aren't we better off to just kind of determine right now, on the basis of the Opinion, that we ought not to permit this through our... [LB628]

PRESIDENT SHEEHY: One minute. [LB628]

SENATOR COOK: No, sir, not in my opinion. I have, as I said, drafted the amendment in close consultation and collaboration with the Attorney General's Office. They are the office that issued the Opinion based on a court decision that was made in 1960. I do not agree with you that we should do that at this time. [LB628]

SENATOR NELSON: All right. Thank you, Senator. I am not certain how I'm going to vote on this but...because it's a quick read of the Opinion, but I think we're still going to have a constitutional problem to address if we do pass this with Senator Cook's amendment. Thank you, Mr. President. [LB628]

PRESIDENT SHEEHY: Thank you, Senator Nelson. Senator Conrad. [LB628]

SENATOR CONRAD: Thank you, Mr. President. Good morning, colleagues. I rise in opposition to the motion and I rise in opposition to the Bloomfield amendment, AM1263. Let's be clear, this legislation authorizes surplus government property to be utilized by

nonprofit organizations and encourages public-private partnerships that benefit the entirety of our citizenry. Senator Cook should be commended for bringing forward this idea which, mind you, is not innovative but indeed is already in practice, say, for example, in the Department of Corrections or in other areas and entities of government. This is an expansion of an existing idea and program that works to benefit all. She should be applauded for that. I thank her for her careful time and attention with this matter and graciously working to ensure it is as technically appropriate as it can be. And I will be supporting her motion to return to Select File for that specific amendment. In regards to other commentary that has been made in the context of the debate this morning, I can tell you in my five years in the Legislature we are all quilty at times of being overrun by passion for the issues that we care deeply about and that we've invested a great deal of time and energy upon. However, I can tell you, in my personal opinion, those comments are among the most offensive that I've heard in terms of floor debate. And I appreciate Senator Bloomfield attempting to make an apology. I hope that he will be more full and forthcoming in that apology because I don't believe that that represents what would be his or any of our position and belief in terms of poverty issues and low-income individuals and families that reside in all of our districts and all across this great state. I don't believe it represents what our public policy is in Nebraska, I don't believe it represents a Christian view of poverty issues, and I don't believe that it has any context in this debate or other. Thank you, Mr. President. [LB628]

PRESIDENT SHEEHY: Thank you, Senator Conrad. (Visitors introduced.) Members requesting to speak on the Bloomfield motion to return LB628 to Select File, we have Senator Karpisek, followed by Senator Council, Senator Howard, and Senator Schumacher. Senator Karpisek. [LB628]

SENATOR KARPISEK: Thank you, Mr. President, members of the body. I had some issues with this bill out of committee and I think I was not voting as it came out. I still am not real solid on it. However, I think that...I know that Senator Cook has talked to the AG and her amendment would fix those things. But what I want to talk about is the political maneuvering on these bills to go get an AG's Opinion and it is an opinion. I've seen it on too many bills. We get an AG's Opinion. Either we don't get the Opinion back and it holds up the bill or it says something like may, shall, we feel. It's an opinion. This isn't the end-all, be-all. There are many bills that we've passed in here that have gone to court. And if we want to play these sort of games on all those bills that's fine, but I'm standing up right here and right now and saying I'm tired of it. We all know how to get an AG's Opinion and if that's going to hold the process up even more, we will have one in by the end of the day or two or three. It's fine to get one but to hold everything up because of an AG's Opinion, in my opinion, is not right. It's a political move, and if everybody doesn't see through that, wake up. Again, I'm not overly wild about this bill but I think I know Senator Cook has gone and worked with them, so I guess I don't understand what the holdup is. We can be here all day, that's fine, I don't care about that, but I think that Senator Cook has done the right steps, done what she's needed to

do. If you don't like the bill, vote no or don't vote or whatever you want to do. But what I'm saying is when you go through what you're trying to do, you're trying to concede, you make concessions and the target keeps moving on you and you can't ever hit it, it's not right. It's not the way we do business in here. But I heard yesterday many times, what's good for the goose is good for the gander, and we can all sit around and learn these things. If that's the way we want to work, we will work that way. That is not a threat; that is a promise. Thank you, Mr. President. [LB628]

PRESIDENT SHEEHY: Thank you, Senator Karpisek. Senator Council. [LB628]

SENATOR COUNCIL: Thank you, Mr. President. I rise in strong opposition to AM1263 and the motion to return LB628 to Select File for that amendment. I also rise in strong opposition to the extremely offensive remarks made by Senator Bloomfield with regard to the ultimate recipients of any donated property here, and I think that's... [LB628]

PRESIDENT SHEEHY: (Gavel) [LB628]

SENATOR COUNCIL: ...what we ought to be focusing in on. This is a bill to donate property to a not-for-profit and the assumption is that the not-for-profit is going to be providing these pieces of equipment, whether they're vehicles or whatever, to undeserving, slothful people, and I resent that. And I resent the fact that, Senator Karpisek, you know, these Attorney General Opinions, and I'm just amazed by them because last session I requested an Attorney General's Opinion on the constitutionality of a bill and they told me, I can't give you an opinion on the constitutionality of the bill because we may have to defend it if it's enacted. And then I see a constitutionality opinion requested and it's entitled "informal opinion." This Opinion is just entitled "Opinion." When do we get them, how do we get them, why do we get them? You know, you're talking about consistency, there ought to be some consistency. Either we can go to the Attorney General and ask for an opinion as to the constitutionality of provisions of proposed legislation or we can't, and that is problematic. Now for those who are questioning this obviously have no appreciation of the fact that the Department of Corrections regularly and routinely receives surplus property from the government and regularly and routinely donates that property to not-for-profits. They do it now. But in this context, when offered in the context of the possibility that it could benefit some person who's down on their luck, all of these issues come up. You know, we've been attacking poor people all session. Stop it! And if this donation, if a donation is going to be unlawful, then it's up to the individual political subdivision who is making the donation to determine whether or not that donation is lawful or not. And as I read the Attorney General's Opinion, somebody asked the question, how will you know whether it's unlawful or not, I don't know because according to this it's a case-by-case determination. So let's move on with this issue. You know, we have much more important and serious matters to address other than who you think might receive a benefit. Please vote in opposition to AM1263, in favor of AM400 I believe is...AM1400,

and move LB628. Thank you. [LB628]

PRESIDENT SHEEHY: Thank you, Senator Council. Senator Howard. [LB628]

SENATOR HOWARD: Thank you, Mr. President and members of the body. And I'm going to make this brief. I want to thank Senator Cook for bringing us this original bill, LB628. I stand in opposition to AM1263. This entire session we've cut back, denied, and refused any sort of assistance to any concern Health and Human Services related, no matter how worthy or how compassionate we might feel or how much it tugged at our heartstrings. And Senator Cook has brought us a bill that is creative, gives a slight bit of assistance to someone in need. Everybody needs transportation if you're going to get a job, and we want everybody to work. So I can't thank Senator Cook enough for trying to advance something that's going to help poor people, people that are underprivileged. I just don't want to say poor people. There are a lot of people that are getting by that are underprivileged. And I want to say that everybody in that situation is not a crook. Everybody is not looking for something that they're going to be able to fence or sell or in someway turn into something that we don't want them to be involved in. You know, there are people that are trying to support their families. There's people that are trying to stay off of our assistance programs and Senator Cook has offered one small way that we can help them and I thank her. [LB628]

PRESIDENT SHEEHY: Thank you, Senator Howard. Senator Schumacher. [LB628]

SENATOR SCHUMACHER: Call the question. [LB628]

PRESIDENT SHEEHY: Senator Schumacher, currently there is no other additional request to speak, so we will just go to Senator Bloomfield to close. [LB628]

SENATOR BLOOMFIELD: Thank you, Mr. President. Colleagues, I never dreamed that at the tender age of 65 I would be standing, asking for forgiveness of youthful exuberance, but I am. I stepped out of line with the comments I made. That does not, however, change the fact that this law needs to be looked at. I believe this needs to come back. Let's vote on it. It is not entirely clear to me and I think to others on the floor whether or not we do in fact take care of the constitutional questions that have arisen. I reiterate here it is not what has been done but what can be done under a statute that determines its constitutionality. If we don't bring this back and deal with it now we will be dealing with it again later. Thank you. [LB628]

PRESIDENT SHEEHY: Thank you, Senator Bloomfield. You have heard the closing. The question before the body is on the adoption of the Bloomfield amendment to return to Select File. All those in favor vote yea; opposed, nay. Please record, Mr. Clerk. [LB628]

CLERK: 3 ayes, 29 nays, Mr. President, on the motion to return the bill. [LB628]

PRESIDENT SHEEHY: The motion to return is not adopted. [LB628]

CLERK: Mr. President, Senator Cook, before we proceed with your motion to return, I had an earlier amendment, Senator, AM1261. I have a note you want to withdraw. [LB628]

PRESIDENT SHEEHY: AM1261 is withdrawn. [LB628]

CLERK: Mr. President, Senator Cook would move to return to the bill for specific amendment, AM1400. [LB628]

PRESIDENT SHEEHY: Senator Cook, you're recognized to open on your amendment to return LB628 to Select File. [LB628]

SENATOR COOK: Thank you, Mr. President. And thank you, colleagues. I think I've explained the necessity for the return motion and the issues that are addressed in AM1400. My hope is that you've had an opportunity to peruse the amendment. Once again, this amendment was drafted in collaboration and in cooperation with the selfsame Attorney General's Office that offered the Opinion, and I do believe that it addresses the issues that were raised in that Opinion. Thank you, Mr. President. Please vote green on the motion to return for AM1400. Thank you. [LB628]

PRESIDENT SHEEHY: Thank you, Senator Cook. You've heard the opening on the motion to return LB628 to Select File for a specific amendment. Senator Lautenbaugh, you're recognized. [LB628]

SENATOR LAUTENBAUGH: Thank you, Mr. President and members of the body. And as I previously indicated, I do rise in favor of this motion to return this bill to Select File for the specific amendment that addresses the potential issues that have been previously discussed. I think that it is important that this bill move forward and I think it is important that we address this issue and we are. At the same time, I would like to thank Senator Bloomfield for his conciliatory words and I would just remind us all that sometimes we all say things that we wish we could take back, and I've certainly...it's at least arguable that I've been guilty of that myself. Senator Lathrop wants to nod but he's not going to. Okay, now he is. That's fine. And we all say things and we, again, wish we could do it over again, and I thank him for his conciliatory words. And I would just remind us that we've all been there and we will all be there again. And I would urge you to vote to return this bill to Select File for a specific amendment. [LB628]

PRESIDENT SHEEHY: Thank you, Senator Lautenbaugh. Senator Bloomfield. [LB628]

SENATOR BLOOMFIELD: Thank you, Mr. President. I am not going to consume any more of the body's time by opposing bringing this bill out. PRESIDENT SHEEHY: Thank you, Senator Cook. You have heard the closing. The question before the body is on the Cook motion to return to Select File for a specific amendment. All those in favor vote yea; opposed, nay. Record, Mr. Clerk. [LB628]

CLERK: 41 ayes, 0 nays, Mr. President, on the motion to return the bill. [LB628]

PRESIDENT SHEEHY: The motion to return is adopted. Senator Cook, you're recognized to open on AM1400 to LB628. (Legislative Journal page 1443.) [LB628]

SENATOR COOK: Thank you, Mr. President, and good morning again, colleagues. I've mentioned before AM1400 is...has been drafted in cooperation with the Attorney General's Office in response to the Opinion that was generated on LB628, and I want to thank my colleagues for their support. And as I said when I introduced the bill, there is a particular pride that comes to an individual or to a family when they are able to support themselves, and I will probably be hard pressed to find a member of this body that doesn't agree with that notion. What I had hoped to do and what I want to do with LB628 is to provide that opportunity for an individual or a family or to support the mission of a nonprofit that is there for people when they need to start over. And many of us have been very, very blessed in that department where there was somebody there for us within our family or within an organization that could help us and advise us or just plain give us money or give us a ride someplace when we need it. There are plenty of people, and unfortunately an increasing number of people in this economy, who do not have that and I believe that personally and as a lawmaker that we should remove barriers to people being able to earn their own living and support themselves and pay into the taxes. Thank you, Mr. President. Please vote green to advance AM1400 to attach it to LB628. Thank you. [LB628]

PRESIDENT SHEEHY: Thank you, Senator Cook. You've heard the opening of AM1400 to LB628. Are there members requesting to speak? Seeing none, Senator Cook, you're recognized to close. Senator Cook waives closing. The question before the body is on the adoption of AM1400. All those in favor vote yea; opposed, nay. Please record, Mr. Clerk. [LB628]
