A BILL

FOR AN ACT relating to agriculture; to amend sections 54-701.03, 54-703, 54-704, 54-705, 54-750, 54-751, 54-752, 54-753, 2 54-753.06, 54-7,105, 54-7,106, 54-7,107, 54-7,108, 3 54-1156, 54-1159, 54-1166, 54-1173, 54-1180, 54-1181, 4 54-1182, 54-1183, 54-1184, and 54-1185, Reissue Revised 5 Statutes of Nebraska, and sections 54-170, 54-1158, 6 7 54-1161, 54-1163, 54-1169, and 54-1170, Revised Statutes Supplement, 2013; to name and change the Exotic Animal 8 Auction or Exchange Venue Act; to change, transfer, and 9 eliminate provisions of the Livestock Auction Market Act; 10 to change provisions relating to regulation of animals; 11 to harmonize provisions; to repeal the original sections; 12 and to outright repeal sections 54-1174 and 54-1177, 13 14 Reissue Revised Statutes of Nebraska.
