Section 1. There is hereby appropriated (1) \$10,284,979

- 2 from the General Fund for FY2013-14 and (2) \$10,279,301 from the
- 3 General Fund for FY2014-15 to the Nebraska Commission on Law
- 4 Enforcement and Criminal Justice, for Program 155, to aid in carrying
- 5 out the provisions of Legislative Bill 561, One Hundred Third
- 6 Legislature, First Session, 2013.
- 7 Total expenditures for permanent and temporary salaries
- 8 and per diems from funds appropriated in this section shall not
- 9 <u>exceed \$131,844 for FY2013-14 or \$134,810 for FY2014-15.</u>
- 10 There is included in the appropriation to this program
- 11 for FY2013-14 \$10,000,000 General Funds for state aid, which shall
- 12 only be used for such purpose. There is included in the appropriation
- 13 to this program for FY2014-15 \$10,000,000 General Funds for state
- 14 aid, which shall only be used for such purpose.
- 15 Sec. 2. There is hereby appropriated (1) \$600 from the
- 16 General Fund for FY2013-14 and (2) \$600 from the General Fund for
- 17 FY2014-15 to the Nebraska Commission on Law Enforcement and Criminal
- 18 Justice, for Program 203, to aid in carrying out the provisions of
- 19 Legislative Bill 561, One Hundred Third Legislature, First Session,

- 21 No expenditures for permanent and temporary salaries and
- 22 per diems for state employees shall be made from funds appropriated
- in this section.
- Sec. 3. There is hereby appropriated \$56,000 from the
