## **LEGISLATIVE BILL 167**

- 1 A BILL FOR AN ACT relating to the Office of Violence Prevention; to amend
- 2 section 81-1450, Reissue Revised Statutes of Nebraska; to require
- 3 the filing of an annual report to the Legislature; to change goals
- 4 for priority funding; and to repeal the original section.
- 5 Be it enacted by the people of the State of Nebraska,

Section 1. Section 81-1450, Reissue Revised Statutes of Nebraska, is amended to read:

3 81-1450 (1) The Office of Violence Prevention and its director shall 4 be administered and supervised, respectively, by the Nebraska Commission 5 on Law Enforcement and Criminal Justice. Among its responsibilities, the Office of Violence Prevention and its director shall be responsible for 6 7 developing, fostering, promoting, and assessing violence prevention programs. To accomplish this mission, the duties of the director shall 8 9 include, but not be limited to, program fundraising, program evaluation, 10 coordination of programs, and assistance with the administration and distribution of funds to violence prevention programs. The office shall 11 file with the Clerk of the Legislature an annual report on or before 12 September 1 of each year regarding its activities to develop, foster, 13 promote, and assess violence prevention programs, and the status of 14 program fundraising, evaluation, and coordination, and the administration 15 16 and distribution of funds to programs. The report shall be submitted 17 electronically.

(2) The advisory council to the Office of Violence Prevention shall 18 19 meet at least quarterly. Among its responsibilities, the advisory council shall recommend to the commission rules and regulations regarding program 20 program evaluation, coordination of programs, and the 21 fundraising, 22 criteria used to assess and award funds to violence prevention programs. Priority for funding shall be given to communities and organizations 23 24 seeking to implement violence prevention programs which appear to have 25 the greatest benefit to the state and which have, as goals, the reduction of street and gang violence, and the reduction of homicides and injuries 26 caused by firearms, and the creation of youth employment opportunities in 27 28 high-crime areas. The duties of the advisory council shall include, but not be limited to, receiving applications for violence prevention funds, 29 evaluating such applications, and making recommendations 30 the commission regarding the merits of each application and the amount of any 31

- 1 funds that should be awarded. If any funds are awarded to a violence
- 2 prevention program, the advisory council shall continuously monitor how
- 3 such funds are being used by the program, conduct periodic evaluations of
- 4 such programs, assess the progress and success regarding the stated goals
- 5 of each program awarded funds, and recommend to the commission any
- 6 modification, continuation, or discontinuation of funding.
- 7 Sec. 2. Original section 81-1450, Reissue Revised Statutes of
- 8 Nebraska, is repealed.
