PRESIDENT FOLEY: THANK YOU, MR. CLERK. SENATOR SMITH, YOU'RE WELCOME TO OPEN ON LB94. [LB94]

SENATOR SMITH: THANK YOU, MR. PRESIDENT, AND GOOD MORNING, COLLEAGUES. LB94 WAS REFERRED TO THE TRANSPORTATION AND TELECOMMUNICATIONS COMMITTEE AND A PUBLIC HEARING WAS HELD ON JANUARY 27TH. THERE WAS NO OPPOSITION TO THE BILL AND IT WAS ADVANCED UNANIMOUSLY BY THE COMMITTEE. LB94 WOULD PROVIDE A PROCESS FOR COUNTY TREASURERS TO ISSUE A TITLE WITH A LIEN RECORDED FOR A MOTOR VEHICLE THAT IS SOLD IN NEBRASKA BUT THAT IS IMMEDIATELY REMOVED FROM THE STATE BY AN OUT-OF-STATE BUYER. WHEN A NEBRASKA RESIDENT PURCHASES A VEHICLE TODAY IN THIS STATE AND THE VEHICLE IS FINANCED, A NOTATION IS MADE ON THE TITLE THAT THERE IS A LIEN. AND THIS IS CALLED A PERFECTION OF THE LIEN. THE PERFECTION OF THE LIEN IS GENERALLY REQUIRED BY STATE AND FEDERAL LAW TO PROTECT THE SECURITY INTERESTS OF THE LENDER. HOWEVER, WHEN AN INDIVIDUAL FROM A DIFFERENT STATE PURCHASES A VEHICLE IN NEBRASKA, THE TITLE IS NOT ISSUED UNTIL THAT PERSON REGISTERS THE VEHICLE IN THEIR HOME STATE. THIS LEAVES A PERIOD OF TIME WHEN THE LENDER'S INTEREST IS NOT SECURED AND IT LEAVES ALL PARTIES INVOLVED, THE LENDER. THE DEALER. AND THE CUSTOMER VULNERABLE. LB94 WOULD CLOSE THAT GAP. IT ALLOWS A LOCAL COUNTY TREASURER TO ISSUE A TEMPORARY NEBRASKA TITLE TO AN OUT-OF-STATE CAR BUYER WITH THE LIEN NOTED. THAT PERSON WOULD THEN TAKE THE NEBRASKA TITLE TO THEIR RESIDENT STATE AND PRESENT IT ALONG WITH OTHER NECESSARY DOCUMENTS WHEN REGISTERING THE VEHICLE. A SIMILAR PROCESS IS USED IN IOWA AND HAS PROVEN TO BE SIMPLE AND EFFECTIVE IN PROTECTING THE LENDER, THE DEALER, AND THE CUSTOMER, THAT'S ALL THERE IS TO LB94. COLLEAGUES. THE RESTRICTION IS, THE CITY HAS GOT TO APPROVE CROSSING AT THAT INTERSECTION, YOU GOT TO CROSS WITH THE LIGHT AND CONFORM TO THE LAWS IN ALL OTHER RESPECTS WITH REGARDING TO THE OPERATION OF THAT UTV. THERE ARE DISTRICTS IN SOME AREAS. RATHER THAN THE CITY BEING RESPONSIBLE, THEY HAD FORMED A DRAINAGE DISTRICT THAT ARE USUALLY CONTROLLED BY A THREE-MEMBER BOARD. EVER SINCE THEIR EXISTENCE, THEY HAVE BEEN PAYING SALES TAX. IT SEEMS SORT OF FRUITLESS TO BE PAYING SALES TAX THAT GOES TO THE STATE WHEN WE'RE PAYING LOCAL TAXES ON A PROPERTY BASIS TO SUPPORT THESE ENTITIES. WE'RE SORT OF PAYING TAX ON MONEY THAT'S ACTUALLY GOING TO GO BACK TO THE STATE WHEN IT WAS LOCAL DOLLARS, LOCAL TAX DOLLARS BEING EXPENDED. I THINK IT'S A NATURAL EXTENSION OF WHAT WE'RE DOING ALREADY IN RELATIONSHIP TO, FOR EXAMPLE, RURAL FIRE DEPARTMENTS OR AIRPORT AUTHORITIES AND SOME OF THE OTHERS. SO IT'S NOT A BIG DEAL, AND I GUESS TO THE EXTENT OF NOT BEING A BIG DEAL, IF ANY OF YOU HAVE LOOKED AT THE FISCAL NOTE, THE FISCAL NOTE ON THIS IS SO SMALL THAT THE ANALYSIS CAME BACK WHERE THEY COULDN'T EVEN PLACE A NUMBER THAT IT WAS SO MINIMAL. AND COMPARING THAT TO. FOR EXAMPLE. SENATOR HUGHES'S BILL WAS A SAVINGS THEY HAD FIGURED OUT AT ABOUT \$2,000 A YEAR. THIS, THEY COULDN'T EVEN DISTINGUISH THAT IT WOULD EVEN HAVE THAT MUCH SAVED. IT ESSENTIALLY IS NEUTRAL, IT IS SO SMALL. SO WITH THAT, I WOULD ASK YOUR SUPPORT OF LB52 AND WOULD BE WILLING TO ANSWER ANY QUESTIONS THAT MIGHT HAVE COME FORWARD. THANK YOU, LIEUTENANT GOVERNOR. SENATOR HARR: THANK YOU, MR. LIEUTENANT GOVERNOR, MEMBERS OF THE BODY. I DON'T KNOW IF YOU HEARD SENATOR SCHEER'S OPENING. IT WAS VERY INTERESTING. IT'S ABOUT PROVIDING TAX RELIEF, RELEASE OF SALE AND USE TAXES FOR FLOOD CONTROL. IT'S NOT UNIQUE TO OUR RURAL AREAS. IN OMAHA, WE'RE FACING THE EXACT SAME SITUATION. WE HAVE SEWER SEPARATION AND IT'S COSTING US BILLIONS UPON BILLIONS OF DOLLARS. ANYWHERE FROM \$2 TO \$4 BILLION. AND SENATOR TOM WHITE WHO PRECEDED ME, SENATOR HEATH MELLO, BROUGHT BILLS TO DO JUST WHAT THIS DID FOR MUD. LET ME RESTATE THAT. IT'S NOT MUD. IT'S FOR THE CITY OF OMAHA WHO PAYS FOR THAT, BUT IT'S COLLECTED THROUGH YOUR WATER UTILITY BILL. TO SAY, HEY, WE'RE TAX EXEMPT AND IT WAS REJECTED BY THIS BODY BECAUSE, QUOTE, IT WAS TOO EXPENSIVE. WE CAN'T AFFORD TO DO IT, WE HAVE BETTER PRIORITIES. I HAVE AN AMENDMENT HERE THAT WOULD INCLUDE THE CITY OF OMAHA TO GET THE SAME TAX BREAKS THAT

ARE OCCURRING RIGHT NOW WITH LB52. I'M NOT GOING TO PUT THE AMENDMENT IN, I MIGHT SAVE IT FOR SELECT, BUT, FOLKS, YOU SIT THERE AND SAY, FEEL SORRY FOR ME, I'M A FARMER, I PAY TOO MUCH IN PROPERTY TAX, AND YOU DO. I'M NOT GOING TO FIGHT YOU THERE. EVERYONE PAYS TOO MUCH IN TAXES. BUT THIS IS REAL TAX THAT WE HAVE TO PAY IN OMAHA AND IT DOESN'T MATTER IF YOU'RE THE BIGGEST BUSINESS OR THE SMALLEST, POOREST PERSON, WE'VE HAD A HUGE, ASTRONOMICAL INCREASE. SENATOR HILKEMANN: GOOD MORNING, LIEUTENANT GOVERNOR. I WOULD LIKE TO ASK SENATOR SCHEER IF HE WOULD TAKE A QUESTION. [LB52]

PRESIDENT FOLEY: SENATOR SCHEER, WOULD YOU YIELD? [LB52]

SENATOR SCHEER: CERTAINLY, THANK YOU. [LB52]

SENATOR HILKEMANN: SENATOR SCHEER, HOW MANY SANITARY DRAINAGE DISTRICTS ARE THERE IN THE STATE OF NEBRASKA? [LB52]

SENATOR SCHEER: VERY FEW. I CANNOT GIVE YOU AN EXACT NUMBER. THOSE ARE LOCALS. THIS WAS BROUGHT TO ME...NORFOLK DOES HAPPEN TO HAVE ONE. I'M NOT SURE, I THINK SOME PERHAPS HAVE BEEN BROUGHT

UNDER THE AUSPICE OF THE COMMUNITIES AS TIME HAS MOVED ON. WE JUST SIMPLY STILL HAVE A SANITARY DRAINAGE DISTRICT IN THE CITY OF NORFOLK. [LB52]

SENATOR HILKEMANN SENATOR, WHEN I WAS LOOKING AT TRYING TO GET SOME DEFINITION ON THESE, THESE CAN BE AS SMALL AS JUST A MATTER OF A FEW ACRES TO HUNDREDS OF ACRES, AM I CORRECT? [LB52]

SENATOR SCHEER: THEY COULD BE. MOST OF THEM ARE INTENDED OR WERE BUILT AS DRAINAGE GULCHES THROUGH COMMUNITIES OR AROUND COMMUNITIES. AND ESSENTIALLY WHAT THE DISTRICT COMMISSIONERS DO IS TO MAKE SURE THAT THAT GROUND IS MAINTAINED AND MORE EXPRESSLY MOWED SO THAT WHEN WATER DOES GO INTO THESE DITCHES IT'S NOT HOLDING THE WATER UP FROM A PRESSURE STANDPOINT OR NOT COLLECTING DEBRIS AS IT'S MOVING DOWN THAT WOULD CAUSE ESSENTIALLY A DAM THAT WOULD STOP THE WATER FROM FLOWING DOWN. THAT IT DOESN'T SEEM THAT I AM THE ONLY ONE AWARE OF THESE KIND OF MATTERS. WHY ARE YOU NOT OFFERING YOUR AMENDMENT AT THIS POINT? [LB52]

SENATOR HARR: GOOD QUESTION. [LB52]

SENATOR CHAMBERS: I ALWAYS ASK GOOD QUESTIONS AND I APPRECIATE YOUR ACKNOWLEDGMENT, (LAUGHTER) YOUNGSTER. [LB52]

SENATOR HARR: YOU KNOW, BECAUSE I HADN'T DONE MY DUE DILIGENCE PRIOR TO READING THE BILL. I DIDN'T READ IT THOROUGHLY SOON ENOUGH, AND I HAVEN'T HAD A CHANCE TO RUN IT THROUGH THE TRYOUTS. I JUST TALKED TO SENATOR SCHEER THIS MORNING ABOUT MY CONCERNS, AND I DIDN'T WANT TO BLINDSIDE THE SENATOR. I DON'T KNOW EVEN IF THE CITY OF OMAHA WOULD SUPPORT ME IN BRINGING AN AMENDMENT. I KNOW I'VE TALKED TO SOME OTHER UTILITIES AND THEY AREN'T IN SUPPORT OF ME BRINGING AN AMENDMENT, SO. THE MUD BOARD SAYS THEY DON'T WANT ME TO BRING IT AT THIS POINT. SENATOR CHAMBERS: WELL, WHEN THEY SAY THEY'RE WORKING ON SOMETHING TO HELP US, WHO IS EMBRACED BY THAT WORD "US"? DO THEY MEAN THE PEOPLE THAT YOU MENTIONED WHO ARE PAYING HIGHER WATER BILLS? [LB52]

SENATOR HARR: THAT IS THE HOPE. SO THE IDEA IS WE'LL DO SOMETHING THAT'S MORE FOCUSED AT THE LOW END RATHER THAN JUST PROVIDING A TAX BREAK THAT MAY OR MAY NOT BE PASSED ON TO THE LOW-INCOME PEOPLE WHO FEEL THIS INCREASE IN FEES THE MOST. [LB52]

MAYBE THERE'S ONE OF HER SONGS YOU HAVE HEARD: WISHING AND HOPING AND THINKING AND PRAYING. WHEN YOU SAY THAT YOU HOPE THAT A POLITICALLY MOTIVATED BODY IS GOING TO DO THE RIGHT THING TOWARD RATEPAYERS, I THINK YOUR HOPE IS MISPLACED. SO I HOPE NOW BECAUSE I CAN SAY THIS, YOU AND I ARE IN THE SAME BODY THAT CONCERN FOR THE RATEPAYERS WILL NOT BE TRUMPED BY WHAT THE CITY OF OMAHA WANTS, WHAT MUD

SENATOR HARR: THANK YOU, MR. LIEUTENANT GOVERNOR. THANK YOU, SENATOR CHAMBERS, FOR YOUR COMMENTS. I SUPPORT LB52. I WAS

THE CITY HASN'T TAKEN AN OFFICIAL STAND, AND THAT'S PART OF THE REASON WHY I HAVEN'T OFFERED THE AMENDMENT. BUT IT IS A REAL ISSUE IN THE CITY OF OMAHA. THIS IS AN INDIRECT PROPERTY TAX ON US. IT'S A COST OF LIVING THAT IF YOU WANT TO LIVE THERE, YOU GOT TO PAY IT. IT LOOKS LIKE A PROPERTY TAX, IT ACTS LIKE A PROPERTY TAX. AND IT QUACKS LIKE A PROPERTY TAX BECAUSE YOU WANT TO LIVE THERE, YOU GOT TO PAY, AND THERE'S NO WAY AROUND IT. AND IF YOU DON'T HAVE WATER. YOU CAN'T LIVE IN THE CITY. WE DON'T HAVE A SPRING YOU CAN GO OUT TO AND PUMP. WE DON'T HAVE WINDMILLS IN THE CITY. SO YOU'RE AT THE BECK AND CALL. AND THIS IS A REAL ISSUE. YOU KNOW. I HAVE REAL CONCERN ABOUT WHAT WE'RE GOING TO DO. AND I'M NOT ALONE. I KNOW IT'S AN ECONOMIC DEVELOPMENT ISSUE FOR THE CITY OF OMAHA, BRINGING IN NEW BUSINESSES. WE ALWAYS USED TO BRAG THAT WE HAD LOW UTILITY RATES. WE DON'T HAVE THAT ANYMORE. WE DON'T HAVE THE COMPETITIVE ADVANTAGE WE HAD BEFORE. I SUPPORT LB52 BECAUSE I THINK IT'S GOOD POLICY. DO I THINK MY FELLOW SENATORS FROM THE RURAL AREAS WILL REMEMBER THAT NEXT YEAR IF I BRING? YEAH. I DO. I TRUST YOU GUYS. I THINK YOU UNDERSTAND AND YOU'LL BE REMINDED. TRUST ME. PRESIDENT FOLEY: SENATOR SCHEER, WOULD YOU YIELD? [LB52]

PRESIDENT SCHEER: CERTAINLY. [LB52]

SENATOR HARR: THANK YOU, SENATOR. THE SALES AND USE TAX FOR THESE SANITARY DISTRICTS, WHO OWNS THE SANITARY DISTRICTS? IS IT A POLITICAL SUBDIVISION OR INDIVIDUAL? [LB52]

SENATOR SCHEER: NO, IT IS A POLITICAL SUBDIVISION. [LB52]

SENATOR HARR: OKAY. SO...THANK YOU, THAT'S ALL I WANTED TO KNOW. SO HERE YOU HAVE A SALES AND USE TAX FOR FLOODING THAT GOES TO A POLITICAL SUBDIVISION. SAME SITUATION WITH THE CITY. THE CITY HAS TO COME THROUGH AND THEY HAVE TO BUY THE PIPE, THE CONCRETE, ALL THAT GOES INTO SEWER SEPARATION, AND THAT GOES BACK, YOU KNOW, THEY PAY A TAX ON IT. THE CITY PAYS A TAX ON IT. IT COMES BACK AS AN ADDITIONAL COST AND THEN THE STATE GETS THE MONEY AND WE IN OMAHA

PAY THE ADDITIONAL COST. DOESN'T MAKE SENSE TO TAX A POLITICAL SUBDIVISION. AGAIN, WHAT'S GOOD FOR THE GOOSE, GOOD FOR THE GANDER. I SUPPORT LB52 AND I LOOK FORWARD TO WORKING WITH MY FELLOW SENATORS NEXT YEAR ON SOMETHING TO HELP CONTROL FLOODING IN THE CITY OF OMAHA AS WELL. THANK YOU, MR. LIEUTENANT GOVERNOR. [LB52]

PRESIDENT FOLEY: THANK YOU, SENATOR HARR. SENATOR FRIESEN, YOU'RE RECOGNIZED. [LB52]

SENATOR FRIESEN: THANK YOU, LIEUTENANT GOVERNOR, I'LL HAVE TO AGREE WITH SENATOR McCOLLISTER. IN THE PAST WHEN THE RURAL AREAS. TOO. WHEN THE SMALL CITIES ADDRESSED SOME DRAINAGE ISSUES THAT I'M FAMILIAR WITH, WE PAID THE SALES TAX AND WE MOVED FORWARD. IT WAS JUST A PART OF THE COST OF DOING BUSINESS. THE MORE WE GRANT EXEMPTIONS AND CARVE OUT NICHES WE ARE NOT GOING TO BE ABLE TO ADDRESS THE PROPERTY TAX ISSUE DOWN THE ROAD. SO WHEN WE START LOOKING AT ALL THESE SMALL ITEMS, SUDDENLY THEY ADD UP TO VERY LARGE ITEMS. AND SO IN THE PAST THERE HAVE BEEN TOO MANY EXEMPTIONS GRANTED AND LAST YEAR EVERYBODY LOOKED AT ALL THE EXEMPTIONS FROM SALES TAX AND. YES. SOME MORE WERE GRANTED. BUT I THINK THIS IS SOMETHING WE HAVE TO LOOK AT REALLY HARD BEFORE WE DO THIS. THERE'S OTHER ISSUES AT PLAY WHEN IT COMES TO THE CITY AT OMAHA AND HOW THINGS WERE DONE IN YEARS PAST. IT WAS AN EXTREMELY HIGH COST ALSO. NEW WATER SYSTEMS WERE PUT IN AND THOSE COSTS ADDED UP, AND THEY WERE NOT CHEAP EITHER. AND SO I THINK WE HAVE TO LOOK REALLY SERIOUSLY AT ADDING MORE EXEMPTIONS TO THE CAUSE. SO THANK YOU. [LB52]

PRESIDENT FOLEY: THANK YOU, SENATOR FRIESEN. SENATOR CHAMBERS, AND THIS IS YOUR THIRD OPPORTUNITY, SENATOR. [LB52]

SENATOR CHAMBERS: THANK YOU, MR. PRESIDENT. AND I AM PREPARING A MOTION. AND I WANT SENATOR SCHEER TO KNOW THAT MY INTENT IS NOT GENERATED BY OPPOSITION TO HIS BILL PER SE. BUT WHEN ANY ITEM OR SUBJECT COMES BEFORE THIS BODY IT IS OPEN TO DISCUSSION AND WHEN IT'S A SERIOUS ONE SUCH AS THIS THAT GOES TO A PRINCIPLE, IT'S GOING TO GET THAT DISCUSSION IF I PERCEIVE THE PRINCIPLE IN HEARING IN IT.

AND IF I HAVE TO BE THE ONLY ONE DOING IT. I'M GOING TO DO IT BECAUSE I BELIEVE IN THE IMPORTANCE OF COMPILING WHAT'S CALLED A LEGISLATIVE HISTORY ON MATTERS SUCH AS THIS. I'LL GIVE AN EXAMPLE. YOU SAY ABORTION IN A LEGISLATURE SUCH AS THIS AND EVERYBODY'S EYES OPEN, THEIR EARS GO UP, AND THEY START DIALING THE TELEPHONE TO SEE WHAT THEIR MARCHING ORDERS ARE. SO THAT'S WHY I WANT TO USE THIS EXAMPLE. THEY BROUGHT A BILL HERE SOME YEARS AGO DEALING WITH WHAT THEY CALL LATE-TERM ABORTION. I AM OPPOSED TO ANY STATE ENCROACHMENT ON THE RIGHT OF A WOMAN TO MAKE A DECISION ABOUT HER OWN BODY AND HER OWN BUSINESS. AND I DON'T WANT ANY MALE-DOMINATED ORGANIZATIONS WHETHER IT'S CALLED A CHURCH OR WHATEVER TO DICTATE TO WOMEN WHAT THEY ARE TO DO. AND I. AS ONE. CANNOT VOTE THESE THINGS DOWN, BUT I CAN TRY TO CRIPPLE THEM. SHOW HOW FOOLISH THEY ARE, AND GET INTO THE RECORD THAT WHICH A COURT MAY USE TO STRIKE THE WHOLE THING DOWN. SO ON THIS BILL THAT I'M TALKING ABOUT I ASK QUESTIONS TO VARIOUS MEMBERS ON THE FLOOR, INCLUDING THE INTRODUCER OF THE BILL, AND I KNEW THE WAY HE HAD TO ANSWER THE QUESTION. IF YOU ARE CONTESTING WITH SOMEBODY IN A COURTROOM. BEFORE YOU ASK A QUESTION BE AWARE OF WHAT THE ANSWER NOT ONLY SHOULD BE BUT WHAT IT COULD BE. BUT I STUDY THE PEOPLE ON THIS FLOOR AFTER I'VE BEEN AROUND THEM FOR A CERTAIN AMOUNT OF TIME AND I KNEW WHAT HE WOULD HAVE TO GIVE AS AN ANSWER, AND IT WAS HIS ANSWER ONCE OBTAINED THAT LET ME KNOW I HAD WON. WHEN THE VOTE CAME, I WAS THE ONLY ONE VOTING AGAINST THE BILL, BUT WHEN THE THING WAS CHALLENGED IT WAS FIRST THE FEDERAL DISTRICT COURT. MY EXCHANGE WITH THAT PERSON WAS CITED BY THE COURT IN SHOWING WHY THE BILL WAS UNCONSTITUTIONALLY VAGUE AND OVERREACHING BASED ON THE STATEMENTS MADE BY THE INTRODUCER OF THE BILL, AND IT WAS STRUCK DOWN. IT WAS APPEALED TO THE EIGHTH CIRCUIT. SAME THING, SAME EXCHANGE WAS RELIED ON. AND THEY AGREED WITH THE DISTRICT COURT. IT WAS APPEALED ALL THE WAY TO THE U.S. SUPREME COURT, AND IT WAS AS THAT SONG I TOLD YOU, THIRD VERSE, SAME AS THE FIRST. IT WAS STRUCK DOWN. SO ALTHOUGH I WAS THE ONLY ONE WHO VOTED AGAINST IT I WAS THE ONLY ONE WHO WAS RIGHT. SO EVEN THOUGH PEOPLE AT THIS POINT IN THE SESSION MAY BE TRYING TO MANIFEST COLLEGIALITY, I KNOW THE WAY THINGS ARE GOING TO DEVELOP BY THE TIME WE GET DEEPER INTO THE SESSION SO I'M STAKING OUT MY POSITION NOW SO NOBODY WILL BE SURPRISED. THIS THAT YOU'RE DOING IS GOING TO COME BACK TO BITE YOU. SENATOR SCHEER'S LITTLE BILL AS IT HAS BEEN POINTED OUT... [LB52]

SENATOR CHAMBERS: ...BY ITSELF IS NOT GOING TO DO THAT MUCH HARM. BUT I HAVE A LITTLE ANALOGY THAT I'VE GIVEN FROM TIME TO TIME WHICH I INTEND TO GIVE. BUT SINCE THIS IS MY THIRD TIME TO SPEAK AND I CAN'T SPEAK AGAIN UNLESS I CREATE THE OPPORTUNITY FOR MYSELF, THAT'S WHAT I PROPOSE TO DO DIRECTLY. THANK YOU, MR. PRESIDENT. [LB52]

PRESIDENT FOLEY: THANK YOU, SENATOR CHAMBERS. SENATOR McCOLLISTER. [LB52]

SENATOR McCOLLISTER: THANK YOU, MR. LIEUTENANT GOVERNOR, COLLEAGUES. WE'RE TALKING BIG MONEY HERE, NOT FOR THIS PARTICULAR BILL, LB52, BUT IF WE WERE TO EXEMPT OUT THE SALES TAX FOR THE PROJECTS IN OMAHA, WHICH I ESTIMATE PROBABLY IS \$250 MILLION A YEAR WHEN YOU INCLUDE OPPD, CITY OF OMAHA, AND MUD, WE'RE TALKING REAL MONEY BECAUSE THE REVENUE TO THE STATE IS IN THE NEIGHBORHOOD OF \$13 MILLION, SO WE ARE TALKING BIG MONEY AND I DOUBT THE CITY OF OMAHA IS GOING TO WANT TO LOSE THAT REVENUE. SO, YOU KNOW, WE SHOULD BE CONSCIOUS OF WHAT WE'RE DOING HERE ESTABLISHING AS A PRECEDENT BECAUSE WE WILL BE BACK TO TALK ABOUT OMAHA'S PARTICULAR SITUATION IF WE CONTINUE TO MOVE ON BILLS OF THIS SORT. THANK YOU, MR. LIEUTENANT GOVERNOR. [LB52]

PRESIDENT FOLEY: THANK YOU, SENATOR McCOLLISTER. SENATOR GLOOR. [LB52]

SENATOR GLOOR: THANK YOU, MR. PRESIDENT. GOOD MORNING, MEMBERS. AS CHAIR OF THE REVENUE COMMITTEE I FEEL THE NEED TO POINT OUT TO THE BODY AND WOULD ASK THE BODY TO TAKE A DEEP BREATH. GO TO YOUR FILE, WHICH I'M SURE YOU BROUGHT UP FROM DOWN BELOW OR DOWN THE HALL. YOU WILL NOTICE THIS BILL CAME OUT OF THE COMMITTEE WITH NO DISSENTING VOTES, WITH NO OPPOSITION FROM ANYBODY WHO WAS A TESTIFIER, AND WITH NO FISCAL NOTE. NO FISCAL NOTE. THE COMMENT IS THE IMPACT WILL BE MINIMAL AND I THINK DURING THE TESTIMONY THE DISCUSSION WAS MAYBE WE'RE TALKING ABOUT \$1,000. THIS IS A DRAINAGE DISTRICT, A DRAINAGE DISTRICT. I UNDERSTAND SENATOR HARR'S ENTHUSIASM ABOUT THE CHALLENGES OMAHA FACES. I ALWAYS APPRECIATE SENATOR CHAMBERS USING DIFFERENT BILLS TO EDUCATE THE BODY, BUT I WANT TO MAKE SURE THAT WE DON'T GET OUR APPLES AND ORANGES MIXED HERE, I DO NOT THINK, I DON'T THINK THE COMMITTEE THINKS WE'RE SETTING PRECEDENT. WE ALREADY EXEMPT CERTAIN DRAINAGE DISTRICTS. SO WE'RE NOT SETTING A PRECEDENT. WE ALREADY EXEMPT SOME DRAINAGE DISTRICTS. WHAT SENATOR SCHEER IS TRYING TO DO WITH HIS LEGISLATION IS, IN FACT, ADD TO THE DEFINITION OF THE TYPE

OF DRAINAGE DISTRICTS THAT ARE EXEMPT. AND YOU'RE WELCOME TO ASK ME TO DEFINE THAT. I'M NOT ABLE AT THIS PERIOD OF TIME TO DEFINE HOW HIS IS DIFFERENT, BUT HE PERHAPS COULD DO THAT IF YOU WANT TO ASK A QUESTION. AGAIN, WE TALKED ABOUT THIS BILL IN COMMITTEE. IT CAME OUT 8-0, WE HAD NO OPPONENTS, NO FISCAL NOTE ATTACHED TO IT, INTERESTING DISCUSSION, BUT WE HAVE GOTTEN WAY DOWN THE ROAD WITH THIS DIALOGUE BEYOND WHAT THE ORIGINAL INTENT OF HIS BILL IS, WHICH RELATES TO DRAINAGE DISTRICTS WHICH ARE ALREADY EXEMPT UNDER STATUTE AND ADDING TO IT A SMALL CHANGE TO ADD THE DEFINITION THAT FITS THE DRAINAGE DISTRICT HE IS TALKING ABOUT. THANK YOU. [LB52]

PRESIDENT FOLEY: THANK YOU, SENATOR GLOOR. MR. CLERK. [LB52]

ASSISTANT CLERK: MR. PRESIDENT, I DO HAVE A PRIORITY MOTION, SENATOR CHAMBERS HAS MOVED TO BRACKET THE BILL UNTIL APRIL 15. [LB52]

PRESIDENT FOLEY: SENATOR CHAMBERS, YOU'RE WELCOME TO OPEN ON YOUR BRACKET MOTION. [LB52]

SENATOR CHAMBERS: THANK YOU, MR. PRESIDENT, MEMBERS OF THE LEGISLATURE. I WOULD LIKE TO ASK SENATOR GLOOR A QUESTION OR TWO. [LB52]

PRESIDENT FOLEY: SENATOR GLOOR, WOULD YOU YIELD? [LB52]

SENATOR GLOOR: CERTAINLY. [LB52]

SENATOR CHAMBERS: SENATOR GLOOR, AS I LOOK AT THIS AGENDA SHEET IT STATES LB52 EXEMPT SANITARY DRAINAGE DISTRICTS FROM SALES AND USE TAXES. DOES THE TERM "EXEMPT" WHEN WE'RE TALKING ABOUT TAXES APPLY TO OTHER THAN SANITARY DRAINAGE DISTRICTS? [LB52]

SENATOR GLOOR: WELL, IF I UNDERSTAND YOUR... [LB52]

SENATOR CHAMBERS: WHEN WE TALK ABOUT MAKING EXEMPTIONS, DO EXEMPTIONS APPLY TO MORE THAN SANITARY DRAINAGE DISTRICTS? [LB52]

SENATOR GLOOR: CERTAINLY. [LB52]

SENATOR CHAMBERS: WHEN WE TALK ABOUT SALES AND USE TAXES, ARE THOSE CATEGORIES OR DESIGNATIONS THAT APPLY TO MORE THAN DRAINAGE DISTRICTS? [LB52]

SENATOR GLOOR: CERTAINLY. [LB52]

SENATOR CHAMBERS: THANK YOU. IF I STUDY HISTORY AND I'M IN THE HISTORY SECTION OF THE LIBRARY STACKS, THE FACT THAT THAT IS WHERE I FOCUS MY INTEREST, DOES THAT MEAN THAT THE ONLY BOOKS IN THOSE STACKS WILL BE BOOKS DEALING WITH HISTORY? [LB52]

SENATOR GLOOR: WELL, NOW YOU'RE IN AN AREA THAT I HAVE A LITTLE EXPERTISE BUT NOT AS MUCH AS YOURS, SO I WON'T CHALLENGE YOU ON THAT, AND I'LL SAY, CERTAINLY. [LB52]

SENATOR CHAMBERS: THANK YOU. MEMBERS OF THE LEGISLATURE. HERE'S THE POINT THAT I'M GETTING TO. WE DEAL WITH SUBJECT MATTERS HERE. WELL, LET ME SPEAK FOR MYSELF. MAYBE THE OTHERS DON'T. BUT THERE ARE SUBJECT MATTERS, SALES AND USE TAXES. WHAT HAS BEEN THE THEME OF THIS SESSION? PROPERTY TAXES. THERE ARE OTHER BIG MONEY PEOPLE WHO ARE INTERESTED IN INCOME TAX BREAKS. BUT THEN WHEN YOU GET TO THE JUSTIFICATION, THAT'S WHEN YOU START TALKING ABOUT, WELL, IT'S JUST A LITTLE BIT HERE, A LITTLE BIT THERE, HERE A LITTLE, THERE A LITTLE, EVERYWHERE A LITTLE. LITTLE. PRINCIPLES WILL MEAN NOTHING. THEY MIGHT INCIDENTALLY BE REFERRED TO. BUT NOW WE'RE ABLE TO HAVE ALMOST AN ACADEMIC DISCUSSION OF TAXATION AND WHO PAYS, WHO DOESN'T PAY, WHO OUGHT TO PAY, AND WHO IS STRONG ENOUGH TO NOT PAY EVEN THOUGH THEY PROBABLY HAVE A GREATER OBLIGATION TO PAY BECAUSE THEY GET GREATER BENEFITS FROM THE TAXES THAT EVERYBODY ELSE PAYS. THERE ARE BUSINESSES THAT ARE SUBSIDIZED IN THE CARE AND CONCERN THAT THEY ARE SHOWN BECAUSE EVERYBODY ELSE IS PAYING. WATER BILLS, EVEN, SO TO STAND ON THIS FLOOR LIKE SENATOR HARR JUST DID AND TALK ABOUT WE HELP EACH OTHER, THAT IS NONSENSE. WE DON'T DO THAT. I DID NOT WANT TO NOT SPEAK IN RELATIONSHIP TO A BRACKET MOTION BECAUSE OBVIOUSLY I WOULD OPPOSE A BRACKET MOTION AND WOULD HOPE AT SOME POINT IN TIME BEFORE A VOTE WAS MADE THAT PERHAPS SENATOR CHAMBERS WHEN HE FINISHES THE AMOUNT OF TIME THAT HE MAY BE ALLOTTED WOULD WITHDRAW THE BILL OR THE AMENDMENT AT THAT POINT IN TIME. THE ONLY THING THAT I WOULD LIKE TO ADD IN RELATIONSHIP TO THE DISCUSSION SO FAR AND NOT TAKING OFFENSE WITH ANYTHING THAT SENATOR CHAMBERS SAID, BUT WE TALK ABOUT HISTORY REPEATING ITSELF AND I THINK THERE IS A LOT TO THAT. I DON'T DISAGREE THAT PERHAPS THERE HAVE BEEN POLITICAL DISPUTES, THAT THERE HAVE BEEN URBAN AND METROPOLITAN DIVIDES. I DON'T QUESTION THAT. BUT I'VE NOT SEEN THAT THIS YEAR. AND WE HAVE 18 NEW SENATORS THIS YEAR. TWO YEARS AGO. THERE WERE 11 OF US THAT WERE BROUGHT IN. LITERALLY HAVE OVER HALF THE BODY THAT'S BEEN REPLACED IN TWO YEARS. AND TO MAKE AN ASSUMPTION THAT THIS BODY WILL MOVE IN ONE DIRECTION OR ANOTHER. I DON'T THINK IS FAIR TO ESPECIALLY THOSE NEW SENATORS, OR REALLY ANY OF US. I KNOW I'M ELECTED BY THE 19th DISTRICT. BUT I'M A NEBRASKA SENATOR AND I WOULD HOPE THAT I TAKE POSITIONS THAT WOULD BE AT LEAST IN MY OPINION IN THE BETTERMENT OF THE ENTIRE STATE, NOT JUST MY DISTRICT. AND I WOULD THINK AND HOPE THAT ALL OF MY COLLEAGUES ON THE FLOOR WOULD DO THE SAME. I'M VERY SYMPATHETIC WITH WHAT'S GOING ON IN OMAHA IN RELATIONSHIP TO THEIR WATER AND SEWER SEPARATION PROBLEMS. I MEAN, I GUESS I'M RURAL BECAUSE I'M NOT PART OF THE METROPOLITAN AREA. I UNDERSTAND THAT. BUT I'M NOT ADVERSE TO PROVIDING RELIEF TO THAT COMMUNITY FOR THOSE. THAT'S A HUGE AMOUNT OF MONEY. I MIGHT BE IN THE MINORITY. I DON'T KNOW. BUT TO CAST THAT IT'S A ALL-EXCLUSIVE RURAL AND URBAN DIVIDE, I JUST DON'T THINK IS ENTIRELY THE CASE. I THINK WE SHOULD BE JUDGED ON HOW WE ACT UPON THINGS AND, QUITE FRANKLY, WE'VE NOT HAD THE OPPORTUNITY IN THE LAST TWO YEARS THAT I'VE BEEN HERE AND PERHAPS WE WILL HAVE THE OPPORTUNITY TO LOOK AT THAT ISSUE NEXT YEAR. I DON'T THINK IT IS GERMANE TO MY BILL, BUT IF WE WANT TO USE THAT FOR DISCUSSION PURPOSES. SO BE IT. BUT I DO WANT TO JUST EMPHASIZE THAT I THINK WE'RE ALL NEBRASKA SENATORS AND WE DO CARE ABOUT WHAT HAPPENS IN SCOTTSBLUFF OR IN FALLS CITY, AND IT SHOULDN'T MAKE ANY DIFFERENCE TO THE SIZE OF THE COMMUNITY OR WHERE THE PEOPLE ARE LOCATED. PRESIDENT FOLEY: THANK YOU, SENATOR BRASCH. SENATOR CHAMBERS, YOU'RE RECOGNIZED. [LB52]

SENATOR CHAMBERS: THANK YOU. MR. PRESIDENT, MEMBERS OF THE LEGISLATURE, THE DIFFERENCE BETWEEN ME AND MY COLLEAGUES IS THAT I SEE LIFE AS A WHOLE. LIFE AS A CONTINUUM. IT'S LIKE THE SPIDER WEB. THOSE THAT ARE BUILT LIKE AN ORB. COULD HAPPEN TO YOUR BILL? [LB52]

SENATOR SCHEER: IT WOULD BE PASSED. [LB52]

SENATOR CHAMBERS: SAY IT AGAIN? [LB52]

SENATOR SCHEER: IT WOULD BE PASSED. [LB52]

SENATOR SCHEER: ABSOLUTELY. [LB52]

IF THE ASSESSMENT RATIO FOR PROTECTED INDUSTRIES IS HIGHER THAN THE COMPARABLE INDUSTRIES, THE STATE MUST EQUALIZE THE ASSESSMENTS OF THE PROTECTED INDUSTRIES. IT CLARIFIES THAT INTEREST WILL NOT BE PAID ON REFUNDS FOR RENEWABLE ELECTRIC GENERATION FACILITIES OR UNDER THE HISTORIC PRESERVATION CREDIT ACT. THIS ALSO PASSED UNANIMOUSLY AND HAD NO OPPONENTS. I'D ASK FOR A YES VOTE ON LB261. [LB261]

(AM45, LEGISLATIVE JOURNAL PAGE 347.) [LB142]

PRESIDENT FOLEY: THANK YOU, MR. CLERK. SENATOR SCHILZ, YOU'RE WELCOME TO OPEN ON LB142. [LB142]

SENATOR SCHILZ: THANK YOU. MR. PRESIDENT AND MEMBERS OF THE BODY. GOOD MORNING AND THANK YOU FOR YOUR CONSIDERATION ON THIS BILL. LB142 WOULD CREATE THE AQUATIC INVASIVE SPECIES PROGRAM AND IT PLACES A FEE ON MOTORBOAT REGISTRATIONS AND RENEWALS IN NEBRASKA TO FUND THE PROGRAM. THE PROGRAM WOULD ALLOW THE GAME AND PARKS TO MONITOR AND SAMPLE NEBRASKA WATER FOR INVASIVE SPECIES, HIRE PERSONNEL, BUY INSPECTION AND DECONTAMINATION EQUIPMENT, PROVIDE ENFORCEMENT, EDUCATION, AND RESEARCH RELATING TO AQUATIC INVASIVE SPECIES. OBVIOUSLY, AQUATIC INVASIVE SPECIES DEFINED IN STATUTE ARE EXOTIC OR NONNATIVE ORGANISM THAT POSE A SIGNIFICANT THREAT TO THE AQUATIC RESOURCES, WATER SUPPLIES, OR WATER INFRASTRUCTURES OF THE STATE, THERE'S OVER 30 AQUATIC INVASIVE SPECIES THAT PRESENTLY THREATENS OUR WATERS AND RESOURCES AND HAVE BEEN IDENTIFIED BY THE GAME AND PARKS COMMISSION, WHICH INCLUDE PHRAGMITES AND ZEBRA MUSSELS. AND OBVIOUSLY MANY OF YOU MAY HAVE HEARD ABOUT THE ZEBRA MUSSEL PROBLEM ON ZORINSKY LAKE IN OMAHA. AQUATIC INVASIVE SPECIES HAVE BEEN GROWING IN NEW HABITATS RAPIDLY, INCLUDING OUR SURROUNDING STATES OF KANSAS AND SOUTH DAKOTA. AQUATIC INVASIVE SPECIES POPULATIONS GROW QUICKLY AND SPREAD RAPIDLY. THEY DISPLACE NATIVE SPECIES, CLOG WATERWAYS, IMPACT MUNICIPAL AND INDUSTRIAL **IRRIGATION AND POWER SYSTEMS, INCLUDING AGRICULTURAL IRRIGATION** SYSTEMS. THEY DEGRADE ECOSYSTEMS AND CAN CAUSE WILDLIFE AND PUBLIC HEALTH PROBLEMS. AND I'VE GOT A HANDOUT COMING AROUND THAT YOU CAN SEE SOME OF THE ISSUES. THE BILL AUTHORIZES THE FEES OF AT LEAST \$5 BUT NO MORE THAN \$10 FOR A MOTORBOAT REGISTERING OR RENEWING IN NEBRASKA. IT WOULD ALSO REQUIRE OUT-OF-STATE MOTORBOAT OWNERS TO PAY A STAMP FEE OF AT LEAST \$10 BUT NOT MORE THAN \$15 FOR MOTORBOATS IF THEY WILL BE OPERATING IN NEBRASKA WATERS. THE FEES WILL CONTRIBUTE TO THE \$330.000 COST TO THE GAME OF PARKS COMMISSION FOR CARRYING OUT ITS DUTIES UNDER THE PROGRAM. I SHOULD TELL YOU THAT THERE WAS NO OPPOSITION TO THE BILL AT THE COMMITTEE HEARING, AND THE COMMITTEE ADVANCED THE BILL UNANIMOUSLY. THANK YOU VERY MUCH, MR. PRESIDENT. [LB142]

PRESIDENT FOLEY: THANK YOU, SENATOR SCHILZ. AS THE CLERK STATED, THERE ARE AMENDMENTS FROM THE NATURAL RESOURCES COMMITTEE. SENATOR SCHILZ, AS CHAIR OF THE COMMITTEE, YOU'RE RECOGNIZED TO OPEN ON THE COMMITTEE AMENDMENTS. [LB142]

SENATOR SCHILZ: THANK YOU, MR. PRESIDENT. AND AM45 SIMPLY CLARIFIES THE LANGUAGE THAT CREATES THE PROGRAM AND LISTS ITS PURPOSES. IT'S TO ENSURE THAT THE FUNDS RAISED WILL BE USED SPECIFICALLY FOR THAT

PURPOSE WHILE AT THE SAME TIME ENSURING THAT THE LIST OF ACTIVITIES TO BE DONE UNDER THE PROGRAM IS NOT ALL INCLUSIVE. THE WORDING IN SECTION 2 OF THE BILL WAS REWRITTEN TO MAKE IT CLEAR THAT THE FUNDS WILL BE USED FOR INVASIVE SPECIES ACTIVITIES WHICH ARE NOT ONLY LIMITED TO THE ACTIVITIES LISTED. THE AMENDMENT ALSO CLARIFIES THE PROPER TERM FOR WATERCRAFT THAT WILL BE SUBJECT TO THE FEE, WHICH IS "MOTORBOAT," AND THAT'S DEFINED IN STATUTE AS "WATERCRAFT PROPELLED IN ANY RESPECT BY MACHINERY." WITH THAT, I WOULD ASK YOUR FOR SUPPORT FOR THE AMENDMENT AND THE UNDERLYING BILL. THANK YOU, MR. PRESIDENT. [LB142]

PRESIDENT FOLEY: THANK YOU, SENATOR SCHILZ. SENATOR KOLOWSKI. [LB142]

SENATOR KOLOWSKI: THANK YOU, MR. PRESIDENT. AND GOOD MORNING, NEBRASKA. I STAND IN SUPPORT OF THIS BILL, LB142. LIVING IN AN AREA THAT HAD THIS IMPACT, HIT LAKE ZORINSKY IN SOUTHWEST OMAHA, RIGHT IN THE MIDDLE OF MY DISTRICT, THEY WENT THROUGH QUITE A...ABOUT AN 18-MONTH PERIOD OF ENTIRELY DRAINING THE LAKE, SITTING BARE FOR AN ENTIRE WINTER TO FREEZE OUT AND KILL ALL THE MUSSELS AND ANYTHING ELSE THAT WERE GATHERING IN THAT PARTICULAR LAKE, AND THEN REFILLING THE LAKE A YEAR LATER. IT WAS A MESS FOR QUITE A WHILE AND VERY DISTURBING TO SEE THAT HAPPEN. BUT IT HAS WORKED. THAT PARTICULAR PLAN HAS KEPT THE LAKE ZORINSKY FREE OF ADDITIONAL INVASIVE SPECIES. AND IT'S NOT JUST THE ZEBRA MUSSELS AND THOSE TYPES OF THINGS. YOU HAVE TO WATCH OUT FOR THE PLANTS THAT ALSO GET IN THERE. ASSUMING THE GAME AND PARKS DECIDES IF IT'S \$5 ONE YEAR, \$10 THE NEXT, AND DEPENDING ON WHAT THE BUDGET NEEDS? [LB142]

SENATOR SCHILZ: YEAH, THERE'S A SPACE THERE AND I'M TRYING TO THINK IF IT'S BASED ON THE SIZE OF THE VESSEL OR IF THEY HAVE THAT ABILITY TO SPREAD THAT OVER EACH VESSEL. PRESIDENT FOLEY: THANK YOU, SENATOR GROENE. SENATOR SCHILZ, YOU'RE RECOGNIZED FOR 5:00. [LB142]

SENATOR SCHILZ: THANK YOU, MR. PRESIDENT. AND THANK YOU, SENATOR GROENE, FOR THE OPPORTUNITY. I WOULD LIKE TO ADDRESS SENATOR BLOOMFIELD'S COMMENTS. AND I KNOW HIS FEELINGS ON SOME OF WHAT HAPPENS OUT THERE. BUT I CAN TELL YOU THIS. IT'S SPECIFICALLY FOR THAT REASON THAT YOU TALK ABOUT THAT WE PUT THE AMENDMENT IN. AND WE FULLY EXPECT THAT WHEN THIS MONEY IS USED, THEY ARE GOING TO BE PARTNERING WITH OTHER...OTHER AGENCIES, OTHER INDIVIDUALS OR, SHOULDN'T SAY OTHER INDIVIDUALS, OTHER AGENCIES THAT WILL...THAT WILL BE WORKING TOGETHER ON THIS. SO I THINK IT'S PRETTY SAFE THAT THIS MONEY IS GOING TO BE SPENT IN THE PROPER FASHION, AT LEAST I HOPE IT IS. AND THEN TO SENATOR GROENE'S QUESTION. AND I...THE CURRENT BOAT FEES ARE BASED ON THE SIZE. SO AS YOU GO UP IN SIZE THAT FEE WOULD GO UP. SO IT DEPENDS ON HOW LARGE YOUR BOAT IS AS TO HOW MUCH YOU PAY. AND LIKE I SAID BEFORE, WE HAVE SOME POLLING THAT'S BEEN DONE OF BOAT OWNERS AS THEY WERE ON THE LAKES AND ABOUT 95 PERCENT OF THOSE FOLKS SAID THAT THEY WOULD BE INTERESTED, IN SOME FASHION, TO BE ABLE TO HELP HANDLE THIS ISSUE. PRESIDENT FOLEY: THANK YOU, MR. CLERK. SENATOR STINNER, YOU'RE WELCOME TO OPEN ON LB241. [LB241]

SENATOR STINNER: THANK YOU. MR. PRESIDENT, I AM OVER HERE, MY BUNKMATE IS GETTING ORGANIZED SO I DIDN'T WANT TO INTERFERE WITH HIM. IT'S A PLEASURE TO PRESENT A BILL WHOSE CONCEPT ORIGINATED IN MY DISTRICT. A CITY OR A VILLAGE OR A CEMETERY ASSOCIATION FORMED BY A CITY OR VILLAGE, IN OTHER WORDS FROM 0 TO 300.000. INTERESTINGLY. IF YOU'RE PRIVATELY OWNED. LIKE A CATHOLIC CEMETERY OR THE VETERANS' CEMETERY, YOU DO NOT HAVE THIS REQUIREMENT. YOU'RE NOT COVERED UNDER THIS LAW. I SHOULD ALSO NOTE THAT THE CITIZENS AND/OR CEMETERY MAY STILL FILE SUCH A DEED IF THEY SO DESIRE. JEAN BAUER, A REGISTER OF DEEDS FOR SCOTTS BLUFF COUNTY. PROVIDED ME A HISTORY AND AN EXPLANATION OF WHAT LB241 IS INTENDED TO DO. AS SHE STATES BEST, LB241 IS...IF LB241 IS PASSED. IT WOULD ALLOW CEMETERIES WITHIN THE STATE OF NEBRASKA TO BYPASS THE REGISTER OF DEEDS OFFICE IN ISSUING CEMETERY DEEDS OR CERTIFICATES AND, INSTEAD, USE THEIR OWN RECORDKEEPING SYSTEM TO TRACK WHO THE LOTS ARE OWNED BY AS WELL AS WHO IS BURIED IN THE LOTS. THE COUNTY REGISTER OF DEEDS ONLY RECORDS WHO OWNS THE LOTS. IN OTHER WORDS, IF YOU BOUGHT FOUR LOTS AND IT WAS NOW, REGISTER OF DEEDS WOULD TAKE THAT. THAT WOULD BE THE ONLY RECORD IS, OF OWNERSHIP, IN THEIR RECORDS, THE CEMETERIES HAVE DETAILED MAPS AND PLATS OF THE CEMETERY AND TRACK NOT ONLY THE OWNER OF THE LOT BUT ALSO WHO IS BURIED IN THE LOT. I AM ADVISED THAT MOST CITY AND CEMETERY ASSOCIATION CEMETERIES HAVE EXCELLENT RECORDS ON BOTH WHO OWNS THE LOT AND WHO IS BURIED. THE SAME IS TRUE OF THE VETERANS' CEMETERIES. NO MAYOR OR CITY COUNCIL WANTS A MISTAKE CONCERNING WHO OWNS THE CEMETERY LOT OR WHO IS BURIED

IN THE LOT. THE RECORDS OF THE CEMETERY ARE SELF-POLICING WITH COUNCIL AND/OR VILLAGE BOARD OVERSIGHT. JUST LIKE ANY OTHER LOCAL GOVERNMENT FUNCTION. JEAN GOES ON TO STATE IF CEMETERIES DO NOT HAVE A RECORDKEEPING SYSTEM OF THEIR OWN, LB241 WOULD ALLOW THE CEMETERIES TO CONTINUE TO RECORD THESE DEEDS OR CERTIFICATES THE SAME WAY THEY HAVE DONE FOR YEARS. IN ADDITION FOR THOSE CEMETERIES WHO WOULD CHOOSE TO BYPASS THE REGISTER OF DEEDS OFFICE. I ALSO WANT TO NOTE ... POINT OUT SOMETHING ELSE SHE SAID. WHEN A PERSON RECEIVES A DEED FROM A CEMETERY, THEY ARE NOT RECEIVING TITLE TO THE LAND. ALL THEY'RE...THE ONLY THING THE PERSON IS RECEIVING OR GETTING IS A RIGHT TO BE BURIED THERE. I THINK THAT'S AN IMPORTANT DISTINCTION. THEREFORE, NO CEMETERY LOTS ARE EVER COVERED UNDER TITLE INSURANCE. IN RECENT YEARS, SEVERAL CEMETERIES HAVE SWITCHED FROM ISSUING DEEDS. WHICH I THINK WE ALL GET CARRIED AWAY WITH WHAT A DEED IS, TO CERTIFICATES. I JUST WANT TO KIND OF GO THROUGH THE PROCEDURE TODAY BECAUSE IF YOU HAVEN'T...IF YOU'RE NOT FAMILIAR WITH IT, IF YOU WALK IN, FOR AN EXAMPLE, IN MORRILL, NEBRASKA. WHICH IS A VILLAGE. THEY HAVE A CEMETERY. SO YOU WALK IN AND YOU WANT TO PURCHASE FOUR OR FIVE LOTS FOR YOU AND YOUR FAMILY MEMBERS. YOU WOULD GET A CERTIFICATE FROM MORRILL, FROM THE CEMETERY. IT WOULD BE STAMPED BY THE VILLAGE. IT WOULD HAVE THE...WELL, IN A CITY SITUATION YOU WOULD HAVE A MAYOR, BUT IN A VILLAGE SITUATION YOU WOULD HAVE THE PRESIDENT OF THE VILLAGE BOARD SIGN IT, THE CLERK. SENATOR BLOOMFIELD: THANK YOU, MR. PRESIDENT. WOULD SENATOR STINNER YIELD TO A QUESTION? [LB241]

SENATOR STINNER: YES, I WOULD. [LB241]

PRESIDENT FOLEY: SENATOR STINNER, WOULD YOU YIELD? [LB241]

SENATOR STINNER: OKAY. [LB241]

SENATOR BLOOMFIELD: ...AND SEE IF WE CAN FIGURE OUT AN AMENDMENT THAT WOULD WORK. THANK YOU. [LB241]

PRESIDENT FOLEY: THANK YOU, SENATOR BLOOMFIELD AND STINNER. SENATOR KRIST, YOU'RE RECOGNIZED. [LB241]

SENATOR KRIST: THANK YOU, MR. PRESIDENT. GOOD MORNING,

COLLEAGUES, AND GOOD MORNING, NEBRASKA. I'M GOING TO STAND AND ADMIT I WAS ONE OF THOSE NO VOTES. PRESIDENT, MEMBERS OF THE LEGISLATURE, EVERY TIME A CEMETERY BILL COMES UP, I HAVE A COMPOSITION TITLED "MORTICIAN'S NATIONAL ANTHEM": I WAS GIVEN A COMMISSION BY A MORTICIAN TO WRITE A NATIONAL ANTHEM FOR THOSE WHO DO PLANT THEM. BUT WE DON'T HAVE ENOUGH TIME FOR ME TO DO IT RIGHT NOW SO I WON'T GIVE IT. BUT IF ON SELECT SENATOR BLOOMFIELD AND SENATOR STINNER DECIDE THAT THEY MIGHT CAN AGREE ON SOMETHING TO PUT INTO THE BILL. THERE MIGHT BE MORE TIME AND IT WILL BE A MORE SUITABLE OCCASION FOR ME TO GIVE YOU SOMETHING. BUT I THINK I SHOULD GIVE YOU A HINT. THE BILL WAS READ FOR THE FIRST TIME ON JANUARY 14, REFERRED TO THE GOVERNMENT, MILITARY AND VETERANS AFFAIRS COMMITTEE. THAT COMMITTEE PLACED THE BILL ON GENERAL FILE WITH NO COMMITTEE AMENDMENTS. [LB272]

PRESIDENT FOLEY: THANK YOU, MR. CLERK. SENATOR CRAWFORD, YOU'RE WELCOME TO OPEN ON... [LB272]

SENATOR CRAWFORD: THANK YOU, MR. PRESIDENT. AND GOOD MORNING, COLLEAGUES. ACCORDING TO THE U.S. DEPARTMENT OF VETERANS AFFAIRS. THERE ARE OVER 146.000 VETERANS LIVING IN NEBRASKA TODAY. BETWEEN 2011 AND 2016 IT IS ESTIMATED THAT OVER 1 MILLION SERVICE MEMBERS WILL LEAVE THE ARMED FORCES. IT'S IMPORTANT THAT OUR POLICIES IN NEBRASKA SUPPORT THESE MEN AND WOMEN RETURNING FROM SERVICE AND ENCOURAGE MANY OF THEM TO COME TO NEBRASKA. MANY OF THESE RETURNING SOLDIERS ARE COMING HOME TO AN ECONOMY IN WHICH POST-9/11 VETERANS EXPERIENCE HIGHER RATES OF UNEMPLOYMENT THAN THEIR VETERAN AND NONVETERAN PEERS. IN THE HEARING, WE HEARD FROM TESTIFIERS AGAIN AND AGAIN THAT EMPLOYMENT IS A KEY ISSUE FACING VETERANS, PARTICULARLY RECENT VETERANS. THANKS TO THE WORK OF SENATOR WATERMEIER AND GOVERNMENT COMMITTEE. LB588 PROVIDES A VETERANS HIRING PREFERENCE FOR PUBLIC SECTOR EMPLOYMENT. LB272. THE BILL BEFORE US TODAY, COMPLEMENTS THE WORK OF THE LEGISLATURE LAST YEAR AND ALLOWS THE PRIVATE SECTOR EMPLOYEES TO RECRUIT VETERAN TALENT, LB272, THOUGH, IS A VOLUNTARY PREFERENCE OPTION, UNDER THE BILL, BUSINESSES CAN ELECT TO OFFER A HIRING PREFERENCE FOR VETERANS AND SPOUSES OF 100 PERCENT DISABLED VETERANS. THIS PREFERENCE POLICY MUST BE IN WRITING AND APPLIED UNIFORMLY TO DECISIONS REGARDING HIRING AND PROMOTION. A REGISTRY OF EMPLOYERS AND VOLUNTARY VETERANS PREFERENCE EMPLOYMENT POLICY. THE DEPARTMENT OF LABOR AND THE EQUAL OPPORTUNITY COMMISSION HAVE BOTH INDICATED THAT THEY CAN DO THIS WITHOUT AN ADDED FISCAL COST. IF ADOPTED, NEBRASKA WOULD JOIN AT LEAST 12 STATES, INCLUDING NEIGHBORING IOWA, WHO HAVE ESTABLISHED SIMILAR PROGRAMS. CURRENTLY, PRIVATE SECTOR EMPLOYEES WISHING TO ESTABLISH A VETERAN HIRING PREFERENCE MAY BE HESITANT TO DO SO OUT OF CONCERN ABOUT DISCRIMINATION UNDER TITLE VII OF THE FEDERAL CIVIL RIGHTS ACT. TITLE VII, SECTION 11 OF THE CIVIL RIGHTS ACT, THOUGH, CONTAINS A CARVE OUT THAT EXEMPTS VETERAN PREFERENCE POLICIES IF AUTHORIZED BY STATE STATUTE, WHICH IS WHY LB272 IS IMPORTANT FOR US TO PASS. SPECIFICALLY. SECTION 11 STATES NOTHING CONTAINED IN THE SUBCHAPTER SHALL BE CONSTRUED TO REPEAL OR MODIFY ANY FEDERAL. STATE, TERRITORIAL, OR LOCAL LAW CREATING SPECIAL RIGHTS OR PREFERENCE FOR VETERANS. WITH THE PASSAGE OF LB272, PRIVATE COMPANIES ACROSS NEBRASKA MAY ESTABLISH A HIRING PREFERENCE FOR VETERANS AND VETERANS' SPOUSES THAT CLEARLY COMPLIES WITH FEDERAL CIVIL RIGHTS LAWS. I RECENTLY SPOKE WITH KEVIN HILTON FROM THE NORTH CENTRAL STATES REGIONAL COUNCIL OF CARPENTERS. AND HE DESCRIBED FOR ME A PROGRAM THEY PARTICIPATE IN CALLED HELMETS TO HARD HATS. THESE PROGRAMS RECRUIT VETERANS TO APPRENTICE IN OUR STATE AND BECOME PART OF OUR SKILLED WORK FORCE. LB272 WOULD ALLOW AN ADDED INCENTIVE FOR VETERANS TO COME TO NEBRASKA TO APPRENTICE AND THEN JOIN OUR WORK FORCE. VETERANS' SKILLS, PARTICULARLY THEIR LEADERSHIP SKILLS, DON'T ALWAYS TRANSLATE WELL TO A CIVILIAN RESUME, AND THIS IS ESPECIALLY TRUE FOR EMPLOYMENT OPPORTUNITIES THAT MIGHT USE ALGORITHMS OR OTHER AUTOMATED PROCESSES TO SEARCH RESUMES. FOR EXAMPLE. MISSILE OPERATOR OR VEHICLE MAINTENANCE CONTROLLER MIGHT NOT GENERATE A HIT IN AN ALGORITHM THE WAY PROGRAM MANAGER MIGHT. EVEN THOUGH BOTH POSITIONS REQUIRE MANY OF THE SAME SKILLS. WHAT'S MORE, ONLY 1 OUT OF 600 CORPORATE HIRING MANAGERS COME FROM A MILITARY BACKGROUND. LB272 ALLOWS BUSINESSES TO GIVE THESE VETERANS' RESUMES A SECOND LOOK AND CONSIDER HIRING THEM IF THEY ARE EQUALLY QUALIFIED FOR THE POSITION. WE HAD NUMEROUS SUPPORTERS FROM VETERANS GROUPS, THE BUSINESS GROUPS, AND I ENCOURAGE YOUR GREEN VOTE ON LB272 TO ALLOW A VOLUNTARY HIRING PREFERENCE THAT COMPLIES WITH FEDERAL CIVIL RIGHTS LAW IN OUR STATE. THANK YOU. [LB272]
