MR. PRESIDENT, LB77 ON GENERAL FILE, A BILL ORIGINALLY INTRODUCED BY SENATOR NORDQUIST. (READ TITLE.) INTRODUCED ON JANUARY 8, REFERRED TO HEALTH AND HUMAN SERVICES COMMITTEE. THE BILL WAS ADVANCED TO GENERAL FILE. THERE ARE HEALTH COMMITTEE AMENDMENTS PENDING. (AM109 LEGISLATIVE JOURNAL PAGE 449.) [LB77]

SPEAKER HADLEY: SENATOR NORDQUIST, YOU ARE RECOGNIZED TO OPEN ON LB77. [LB77]

SENATOR NORDQUIST: THANK YOU, MR. SPEAKER AND COLLEAGUES, GOOD MORNING. LB77 IS A BILL DEDICATED TO PREVENTIVE HEALTH FOR NEBRASKA WOMEN. THERE ARE TWO COMPONENTS TO LB77. THE BILL REQUIRES OUR DEPARTMENT OF HEALTH AND HUMAN SERVICES TO APPLY FOR A STATE PLAN AMENDMENT FOR PURPOSES OF EXPANDING MEDICAID FAMILY PLANNING SERVICES FOR PERSONS WHOSE EARNED INCOME IS AT OR BELOW 185 PERCENT OF THE FEDERAL POVERTY LEVEL. SO FOR A FAMILY OF THREE, THAT WOULD BE \$36,000 A YEAR. SINCE THE 1990s, STATES AROUND THE COUNTRY HAVE BEEN EXPANDING ELIGIBILITY FOR FAMILY PLANNING SERVICES. THIS IS SOMETHING THAT HAS BEEN HAPPENING FOR DECADES. TWENTY-NINE STATES NOW OFFER THESE SERVICES. THE REIMBURSABLE 90 PERCENT BY THE FEDERAL GOVERNMENT AND THE STATE'S SHARE IS 10 PERCENT. AGAIN. THIS HAS BEEN HAPPENING SINCE THE 1990s. THE BILL ALSO...THE SECOND COMPONENT OF THE BILL, IT WOULD ALSO APPROPRIATE. \$1 MILLION OVER TWO YEARS TO THE EVERY WOMAN MATTERS PROGRAM WITHIN THE STATE DEPARTMENT OF HEALTH AND HUMAN SERVICES. THIS PROGRAM IS DEDICATED TOWARDS CANCER. SCREENINGS FOR LOW-INCOME WOMEN, FOR MAMMOGRAMS, BREAST EXAMS, PAP SMEARS, AND ASSOCIATED LABORATORY COSTS FOR WOMEN WHO DO NOT HAVE OTHER MEANS TO PAY. THESE SERVICES ARE PROVIDED FREE OR AT LOW COST TO WOMEN AT OR BELOW 100 PERCENT OF THE FEDERAL POVERTY LEVEL AND WITH A VERY SMALL DONATION REQUEST FOR THOSE ABOVE 100 PERCENT OF THE FEDERAL POVERTY LEVEL UP TO 225 PERCENT. ALTHOUGH WE STILL ARE NOT REACHING ALL OF THE WOMEN WHO NEED IT. ABOUT 778 CLINICS IN THE STATE, CLINICS, HOSPITALS, AND FACILITIES PERFORM SERVICES FOR THE EVERY WOMAN MATTERS

PROGRAM: AND TO DATE. ALMOST 1.500 WOMEN HAVE BEEN DIAGNOSED THROUGH THE PROGRAM AND HAVE RECEIVED SERVICES WITH THE MEDICAID WOMEN'S CANCER CONTROL PROGRAM FOR CANCER TREATMENT. OUR NEIGHBORING STATES GOING BACK TO THE FAMILY PLANNING WAIVER. NEIGHBORING STATES OF IOWA, MISSOURI, AND WYOMING ALL PROVIDE THESE SERVICES. I INTRODUCED THIS BILL BECAUSE IT'S THE RIGHT THING TO DO FOR NEBRASKA WOMEN AND NEBRASKA FAMILIES AND NEBRASKA BABIES, IT WILL SAVE THE STATE, AS EVIDENCED IN THE FISCAL NOTE AND BY THE DEPARTMENT OF HEALTH AND HUMAN SERVICES, MILLIONS OF DOLLARS A YEAR, AND MOST IMPORTANTLY, AS SOMEONE WHO IS PRO-LIFE, IT WILL HELP REDUCE THE NUMBER OF UNINTENDED PREGNANCIES AND REDUCE THE NUMBER OF ABORTIONS IN OUR STATE. A FOCUS ON PREVENTION AND WOMEN'S HEALTH WILL HELP CREATE HEALTHIER FAMILIES AND COMMUNITIES AND WILL REDUCE HEALTH COSTS, AS WELL AS SOCIAL AND ECONOMIC COSTS IN THE LONG RUN. HALF OF ALL PREGNANCIES IN THE UNITED STATES ARE UNINTENDED. THEY'RE HIGHLY CONCENTRATED AMONG LOW-INCOME WOMEN AND HAVE HIGH BURDENS ON TAXPAYERS. ONE STUDY BY THE BROOKINGS INSTITUTE ESTIMATES THAT TAXPAYER SPENDING ON MEDICAID SUBSIDIZED MEDICAL CARE RELATED TO UNINTENDED PREGNANCIES TOTALS \$12 BILLION ANNUALLY. THAT'S MORE MONEY THAN THE FEDERAL GOVERNMENT SPENDS ON HEAD START OR EARLY HEAD START PROGRAMS. AND MORE IMPORTANTLY, UNINTENDED PREGNANCIES ARE SIGNIFICANTLY MORE LIKELY THAN INTENDED PREGNANCIES TO BE TERMINATED, AND UNINTENDED PREGNANCIES DO ACCOUNT FOR 90 PERCENT OF ALL ABORTIONS. ACCORDING TO A STUDY IN MILBANK QUARTERLY WHICH LOOKED AT POPULATION HEALTH AND HEALTH POLICY, IN 2010 CARE PROVIDED TO PUBLICLY SUPPORTED FAMILY PLANNING SERVICES ACROSS THE COUNTRY IS PROVIDED TO ABOUT 9 MILLION POOR AND LOW-INCOME WOMEN TO HELP AVERT. AND THOSE INVESTMENTS HELPED AVERT 2.2 MILLION UNINTENDED PREGNANCIES OF WHICH IF THOSE PREGNANCIES HAD BEEN MOVED FORWARD, 1.1 MILLION WOULD HAVE RESULTED IN A BIRTH; 360,000 IN A MISCARRIAGE; AND 760,000 IN ABORTIONS. THE NET SAVINGS OF THOSE SERVICES WAS OVER \$10.5 BILLION TO THE PUBLIC TRUST FUNDS. AS I SAID. AS SOMEONE WHO IS PRO-LIFE. I VOTED FOR SPEAKER FLOOD'S 20-WEEK BILL. I WAS A COSPONSOR OF SENATOR FULTON'S ULTRASOUND BILL BACK IN 2009 THAT PASSED THIS LEGISLATURE. BUT THIS BILL UNDOUBTEDLY WILL PREVENT MORE UNINTENDED PREGNANCIES AND PREVENT MORE ABORTIONS THAN ANYTHING THIS LEGISLATURE HAS DONE IN RECENT YEARS. THIS BILL CARRIES STRONG SUPPORT FROM MEDICAL ESTABLISHMENTS, ORGANIZATIONS IN OUR STATE BECAUSE THEY KNOW THAT INVESTING IN PREVENTION IS THE RIGHT THING TO DO. CONSERVATIVE STATES AROUND THE COUNTRY HAVE TAKEN UP THIS OPTION. AS I SAID, OUR NEIGHBORING STATE OF WYOMING; GOVERNOR RICK

PERRY IN TEXAS ESTABLISHED A PROGRAM LIKE THIS: GOVERNOR NIKKI HALEY IN SOUTH CAROLINA JUST THIS YEAR EXPANDED THEIR PROGRAM. AND ESSENTIALLY WHAT THE FEDS TELL US WITH THE FAMILY PLANNING STATE PLAN AMENDMENT IS THAT WE COVER PREGNANT WOMEN RIGHT NOW TO 185 PERCENT OF THE FEDERAL POVERTY LEVEL. IF A WOMAN GETS PREGNANT AND THEY'RE BELOW 185 PERCENT OF THE FEDERAL POVERTY LEVEL, WE COVER THEIR PREGNANCY-RELATED SERVICES. THE FEDS, THROUGH THIS PROGRAM. FOR DECADES NOW HAVE SAID. LOOK. WE WILL PAY TO HELP YOU PREVENT THOSE PREGNANCIES IF THE WOMEN DON'T WANT TO GET PREGNANT. UP TO THAT SAME INCOME LEVEL. SO YOU HAVE A WOMAN WHO IS BELOW 185 PERCENT OF THE FEDERAL POVERTY LEVEL. SHE GETS PREGNANT. WE PAY FOR ALL THOSE COSTS. WE'RE SAYING JUST WITH THIS BILL, LOOK, WE'LL HELP HER PLAN HER PREGNANCY IF SHE CHOOSES. WE'LL HELP HER PROVIDE CONTRACEPTION. IF SHE'S HAD A BIRTH RECENTLY, WE'LL HELP HER UNDERSTAND THE NEED TO SPACE PREGNANCIES APPROPRIATELY, AND THAT'S WHY GROUPS LIKE THE MARCH OF DIMES ARE SUPPORTIVE OF THIS BECAUSE THEY KNOW IT PROVIDES THE INFORMATION NEEDED FOR WOMEN TO HAVE HEALTHY BABIES. AND AGAIN, WHEN THAT WOMAN GETS PREGNANT. WE PAY FOR IT IN MEDICAID. THAT'S WHY IF YOU LOOK AT THE FISCAL NOTE AND I'VE BEEN ONE WHO'S BROUGHT A LOT OF BILLS TO THE HEALTH COMMITTEE AND OFTEN ARGUE. SAY. IF WE INVEST A DOLLAR HERE, WE'RE GOING TO SAVE, THERE IS RESEARCH THAT SHOWS WE'LL SAVE THIS MUCH ON THE BACK END. BUT NEVER HAVE I BROUGHT A BILL AND HAD THE DEPARTMENT OF HEALTH AND HUMAN SERVICES SAY WHAT I SAID. USUALLY THEY SAY NO, SENATOR NORDQUIST. THIS IS GOING TO COST US \$10 MILLION OR \$20 MILLION. BUT THIS TIME THE PROOF IS ON THE FISCAL NOTE. THIS BILL IN THIS BIENNIUM WILL SAVE THE STATE GENERAL FUND \$10 MILLION. THERE HAS BEEN SO MUCH EVIDENCE PUT FORWARD AND RESEARCH DONE ON THIS THAT THE COST SAVINGS ARE SO REAL THAT WE CAN REDUCE OUR MEDICAID BUDGET BY GOING FORWARD \$10 MILLION...IT'S ACTUALLY \$11.9 MILLION NEXT YEAR IN FISCAL YEAR '16-17. AND THIS PARTICULAR DOCUMENT THAT I SHARED WITH YOU AND I READ PARTS OF IT, IT SAYS: THE EVERY WOMAN MATTERS PROGRAM IS A FEDERALLY FUNDED PROGRAM THAT PAYS FOR THE OFFICE VISITS WITH ASSOCIATED PAP SMEARS, PELVIC EXAMS, CLINICAL BREAST EXAMS, AND LAB FEES. AGE APPROPRIATE MAMMOGRAPHIES IS ALSO COVERED AS WELL AS A LIMITED NUMBER OF DIAGNOSTIC TESTS. THE PROGRAM PROVIDES SCREENING SERVICES TO MEDICALLY UNDERSERVED WOMEN AGES 40 TO 74. FUNDING IS AWARDED BY THE CENTERS FOR DISEASE CONTROL AND PREVENTION. IT ALSO GOES ON TO SAY IN THE FOURTH BULLET POINT: NEBRASKA HAS COVERAGE ACROSS THE STATE FOR SERVICES. ABOUT 778 HEALTHCARE CLINICS/OFFICES, HOSPITALS, MAMMOGRAPHY FACILITIES/RADIOLOGY GROUPS. AND LABORATORIES PERFORM SERVICES FOR THE EWM PROGRAM. ALL COUNTIES IN NEBRASKA ARE SERVICED BY COMMUNITY PARTNERS WHO PROMOTE THE SCREENING PROGRAM, ENROLL ELIGIBLE CLIENTS, AND PROVIDE HEALTH EDUCATION ACTIVITIES IN THEIR LOCAL COMMUNITIES. PARTNERS ALSO DECREASE BARRIERS TO CLIENTS AND HELP CLIENTS ACCESS PREVENTIVE HEALTHCARE SERVICES. SENATOR KINTNER: THANK YOU, MR. PRESIDENT. YOU KNOW, WE FOUGHT BACK MEDICAID EXPANSION MY FIRST YEAR. WE BEAT IT AGAIN LAST YEAR. THIS YEAR LOOKS LIKE THEY'VE KIND OF BROKEN IT UP AND THEN WE'RE GOING TO SEE IT IN A COUPLE DIFFERENT BILLS. AND WE FIND OURSELVES, UNFORTUNATELY, I THINK EASILY PULLED OFF COURSE FROM WHAT SOME OF OUR PRIORITIES I THINK SHOULD BE AS LEGISLATORS. I UNDERSTAND PEOPLE WITH MORAL OBJECTIONS ABOUT A COMPONENT OF THIS, I RAN A CHURCH AFFILIATED INSTITUTION FOR YEARS AND YEARS WHOSE BELIEFS I DIDN'T NECESSARILY SHARE. BUT ON THE OTHER HAND WAS MORALLY CHARGED WITH FOLLOWING THROUGH WITH THOSE. SO, YOU KNOW, I'M TUNED INTO THAT AND UNDERSTAND. BEGINNING MANY YEARS AGO WHEN I STILL SERVED AS THE GOVERNOR'S DIRECTOR OF URBAN AFFAIRS WITHIN GOVERNOR JOHANNS' ADMINISTRATION. IS INVOLVED IN THE ISSUE OF EPIDEMIC, SOME SAY ENDEMIC, ISSUES AS THEY RELATE TO UNPLANNED PREGNANCY OR TEEN PREGNANCY WITHIN THE POOR COMMUNITIES WITHIN THE STATE OF NEBRASKA. AND I'M GOING TO SHARE WITH YOU, BECAUSE MOST OF YOU DO NOT SERVE ON THE HEALTH AND HUMAN SERVICES COMMITTEE, SOME INFORMATION THAT WAS SHARED WITH MEMBERS OF THE HEALTH AND HUMAN SERVICES COMMITTEE ABOUT HOW IMPORTANT IT IS AND HOW IT IS TO HAVE ACCESS TO CONTRACEPTION AND TO UNDERSTAND HOW AND WHEN TO USE IT AND HOW IMPORTANT IT IS TO USE CONTRACEPTION CONSISTENTLY. SENATOR COOK: ...TOP ISSUES...THANK YOU, MR. PRESIDENT. [LB77]

SPEAKER HADLEY: SENATOR KOLTERMAN, YOU'RE RECOGNIZED. [LB77]

SENATOR KOLTERMAN: THANK YOU. MR. PRESIDENT. SEVERAL THINGS I'D JUST LIKE TO COMMENT ON. I'M NEW AT THIS. I THINK EVERYBODY KNOWS THAT. I WOULD LIKE TO SAY THAT WE'VE SOME REALLY GOOD DISCUSSIONS IN HEALTH AND HUMAN SERVICES. THERE ARE A COUPLE OF ADVANTAGES OF GETTING OLD: ONE, YOU'RE STILL UPRIGHT; AND TWO, YOU HAVE A LITTLE MEMORY AND A LITTLE HISTORICAL CONTEXT. IN THE EARLY 1970s, I HAD THE UNIQUE PRIVILEGE OF BEING ABLE TO LISTEN TO SOME OF THE TOP PEOPLE IN OUR GOVERNMENT FRANKLY AND GENUINELY LAMENT OUR SITUATION. AND THERE WERE TWO TOPICS OF LAMENTING: ONE. WHAT WAS GOING TO HAPPEN IF WE DIDN'T BALANCE THE FEDERAL BUDGET AND WE CONTINUED TO HAVE BAD BALANCES OF TRADE: AND THE SECOND ONE WAS WHAT WAS GOING TO HAPPEN IF WE STARTED DOWN THE PATH OF WELFARE AND SOCIAL NETS. THERE WAS GREAT CONCERN, AND IT WASN'T THE KIND OF CONCERN THAT WE SEE NOW WITH PEOPLE FOLLOWING DOGMAS AND PRINCIPLES AND RULES AND BOOKS AND ALL THAT, BUT IT WAS GENUINE CIVIC CONCERN. AND THE CONCERN WAS. ONCE WE LIT UP THOSE CIGARS. IT WOULD BE IMPOSSIBLE TO GET THE SMOKE BACK IN THEM. WELL, WE DID LIGHT UP THOSE CIGARS. WE NO LONGER CAN REALISTICALLY TALK IN TERMS OF BALANCED FEDERAL BUDGETS OR BALANCES OF TRADE WITH OTHER COUNTRIES. WE RUN CONSTANT DEFICITS AND WE'RE IN A COMPLETELY DIFFERENT WORLD THAT WE WILL NEVER BE ABLE TO GET THE SMOKE BACK IN THE CIGAR ON. LIKEWISE WITH THE WORLD OF WELFARE. WE BEGAN AN EXTENSIVE WELFARE PROGRAM. AND OUR WELFARE PROGRAMS EXTENDED BENEFITS, NOT OF GREAT HUMANITARIAN DESIRES BUT BENEFITS TO OLD PEOPLE. WHICH WE SPEND MOST OF OUR MEDICAID DOLLARS ON IN THE STATE, AND ALSO TO YOUNG WOMEN AND TO CHILDREN WHOSE PARENTS COULD NOT AFFORD OR CARE TO SUPPORT THEM IN SOME CASES. AND WHEN WE DID THAT, WE TOOK ON TREMENDOUS EXPENSE AS A SOCIETY, TREMENDOUS SHIFT OF RESPONSIBILITY, SOME OF WHICH WE ARE NOT COMFORTABLE WITH TODAY. BUT NEVERTHELESS, THE SMOKE IS OUT OF THE CIGAR. PART OF THE WAY THAT WE HAVE TO RESPONSIBLY DEAL WITH

AND IN ORDER TO DO THAT, WE NEED THE PROPER TYPE OF EDUCATION AS TO FINANCES AND BIOLOGIES AND CONTRACEPTION. BECAUSE WHEN THOSE CHILDREN ARE BORN, LOTS OF THEM, LOTS OF THEM ARE ON OUR NICKEL. I DID THAT BECAUSE EVEN SANDRA DAY O'CONNOR, JUSTICE SANDRA DAY O'CONNOR, SAID THAT ABORTION IN GENERAL AND THE RULINGS THAT WERE MADE ON THE BENCH WAS AND IS ON A COLLISION COURSE WITH SCIENCE. BECAUSE WHEN WE CAN DEFINE CONCEPTION AS THE BEGINNING OF LIFE, WE THEN CAN DEFINE LIFE ITSELF. BUT I'M A LAWMAKER AND I HAVE TO STAND UP ON THIS FLOOR AND DEFEND WHAT I BELIEVE IN, WHAT MY CONSTITUENTS BELIEVE IN, WHAT MY CORE BELIEVES IN, AND WHAT IS GOOD FOR THE STATE. THE EVERY WOMAN MATTERS PROGRAM DOES NOT CURRENTLY PROVIDE FAMILY PLANNING SERVICES. AS IT IS GEARED TO OLDER WOMEN. AND IT IS MORE DIRECTED TO PREVENTIVE SCREENINGS FOR THINGS LIKE BREAST. COLON. AND CERVICAL CANCER. I UNDERSTAND FROM THE INTRODUCER THE INTENT OF THE BILL WAS NOT TO EXPAND THE SERVICES OFFERED BY EVERY WOMAN MATTERS IN THIS WAY. I THINK IT'S IMPORTANT. IT CUT IN HALF THE NUMBER OF WOMEN WHO DELIVERED WITHIN 18 MONTHS OF THEIR FIRST PREGNANCY. AND IT HELPED REDUCE INFANT MORTALITY AMONG MEDICAID INFANTS. THE FIRST THREE YEARS SAVED \$14.3 MILLION IN MEDICAID EXPENSES. AND THAT WAS IN 1993 DOLLARS. RIGHT NOW, NEBRASKA RANKS...RIGHT NOW, NEBRASKA HAS ABOUT 39 PERCENT OF UNINTENDED PREGNANCIES. AND WE RANKED FIFTY-FIRST IN FAMILY PLANNING AND FORTY-NINTH IN FUNDING ANY KIND OF PLANNING OR FAMILY SUPPORT...FAMILY PLANNING. THE MARCH OF DIMES TESTIFIED THAT PRECONCEPTION AND INTERCONCEPTION HEALTHCARE AND FAMILY PLANNING REDUCED THE RISKS OF BIRTH DEFECTS. OF LOW BIRTHWEIGHT, OF PREMATURITY, AND INFANT IMMORTALITY. THOSE SEEM LIKE WORTHY GOALS FOR OUR STATE. FOUR-HUNDRED PERCENT OF THE POVERTY LEVEL IN THE STATE OF NEBRASKA FOR A FAMILY OF FOUR IS ABOUT \$94,000. AND THEY GET SOME SUBSIDIES BUT VERY LITTLE SUBSIDIES. BUT I WANT PEOPLE TO KNOW ON THIS FLOOR THAT IT'S NOT JUST THE WORKING POOR THAT ARE BEING HURT BY THIS AFFORDABLE CARE ACT. I HAVE PEOPLE IN MY OFFICE DURING THOSE OPEN ENROLLMENTS. THEY'LL COME IN AND THEY'LL SAY, WELL, I'VE GOT FIVE KIDS AND WE MAKE \$95,000 to \$100,000 A YEAR, IS THERE ANY HELP FOR US? AND WE'LL HAVE TO TELL THEM. NO. IT ISN'T VERY OFTEN...WELL, I PROBABLY SHOULD NOT SAY NEVER, BUT IT'S HIGHLY UNLIKELY THAT I'M GOING TO OPEN A FISCAL NOTE AND SEE THAT THE DEPARTMENT SEES HOW MUCH SAVINGS WE'RE GOING HAVE IF WE PUT THIS PROGRAM INTO EFFECT. MOST OF THE TIME, WE'RE SEEING A HIGHER FISCAL NOTE. SO I HOPE THAT YOU'LL TAKE SOME TIME TO TAKE A LOOK AT WHAT THAT FISCAL NOTE SAYS. I ALSO WANT TO INDICATE TO YOU THAT IN THE TESTIMONY BEFORE THE COMMITTEE. WE LOOKED AT...APPLESEED BROUGHT FORTH SOME TESTIMONY THAT I THINK IS WORTHY OF LOOKING AT. THE SERVICES THEMSELVES. SPECIFICALLY WITH THEIR FOCUS ON WOMEN'S HEALTH, CAN RESULT IN LONG-TERM FINANCIAL SAVINGS. NATIONALLY, IN 2010, ROUGHLY \$7 WAS SAVED FOR EVERY PUBLIC DOLLAR SPENT ON FAMILY PLANNING SERVICES. THAT SAME YEAR, IN NEBRASKA, PUBLICLY FUNDED FAMILY PLANNING SERVICES SAVED THE STATE OVER \$49 MILLION IN COSTS, INCLUDING THOSE RELATED TO MATERNITY AND BIRTH, MISCARRIAGE, AND TESTING FOR SEXUALLY TRANSMITTED INFECTIONS. THESE SAVINGS REFLECT SERVICES PROVIDED TO PEOPLE TRADITIONALLY ELIGIBLE FOR MEDICAID AND NOT THE ADDITIONAL SAVINGS THAT WE COULD GET UNDER THIS BILL. WE ARE INVESTING IN PREVENTION AND MAKING SURE THAT THOSE WOMEN ARE ABLE TO TAKE THE STEPS THAT THEY NEED. I KNOW, AS I MENTIONED BEFORE, I KNOW THERE HAS BEEN DISCUSSIONS ABOUT A PARTICULAR PROVIDER. AND REST ASSURED, NOTHING...THERE'S NO COVERAGE AT ALL... [LB77]

AND THAT CHILD IN A LOW-INCOME FAMILY WILL LIKELY RECEIVE SUPPORT THROUGH THE CHILD CARE SUBSIDY PROGRAM, THROUGH THE FOOD STAMP PROGRAM, THROUGH A NUMBER OF OTHER SOCIAL WELFARE PROGRAMS, AT THE COST OF TAXPAYERS. AND WE CAN FIRST HELP PREVENT AND HELP MOTHERS HAVE PREGNANCIES WHEN THEY WANT TO AND MAKE SURE THAT THEY'RE HEALTHY WHEN THEY DO. BEFORE THEY COME INTO THE MEDICAID PROGRAM. BEFORE THEY GET PREGNANT. WE CAN MAKE SURE THAT THEY ARE HEALTHY, THAT THEY HAVE HAD CHECKUPS PRIOR TO GETTING PREGNANT. THAT'S WHAT THIS BILL DOES. AND STATES LIKE TEXAS AND SOUTH CAROLINA AND WYOMING AND OTHER CONSERVATIVE STATES HAVE SAID THIS IS THE CONSERVATIVE WAY TO DO THINGS, PREVENTING PREGNANCY. AND THE FISCAL NOTE SHOWS THAT TO THE TUNE OF \$10 MILLION THIS BIENNIUM THAT WE CAN TAKE FROM THE MEDICAID PROGRAM AND INVEST IN OTHER AREAS--EDUCATION, TAX RELIEF, INFRASTRUCTURE--AND, GOING FORWARD, \$13 MILLION A YEAR OF SAVINGS TO THE STATE GOVERNMENT AND \$14 MILLION A YEAR OF SAVINGS TO THE FEDERAL GOVERNMENT, WHO DESPERATELY NEEDS THE SAVINGS. I WOULD APPRECIATE YOUR SUPPORT OF LB77. THANK YOU. [LB77]
