SPEAKER HADLEY: THE CUPCAKES ARE IN CELEBRATION OF SENATOR BOLZ'S BIRTHDAY. THANKS, SENATOR BOLZ. (VISITORS INTRODUCED.) MR. CLERK, WE WILL MOVE TO FINAL READING. MEMBERS SHOULD RETURN TO THEIR SEATS IN PREPARATION FOR FINAL READING. MR. CLERK, THE FIRST BILL IS LB52. [LB52]

CLERK: MR. PRESIDENT, I HAVE A MOTION. SENATOR CRAWFORD WOULD MOVE TO RETURN THE BILL FOR SPECIFIC AMENDMENT. (FA17, LEGISLATIVE JOURNAL PAGE 655.) [LB52]

SPEAKER HADLEY: SENATOR CRAWFORD, YOU'RE RECOGNIZED TO OPEN ON YOUR MOTION. [LB52]

SENATOR CRAWFORD: THANK YOU, MR. SPEAKER. AND I HAVE NO PROBLEM WITH LB52 AND HAVE TOLD SCHEER THAT I WOULD PUT A MOTION ON THE BILL JUST TO HAVE A CHANCE TO RESPOND TO THE GOVERNOR'S MESSAGE ON LB109. COLLEAGUES, IN FRONT OF YOU IS THE CORRESPONDENCE FROM GOVERNOR RICKETTS REGARDING HIS CONCERNS WITH LB109, AND THEY WERE READ IN EARLIER IN OUR RECORD. AS YOU RECALL, WE PASSED LB109 ON A 49 TO 0 VOTE LAST FRIDAY. AT THE BILL'S HEARING, THE UNIVERSITY OF NEBRASKA, NEBRASKA STATE COLLEGES. AND NEBRASKA COMMUNITY COLLEGES ALL TESTIFIED IN SUPPORT OF THE BILL, AND NO ONE TESTIFIED IN OPPOSITION TO THE LEGISLATION. LB109 WAS CAREFULLY CRAFTED TO REFER SPECIFICALLY TO ELIGIBLE INDIVIDUALS IN THE NEBRASKA LANGUAGE. THE BILL STATES THAT INDIVIDUALS RECOGNIZED AS ELIGIBLE BY THE FEDERAL GOVERNMENT FOR G.I. BILL BENEFITS ARE ELIGIBLE FOR IN-STATE TUITION IN NEBRASKA. SO NEBRASKA IS RECOGNIZING THESE INDIVIDUALS FOR THIS BENEFIT BECAUSE THEY ARE ELIGIBLE FOR FEDERAL BENEFITS, NOT BECAUSE OF THEIR MARITAL STATUS. SO I RESPECTFULLY DISAGREE WITH THE GOVERNOR THAT LB109 POSES A POTENTIALLY UNCONSTITUTIONAL VIOLATION. HOWEVER, I ASSURED THE GOVERNOR THAT IF HE SIGNED THE BILL INTO LAW THAT I WOULD WORK WITH HIM TO TRY TO ALLEVIATE HIS CONCERNS, SO LONG AS THE REMEDY STILL PROVIDES TUITION BENEFITS TO ALL WHO ARE COVERED BY LB109 AND LB740

THAT WE PASSED LAST YEAR. AS A REMINDER, IN JUNE CONGRESS PASSED H.R. 3230. ALL FIVE MEMBERS OF NEBRASKA'S DELEGATION SUPPORTED H.R. 3230. THE BILL WHICH PRESIDENT OBAMA SIGNED INTO LAW AUGUST 7, 2014. REQUIRES, AMONG OTHER THINGS, THAT STATES EXTEND IN-STATE TUITION BENEFITS TO VETERANS WHO HAVE LEFT ACTIVE DUTY SERVICE WITHIN THE PAST THREE YEARS, AS WELL AS THEIR DEPENDENTS. STATES WHO FAIL TO COMPLY WILL HAVE ALL COURSES FOR ALL MONTGOMERY G.I. AND POST-9/11 G.I. BENEFITS DISAPPROVED AT THE STATE'S PUBLIC COLLEGES AND UNIVERSITIES. IN OTHER WORDS, ALL VETERANS WHO ARE RECEIVING MONTGOMERY G.I. OR POST-9/11 G.I. BENEFITS ARE IN JEOPARDY OF LOSING THEIR EDUCATIONAL BENEFITS IF OUR STATE DOES NOT COMPLY. AS PASSED, LB109 BRINGS US INTO COMPLIANCE WITH FEDERAL LAW AND ENSURES OUR STATE VETERAN STUDENTS HAVE ACCESS TO THEIR HARD-EARNED EDUCATIONAL BENEFITS, WHILE STILL RESPECTING THE NEBRASKA CONSTITUTION. YESTERDAY AFTERNOON GOVERNOR RICKETTS REQUESTED A MEETING WITH ME TO DISCUSS LB109. THE CONCERNS HE RAISED WERE LARGELY AROUND THE DEPARTMENT OF DEFENSE'S DECISION TO RECOGNIZE SAME-SEX SPOUSES AS DEPENDENTS FOR THE PURPOSES OF VETERANS' BENEFITS, INCLUDING EDUCATIONAL BENEFITS. THE VETERANS BENEFITS ADMINISTRATION CLEARLY EXPLAINED TO OUR OFFICE, AS WELL AS THE PRO STAFF, THAT FAILURE TO EXTEND EDUCATIONAL BENEFITS TO ELIGIBLE SAME-SEX SPOUSES WILL RESULT IN A LOSS OF EDUCATIONAL BENEFITS FOR ALL OUR STUDENT VETERANS CURRENTLY ENROLLED IN ONE OF OUR STATE COLLEGES OR UNIVERSITIES, WHICH IS OVER 1,500 STUDENTS AT UNL AND UNO ALONE. ALL 50 STATES MUST NOW GRANT IN-STATE TUITION TO RECENTLY SEPARATED VETERANS WHO QUALIFY FOR FEDERAL EDUCATIONAL BENEFITS. THIS INCLUDES SEVERAL STATES WITH SIMILAR CONSTITUTIONAL AMENDMENTS AND CASES. TEXAS, WHICH PASSED ITS SAME-SEX MARRIAGE BAN IN 2005, WAS THE FIRST OF THE STATES TO FULLY COMPLY WITH THE FEDERAL REQUIREMENTS FOR IN-STATE TUITION, INCLUDING SAME-SEX SPOUSES. I APPRECIATE GOVERNOR RICKETTS SIGNING LB109 AND I WILL HONOR THE COMMITMENT I MADE TO THE GOVERNOR YESTERDAY TO WORK WITH HIM TO ENSURE WE COMPLY WITH FEDERAL LAW AND, IF POSSIBLE, ADDRESS HIS CONCERNS WITH LB109, WHILE STILL MAKING SURE THAT ALL OUR RECENTLY SEPARATED VETERANS AND SPOUSES RECEIVE IN-STATE TUITION. THANK YOU FOR YOUR SUPPORT OF LB109. PLEASE FEEL FREE TO COME SEE ME WITH ANY QUESTIONS. AND I WOULD LIKE TO WITHDRAW MY MOTION, PLEASE. [LB52 LB1091

SPEAKER HADLEY: THE MOTION IS WITHDRAWN. WE WILL RETURN TO LB52. MR. CLERK. [LB52]

CLERK: MR. PRESIDENT, SENATOR CHAMBERS WOULD MOVE TO RETURN THE BILL. (FA18, LEGISLATIVE JOURNAL PAGE 655.) [LB52]

SPEAKER HADLEY: SENATOR CHAMBERS, YOU ARE RECOGNIZED ON YOUR MOTION. [LB52]

SENATOR CHAMBERS: MR. PRESIDENT, MEMBERS OF THE LEGISLATURE, I'M PUTTING A MOTION ON EVERY BILL ON FINAL READING, NOT NECESSARILY THAT I HAVE ANY PROBLEM WITH ANY ONE OF THE BILLS. BUT I HAVE A PROBLEM WITH THE WAY SOME THINGS ARE BEING DONE AROUND HERE, AND I KNOW THAT I'M GOING TO BE ON THE SHORT END OF THE STICK. BUT I'M GOING TO FOLLOW THE ADVICE OF JOSEPH KENNEDY, THE FATHER OF THE KENNEDY BROTHERS: DON'T GET MAD, GET EVEN. JUST BECAUSE I'M TREMENDOUSLY OUTNUMBERED DOESN'T MEAN I'M GOING TO BECOME A SHRINKING VIOLET. DRY UP, AND BLOW AWAY IN THE FIRST BREEZE THAT COMES. WE PROBABLY ARE ONE-THIRD, A LITTLE BIT MORE THAN ONE-THIRD OF THE WAY THROUGH THIS SESSION. YOU HAVE NOT TALKED ABOUT TAXES. YOU HAVE NOT TALKED ABOUT THE BUDGET. AND THE BUDGET IS THE ONLY THING WE REALLY HAVE TO DO AND THAT CAN BE DONE IN A SPECIAL SESSION IF NECESSARY, I DON'T KNOW--I'M GENUINELY TELLING YOU MY STATE OF MIND AT THIS POINT--I DON'T KNOW HOW LONG I WILL TALK ON ANY ONE OF THESE MOTIONS OR IF I WILL TALK ON ALL OF THEM. BUT THE BOY SCOUT MOTTO IS "BE PREPARED," AND THE WAY FOR ME TO FUNCTION AROUND HERE IS TO BE PREPARED TO DO WHATEVER IT IS I THINK OUGHT TO BE DONE ON MY OWN. I WILL NOT COUNT ON ANYBODY TO DO ANYTHING. I WILL NOT ASK ANYBODY TO DO ANYTHING. IF YOUR CONSCIENCE OR WHATEVER LEADS YOU TO ACT PRODS YOU TO ACT IN A CERTAIN WAY, THAT'S THE WAY IT WILL BE. ANY PROPOSITION I OFFER, ANY BILL THAT I INTRODUCE I'M WILLING TO DISCUSS WITH ANYBODY WHO WANTS TO TALK TO ME. BUT WHEN CERTAIN REPRESENTATIONS ARE MADE ABOUT MY LEGISLATION BEFORE WE EVEN COME INTO SESSION, THAT IS THE ATTITUDE I'M GOING TO DEEM TO BE THE ONE PREVAILING IN THIS BODY. AND I'M GOING TO RESPOND ACCORDINGLY. I WAS AT A HEARING YESTERDAY ON MY MOUNTAIN LION BILL, AND SO CERTAIN IS THE OTHER SIDE THAT THE COMMITTEE IS NOT GOING TO ADVANCE MY BILL, THEY WERE PATHETIC IN THEIR OPPOSITION. THE DIRECTOR OF GAME AND PARKS CAME THERE LIKE A WHIPPED PUPPY DOG, TAIL DRAGGING, DIDN'T HAVE ANSWERS TO VARIOUS QUESTIONS, AND SAID, WELL, THERE'S SOMEBODY HERE WHO IS A BIOLOGIST WHO CAN PROBABLY ANSWER

THE QUESTIONS. THEY KNOW IT'S A FOREGONE CONCLUSION. BUT I WANT MY COLLEAGUES TO KNOW THIS, AND I'M GOING TO SHOW AN EXAMPLE OF IT THIS MORNING. I CAN CONTROL THIS SESSION AT ANY POINT THAT I CHOOSE TO DO SO. ALTHOUGH IT MAY NOT SEEM TO SOME OF YOU, I HAVE TRIED TO BE COLLEGIAL THIS SESSION. SOME OF YOU KNOW THAT I'VE TALKED TO YOU ON YOUR BILLS, WORKED WITH YOU TO TRY TO DO SOMETHING TO IMPROVE IT, AND THAT'S WHAT I WILL CONTINUE TO DO. BUT BY THE SAME TOKEN, I'M GOING TO LOOK OUT FOR THE INTERESTS THAT I HAVE. WHAT HAS HAPPENED WITH ME ON THESE MOUNTAIN LIONS IS THE CREATION OF A CRUSADE. I NEED TO PROTECT THOSE ANIMALS FROM ERADICATION IN THIS STATE, AND I'M GOING TO DO EVERYTHING THAT I CAN. AND IF IT MEANS SACRIFICING THE SESSION, SO WHAT? I WANT TO KEEP NATURE'S CHILDREN ALIVE IN THIS STATE. I DON'T CARE ABOUT GAME AND PARKS, AND I CERTAINLY DON'T CARE ABOUT CABELA'S. THEY SENT SOME FELLOW HERE, AND SOMEBODY WHO IS INTERESTED IN WHAT THEY CALL BIG GAME HUNTING, TO SAY THAT IT'S NOT FOR POLITICIANS TO MANAGE THESE ANIMALS IN THIS STATE. I POINTED OUT TO THE COMMITTEE THAT THOSE ANIMALS ARE A NATURAL RESOURCE, AND I POINTED OUT THAT EVERY PERSON ON THAT COMMITTEE IS A POLITICIAN. FOR THEM TO MAKE THAT STATEMENT SHOWED A TOTAL DISREGARD FOR THE COMMITTEE, A DISRESPECT FOR THEIR INTELLIGENCE, AND IGNORING WHAT THE NAME OF THAT COMMITTEE IS: NATURAL RESOURCES. AND I ASKED RHETORICALLY TO THE COMMITTEE, IF YOU ARE GOING TO SAY THAT THESE HUNTERS WHO RUN GAME AND PARKS SHOULD BE ALLOWED TO MANAGE THESE ANIMALS, WHY DON'T YOU STOP BRINGING BILLS ON WATER TO THIS LEGISLATURE AND LET THE IRRIGATORS AND OTHERS WHO MAKE USE OF WATER MANAGE THE WATER? WHY DON'T YOU DO THAT? YOU'RE NOT GOING TO DO IT. AND YOU THINK NOBODY CARES ABOUT THESE ANIMALS, BUT I DO. MR. DOUGLAS HAD THE NERVE TO SAY NO FORM OF GAME MANAGED BY GAME AND PARKS HAS EVER BECOME ENDANGERED. NO FORM OF GAME THAT THEY MANAGE HAS EVER BEEN COMPLETELY ERADICATED FROM THIS STATE. AND THERE IS SOMETHING ELSE THAT NEEDS TO BE CONSIDERED. HOW IS GAME AND PARKS GOING TO MANAGE THESE ANIMALS THROUGH HUNTING, WHEN MOST OF THE LAND IS PRIVATELY OWNED WHERE THESE ANIMALS ARE AND YOU CANNOT HUNT ON LAND UNLESS THE LANDOWNER SAYS YOU CAN? SO FOR GAME AND PARKS TO GIVE THE IMPRESSION THAT THEY IMPERIALLY CAN MANAGE WHAT HAPPENS ON PRIVATE PROPERTY, THEY ARE MISTAKEN. THERE ARE SOME PEOPLE WHO REMEMBER WHEN DEER FELL UNDER A BAD DISEASE. AND THERE WAS A DROUGHT AT THE SAME TIME. SO YOU KNOW WHAT DEER WOULD DO? LIKE YOU PREDATORS WOULD DO. HUMAN BEINGS ARE PREDATORS. ANYTHING WHICH IS THIRSTY WILL GO WHERE THE WATER IS. SO THEY CLUSTERED

AROUND PONDS AND WHEREVER THEY COULD FIND WATER, AND THEY TRANSMITTED THE DISEASE TO EACH OTHER. HAD NOT THE STATE'S DOMINANT PREDATOR NOT BEEN DECIMATED, THOSE DEER WOULD HAVE BEEN PUT TO FLIGHT AND SCATTERED BY THE MERE PRESENCE OF MOUNTAIN LIONS. THEY DON'T CONTROL HERBIVORES BY KILLING THEM BUT BY FRIGHTENING THEM. AND IT CAUSES THEM TO STAY IN THE OPEN SO THEY CAN SEE THE PREDATOR WHICH STALKS ITS PREY AND STRIKES FROM AMBUSH. BUT WITHOUT A PREDATOR, THEY CAN CLUSTER TOGETHER AND NOT JUST DESTROY VEGETATION, BUT THEY CAN SPREAD DISEASES THAT WILL DESTROY THEM. NATURE HAS A BETTER UNDERSTANDING OF HOW TO DEAL WITH THE ECOLOGY THAN THESE PEOPLE WITH GAME AND PARKS. GAME AND PARKS COMMISSIONERS KNOW NOTHING ABOUT MANAGING THE ECOLOGY OR THESE ANIMALS. THAT'S NOT WHAT THEY'RE APPOINTED FOR. IT'S A GOOD OLD BOYS CLUB. THEY ARE ACCOUNTABLE TO NOBODY. AND I'M THE ONE WHO GETS LETTERS FROM PEOPLE AROUND THIS STATE SAYING THAT THEY WRITE TO THE COMMISSIONERS AND DON'T EVEN GET AN ACKNOWLEDGMENT OR A RESPONSE. AND WHEN I ASK, WHY DO YOU WRITE TO ME, WHY DON'T YOU WRITE TO THE SENATOR WHO REPRESENTS YOU: BECAUSE THEY DON'T BELIEVE THOSE SENATORS WILL DO ANYTHING. BUT I'M GOING TO DO SOMETHING. AND IT MIGHT TAKE ME THE SIX YEARS THAT I MAY HAVE LEFT TO BE IN THIS LEGISLATURE BEFORE BEING TERM LIMITED OUT AGAIN. AND HE'S GOT TO CHOOSE WHICH DIRECTION HE'S GOING TO FALL. BUT THEY'RE THE ONES WHO DETERMINE WHETHER OR NOT HE KEEPS HIS JOB. SO I HAVE MANY THINGS THAT I INTEND TO TALK ABOUT, MANY ISSUES I INTEND TO RAISE, BUT THEY WILL NOT ALL BE RAISED ON SENATOR SCHEER'S BILL, BECAUSE I THINK THE LAST TIME I SAID SOMETHING ON HIS BILL, I ASSURED HIM THAT HIS BILL WOULD PASS. SO, MR. PRESIDENT, I'M WITHDRAWING THAT PENDING MOTION ON LB52, WHICH IS SENATOR SCHEER (SHAKING IN HIS BOOTS), INTRODUCER OF THE BILL. THANK YOU, MR. PRESIDENT. [LB52]

SPEAKER HADLEY: ALL PROVISIONS OF LAW RELATIVE TO PROCEDURE HAVING BEEN COMPLIED WITH, THE QUESTION IS, SHALL LB52 PASS? ALL THOSE IN FAVOR VOTE AYE; ALL THOSE OPPOSED VOTE NAY. RECORD, MR. CLERK. [LB52]

ASSISTANT CLERK: (RECORD VOTE READ, LEGISLATIVE JOURNAL PAGE 656.) VOTE IS 46 AYES, 0 NAYS, 3 EXCUSED AND NOT VOTING, MR. PRESIDENT. [LB52]

SPEAKER HADLEY: LB52 PASSES. (VISITORS INTRODUCED.) MR. CLERK, WE WILL PROCEED TO LB87. [LB52 LB87]

ASSISTANT CLERK: MR. PRESIDENT, SENATOR CHAMBERS WOULD MOVE TO RETURN LB87 TO SELECT FILE FOR SPECIFIC AMENDMENT, THAT BEING STRIKE THE ENACTING CLAUSE. (FA19, LEGISLATIVE JOURNAL PAGE 656.) [LB87]

SPEAKER HADLEY: SENATOR CHAMBERS, YOU ARE RECOGNIZED. [LB87]

SENATOR CHAMBERS: THANK YOU. MR. PRESIDENT, MEMBERS OF THE LEGISLATURE, I OBVIOUSLY HAVE NOTHING AGAINST THIS BILL, BUT I'M GOING TO HAVE A FEW THINGS TO SAY. THE MEMBERS OF THIS BODY DO NOT ATTEND COMMITTEE HEARINGS BECAUSE THE MEMBERS ARE TIED UP IN THEIR OWN COMMITTEES. WELL, SOMETHING WAS PRINTED IN ONE OF THE PAPERS ABOUT...I DON'T...IT MIGHT HAVE BEEN THE LINCOLN JOURNAL STAR OR THE WORLD-HERALD, THOSE ARE THE TWO THAT I READ, IN ONE OR THE OTHER, THAT IF THERE'S NO HUNTING ALLOWED OF THIS TINY POPULATION OF MOUNTAIN LIONS IN NEBRASKA, THEY WILL...THE MOUNTAIN LIONS IN OTHER STATES WHERE THERE'S HUNTING WILL REALIZE THAT THERE'S NO HUNTING IN NEBRASKA, AND THEY'LL COME HERE BECAUSE IT'S A REFUGE. NOW, DO YOU BELIEVE THAT? THAT'S THE KIND OF PREPOSTEROUS POPPYCOCK THAT THEY TOLD TO THAT COMMITTEE, FEELING THAT THEY'VE GOT AN EAR ON ONE SIDE OF THEIR HEAD AND A CORRESPONDING EAR ON THE OTHER SIDE OF

MISSING IN AMERICA PROJECT IS A NATIONAL VETERANS SERVICE ORGANIZATION RUN SOLELY ON

TO ACHIEVE THIS MISSION, MISSING IN AMERICA PROJECT WORKS WITH FUNERAL DIRECTORS, THE STATE AND FEDERAL VETERANS ADMINISTRATION, AND FAMILIES, FAMILIES ARE NEVER CHARGED FOR THESE SERVICES. SINCE 2013, THE NEBRASKA CHAPTER OF MISSING IN AMERICA PROJECT HAS ARRANGED FOR BURIAL WITH FULL MILITARY HONORS FOR 29 OF THESE VETERANS.
