SENATOR HOWARD: THANK YOU, SPEAKER HADLEY, GOOD MORNING, COLLEAGUES. TODAY, I'M HERE TO TALK TO YOU ABOUT LR418, A RESOLUTION THAT WOULD CREATE THE ACCESSNEBRASKA OVERSIGHT COMMITTEE. THE RESOLUTION WAS HEARD IN THE EXECUTIVE COMMITTEE ON FEBRUARY 8 AND IT WAS ADVANCED UNANIMOUSLY TO THE FULL LEGISLATURE FOR YOUR CONSIDERATION. LAST YEAR I WAS APPOINTED CHAIR OF THE LR33 ACCESSNEBRASKA SPECIAL INVESTIGATIVE COMMITTEE AND WAS PRECEDED IN THAT ROLE BY SENATOR ANNETTE DUBAS IN 2014 WITH THE LR400 COMMITTEE. THE OTHER MEMBERS OF MY COMMITTEE INCLUDED VICE CHAIR, SENATOR JOHN McCOLLISTER, SENATOR JONI CRAIGHEAD, SENATOR SUE CRAWFORD, SENATOR MATT HANSEN, SENATOR MERV RIEPE, AND SENATOR JOHN STINNER. ACCESSNEBRASKA, FOR THOSE OF YOU WHO ARE NOT FAMILIAR WITH IT, IS THE CALL CENTER SYSTEM THAT WE USE TO HELP ELIGIBLE APPLICANTS ENROLL IN OUR SOCIAL BENEFIT PROGRAMS. THOSE SOCIAL BENEFIT PROGRAMS RANGE FROM HEALTHCARE TO ENERGY ASSISTANCE TO FOOD STAMPS. THROUGH OUR WORK OVER THE INTERIM, WE TOURED EACH OF THE CUSTOMER SERVICE CALL CENTERS AND BOTH OF THE DOCUMENT IMAGING CENTERS KNOWN AS THE ANDI OFFICES. WE HELD A PUBLIC HEARING IN JULY AND MY STAFF ATTENDED REGULAR MEETINGS COMPRISED OF ACCESSNEBRASKA LEADERSHIP. THE OMBUDSMAN'S OFFICE WAS ALSO ...ALSO CONDUCTED A SURVEY OF EMPLOYEES. EACH OF THESE IS TOUCHED ON IN THE REPORT THAT WAS ISSUED IN JANUARY. WHAT WE FOUND IS THAT WHILE ACCESSNEBRASKA HAS FACED SIGNIFICANT CHALLENGES IN OPERATIONS OVER THE RECENT YEARS--AND FOR THOSE OF YOU WHO DON'T REMEMBER, WE WERE LOOKING AT OVER 40-MINUTE-LONG CALL WAIT TIMES TWO YEARS AGO, AND TODAY WE'RE HAPPILY DOWN TO AROUND 5 MINUTES--NOTABLE GAINS HAVE BEEN ACHIEVED OVER THE PAST FEW YEARS. IMPROVING FUNCTIONALITY OF THE PROGRAM HAS BEEN A PRIORITY FOR THE DEPARTMENT OF HEALTH AND HUMAN SERVICES AND CREDIT IS GIVEN ESPECIALLY TO THE NEW ADMINISTRATION. RECOGNITION IS

ALSO GIVEN TO THE LONG-TERM EMPLOYEES WHO HAVE CONTINUED TO ADVOCATE FOR A PROGRAM THAT THEY BELIEVE CAN HAVE A POSITIVE IMPACT ON THOSE NEEDING BENEFITS IN OUR STATE. THE LR33 COMMITTEE RELEASED THEIR FULL REPORT TO THE LEGISLATURE ON JANUARY 5, 2016. IN THIS REPORT, THE COMMITTEE MADE A NUMBER OF RECOMMENDATIONS FOR THE CONTINUED IMPROVEMENT OF FUNCTIONALITY, CUSTOMER SERVICE, AND DELIVERY OF BENEFITS BY ACCESSNEBRASKA. I WOULD ALSO LIKE TO JUST GIVE A SPECIAL SHOUT-OUT TO SENATOR JOHN McCOLLISTER AND SENATOR JOHN STINNER. THEY REALLY LOOKED AT OUR ACCESSNEBRASKA CHALLENGES FROM A BUSINESS PERSPECTIVE AND SO A LOT OF THESE RECOMMENDATIONS REALLY DO COME FROM THAT POINT OF VIEW. SOME OF YOU MAY NOT KNOW THIS, BUT THERE WAS A LAWSUIT FILED BECAUSE IT WAS TAKING TOO LONG FOR US TO PROCESS FOOD STAMP BENEFITS. AND WHEN YOU...WHEN IT TAKES TOO LONG TO PROCESS FOOD STAMP BENEFITS, PEOPLE GO WITHOUT FOOD. AND SO THAT WAS WHY THE LAWSUIT WAS FILED. WE ALSO ASK THAT THEY CAN CREATE CONTINGENCY PLANS FOR COMPUTER AND CALLING SYSTEM MALFUNCTIONS. WE WANTED THEM TO DEVELOP SUCCESSION PLANS, WHICH IS ALSO A BUSINESS IMPROVEMENT PLAN. WE WANTED THEM TO CONTINUE TO ADDRESS THE BACKLOG OF FRAUD COMPLAINTS AND DEVELOP BETTER MONITORING SYSTEMS. WHAT WE DISCOVERED IN OUR INVESTIGATION WAS THAT THERE A FRAUD E-MAIL INBOX WHERE IF AN ACCESSNEBRASKA EMPLOYEE SUSPECTED FRAUD, THEY WOULD SEND AN E-MAIL TO THIS INBOX, BUT NO ONE HAD CHECKED IT FOR MONTHS AND THERE WERE THOUSANDS OF E-MAILS IN THAT INBOX. ALONG WITH THE CONTINUED SURVEY OF ACCESSNEBRASKA EMPLOYEES, WE WANTED THEM TO DEVELOP A CUSTOMER SURVEY AND STAKEHOLDER INPUT PROCESS, AND WE WANTED TO MAINTAIN ONE MORE YEAR OF LEGISLATIVE OVERSIGHT FOR ACCESSNEBRASKA BECAUSE WHILE THERE HAVE BEEN SIGNIFICANT IMPROVEMENTS, WE WANT TO MAKE

SURE THAT THEY KNOW THAT WE'RE STILL WATCHING AND WE STILL WANT THOSE CALL WAIT TIMES TO GO DOWN AND THE PROCESSING OF APPLICATIONS TO SPEED UP. AS A MEMBER OF THE SPECIAL INVESTIGATION COMMITTEE AND A MEMBER OF THE HEALTH AND HUMAN SERVICES COMMITTEE, I BELIEVE WE HAVE TO ACKNOWLEDGE WHERE WE ARE TODAY AND NOT WALLOW IN PAST FAILURES. THE DEPARTMENT OF HEALTH AND HUMAN SERVICES HAS DONE A COMMENDABLE JOB AT MEETING OR EXCEEDING MOST OF THE FEDERAL REQUIREMENTS. I DO NOT FEEL THE RECOMMENDATIONS SET OUT IN THE REPORT TRULY RECOGNIZE THE IMPROVEMENTS MADE BY THE DEPARTMENT. IN FACT, A HANDOUT HAS OR WILL BE PROVIDED TO YOU WITH THE METRICS FROM JANUARY 2016. SO YOU MAY SEE HOW THE DEPARTMENT HAS GREATLY IMPROVED. I FEEL OVERSIGHT OF ACCESSNEBRASKA IS IMPORTANT, BUT NOT AT THE CRISIS INVESTIGATIVE LEVEL REQUIRED BY A SPECIAL INVESTIGATIVE COMMITTEE. OVERSIGHT MAY BE ACCOMPLISHED THROUGH THE HEALTH AND HUMAN SERVICES COMMITTEE, ITS FUNDAMENTAL ROLE. SENATOR COOK: THANK YOU, MR. PRESIDENT, AND GOOD MORNING, COLLEAGUES. I RISE IN STRONG SUPPORT OF SENATOR HOWARD'S LR418, AND WOULD LIKE TO COMMEND HER AND OTHER MEMBERS OF THE COMMITTEE FOR THEIR COMMITMENT OF TIME AND RESEARCH INTO THIS ONGOING ISSUE. EARLIER IN MY CAREER HERE IN THE LEGISLATURE, I INTRODUCED LEGISLATION RELATED TO ACCESSNEBRASKA. THIS WAS BACK IN THE DAYS WHEN WE HAD 45-MINUTE WAIT TIMES, PEOPLE'S PHONES RUNNING OUT OF MINUTES, MULTIPLE INQUIRIES, CONSTITUENT INQUIRIES INTO MY OFFICE EVERY WEEK ASKING FOR HELP WITH NAVIGATING THE SYSTEM. MANY OF YOU WERE NOT AROUND WHEN THE DECISION WAS MADE TO SWITCH TO ... THIS WAS A HARDSHIP. I STILL RECEIVE ROUTINE INQUIRIES FROM CONSTITUENTS ABOUT WHETHER OR NOT THEY'RE ABLE TO GET THEIR BENEFITS. THESE ARE BUSY, WORKING PEOPLE IN MANY CASES. THE REPORT IDENTIFIED SEVERAL LIKELY GAPS IN SERVICES ACROSS THE STATE AND THE MAIN RECOMMENDATION OF THE AUDIT WAS THAT A LEGISLATIVE OVERSIGHT COMMITTEE BE ESTABLISHED TO MONITOR THE PROGRESS OF THE DEPARTMENT OF HEALTH AND HUMAN SERVICES, THE DIVISION OF BEHAVIORAL HEALTH IN CONDUCTING A STATEWIDE NEEDS ASSESSMENT, AND IN DEVELOPING A STRATEGIC PLAN. TO THAT END, LR413 ESTABLISHES THE TASK FORCE ON BEHAVIORAL AND MENTAL HEALTH. IN ADDITION TO MONITORING THE DEPARTMENT'S PROGRESS IN CONDUCTING THE NEEDS AND ASSESSMENT IN DEVELOPING A STRATEGIC PLAN, THE TASK FORCE IS RESPONSIBLE FOR STUDYING THE FOLLOWING ISSUES: ONE, THE ADEQUACY AND NEEDS OF BEHAVIORAL HEALTH SYSTEMS AND SERVICES PROVIDED BY THE REGIONS; TWO, THE ADEQUACY AND NEEDS OF THE LINCOLN REGIONAL CENTER TO PROVIDE SERVICES TO INDIVIDUALS UNDER A MENTAL HEALTH COMMITMENT: AND, THIRDLY, THE ADEOUACY AND NEEDS OF JAILS, YOUTH REHABILITATION AND TREATMENT CENTERS, AND THE DEPARTMENT OF CORRECTIONAL SERVICES IN PROVIDING BEHAVIORAL HEALTH

SERVICES FOR THE INDIVIDUALS EXITING THE JUDICIAL SYSTEM. THANK YOU FOR YOUR TIME AND I'D BE GLAD TO ANSWER ANY QUESTIONS. I BROUGHT THIS ON BEHALF OF THE PERFORMANCE AUDIT AND OBVIOUSLY SENATOR BOLZ AND I HAD HAD SEVERAL CONVERSATIONS ABOUT THIS, BUT I WOULD BE GLAD TO ANSWER ANY QUESTIONS IF YOU NEED. THANK YOU, MR. SPEAKER HADLEY: SENATOR BOLZ, YOU'RE RECOGNIZED. [LR413]

I JUST RISE IN SUPPORT OF THIS RESOLUTION AND APPLAUD THE PERFORMANCE AUDIT STAFF AND THE PERFORMANCE AUDIT COMMITTEE ON THEIR GOOD WORK WITH A VERY COMPLEX ISSUE. JUST A OUICK BIT OF HISTORY HERE, LB1083 CHANGED BEHAVIORAL HEALTH SERVICES IN NEBRASKA DRAMATICALLY IN 2004. IT MOVED US FROM INSTITUTIONAL CARE TO COMMUNITY-BASED CARE. AND THAT VISION IS A REALLY GOOD VISION. IT REPRESENTS THE BEST OF GOVERNMENT VALUES, INCLUDING THE LOWEST LEVEL OF TREATMENT AND COST EFFICIENCY. BUT WE STILL HAVE SOME WORK TO DO IN IMPLEMENTING THE TRUE VISION ESTABLISHED BY THAT PIECE OF LEGISLATION MORE THAN 12 YEARS AGO. AND SENATOR WATERMEIER IS RIGHT. THERE ARE STILL SIGNIFICANT GAPS IN OUR BEHAVIORAL HEALTH SYSTEMS AND SERVICES. CLERK: MR. PRESIDENT, LR403 WAS A RESOLUTION INTRODUCED BY SENATOR HANSEN. IT CALLS ON THE EXECUTIVE BOARD TO APPOINT AN ELECTION TECHNOLOGY COMMITTEE AS A SPECIAL COMMITTEE OF THE LEGISLATURE. RESOLUTION WAS INTRODUCED ON JANUARY 12, AT THAT TIME REFERRED TO THE EXECUTIVE BOARD WHO HAS REPORTED THE RESOLUTION BACK TO THE FLOOR. THERE ARE EXECUTIVE BOARD COMMITTEE AMENDMENTS, MR. PRESIDENT. (AM2162, LEGISLATIVE JOURNAL PAGE 638.) [LR403]

SPEAKER HADLEY: THANK YOU, MR. CLERK. SENATOR HANSEN, YOU'RE RECOGNIZED TO OPEN ON LR403. [LR403]

SENATOR HANSEN: THANK YOU, MR. PRESIDENT, AND GOOD MORNING, COLLEAGUES. I RISE TODAY TO INTRODUCE LR403 WHICH SEEKS TO CREATE A SPECIAL COMMITTEE, THE ELECTION TECHNOLOGY COMMITTEE, WITHIN THE LEGISLATURE TO ADDRESS NEBRASKA'S AGING ELECTION EQUIPMENT AND TECHNOLOGY. TO GIVE A BRIEF HISTORY OF NEBRASKA'S ELECTION TECHNOLOGY, IN 2002 CONGRESS PASSED THE HELP AMERICA VOTE ACT, COMMONLY REFERRED TO AS HAVA, TO REFORM THE NATION'S VOTING PROCESS, SPECIFICALLY AIMED AT MAKING IMPROVEMENTS TO VOTER SYSTEMS AND VOTER ACCESS. MANY OF THE ELECTION PROCEDURES WE HAVE TODAY, INCLUDING PROVISIONAL VOTING AND STATEWIDE VOTER REGISTRATION DATABASES, WERE IMPLEMENTED VIA THE HAVA PROCESS. PERHAPS THE BEST KNOWN PART OF HAVA WAS THE FEDERAL FUNDS USED BY STATES TO UPDATE AND UPGRADE VOTING EQUIPMENT. AT THAT TIME, NEBRASKA RECEIVED SOMEWHERE IN THE \$14 MILLION TO \$16 MILLION RANGE, A FEDERAL

ALLOCATION, A LARGE PORTION OF WHICH WAS USED BY THE SECRETARY OF STATE TO PURCHASE OPTICAL SCAN VOTE TABULATORS AND AUTOMARK MACHINES. THE AUTOMARK MACHINES FULFILLS A HAVA REQUIREMENT THAT A VOTER BE ABLE TO CAST A BALLOT PRIVATELY AND INDEPENDENTLY AND A TOUCH SCREEN AUDIO AND BRAILLE ARE USED BY THOSE WITH A PHYSICAL DISABILITY, VISUAL OR HEARING IMPAIRMENT. NEBRASKA STATE STATUTE REQUIRES AT LEAST ONE AUTOMARK MACHINE AVAILABLE AND OPERATIONAL AT EVERY POLLING SITE. THE HAVA FUNDS WERE USED TO PURCHASE THESE MACHINES AND WENT THROUGH THE SECRETARY OF STATE'S OFFICE. AND CURRENTLY, THE SECRETARY OF STATE'S OFFICE OWNS THE MACHINES AND REIMBURSES COUNTIES FOR EXPENSES PAID AND FOR MAINTENANCE. PRIOR TO HAVA, THESE MACHINES WERE NOT REQUIRED, BUT NOW THAT THEY ARE, AND WE'RE COMING TO THE UNDERSTANDING THAT THEY MAY NEED TO BE REPLACED SOON, THE QUESTION THE LEGISLATURE NEEDS TO ANSWER IS, WHO BUYS THE REPLACEMENTS, THE STATE OR THE COUNTIES? CURRENTLY, COUNTIES BEAR THE COST OF RUNNING ELECTIONS. BALLOT PRINTING. POLLING PLACE RENTAL FEES, AND POLL WORKER PAY ARE ALL FUNDED BY THE COUNTIES. ADDING THE PURCHASE OF ELECTION MACHINES COULD DOUBLE OR TRIPLE SOME COUNTY BUDGETS. FOR INSTANCE, HALL COUNTY JUST PURCHASED A NEW VOTE TABULATOR FOR \$100,000. A REPLACEMENT AUTOMARK MACHINE IS ESTIMATED TO BE AROUND THE \$500,000...SORRY, \$5,000 RANGE. AND LANCASTER COUNTY, FOR INSTANCE, HAS 175, WHICH WOULD COST SOMETHING APPROACHING \$900,000 TO REPLACE THEM ALL. SMALLER COUNTIES, WHILE HAVING SIGNIFICANTLY LESS MACHINES, WOULD ALSO SEE A DISPROPORTIONATELY LARGE INCREASE IN THEIR BUDGET. THERE ARE MANY PATHS WE COULD TAKE REGARDING THIS ISSUE. DOES THE STATE PAY? DO THE COUNTIES PAY? DO THEY SPLIT THE COST? ALL OF THESE QUESTIONS NEED TO BE ANSWERED AT SOME POINT AND LR403 CREATES THE MECHANISM TO DO SO. THESE ARE POLICY DECISIONS THAT NEED TO BE MADE BY US AS THE POLICYMAKERS AND THAT IS WHY THIS LR IS PROPOSING CREATION OF A SELECT COMMITTEE OF SEVEN STATE SENATORS TO BE APPOINTED BY THE EXECUTIVE BOARD. TWO OF THE MEMBERS WOULD REPRESENT THE CHAIR OF GOVERNMENT, MILITARY AND VETERAN AFFAIRS AND APPROPRIATIONS COMMITTEES. BOTH OF THESE INDIVIDUALS, OR THEIR DESIGNEE, ARE NECESSARY TO ENSURE BOTH MONETARY AND POLICY CONSIDERATIONS ARE EXPLORED, DISCUSSED, AND EVALUATED. ANY PROPOSAL FROM THE SPECIAL COMMITTEE THAT RECOMMENDS STATE CONTROL OR PURCHASING WOULD, FOR EXAMPLE, NEED A LARGE APPROPRIATIONS BILL. FURTHER, THE APPROPRIATIONS CHAIR IS UNIQUELY SUITED TO PROVIDE INSIGHT ON WHERE STATE FUNDS, IF ANY, COULD COME FROM, WHILE THE GOVERNMENT

COMMITTEE COULD PROVIDE INSIGHT TO THE CURRENT ELECTION PROCEDURES AND POLICIES. I FEEL THE SPECIAL AND SENSITIVE NATURE OF ELECTION LAW AND ELECTION TECHNOLOGY, AS WELL AS THE SCOPE OF THE POTENTIAL RECOMMENDATIONS, SUPPORT A SPECIAL COMMITTEE RATHER THAN AN INTERIM STUDY OR OTHER AD HOC PLANNING. THIS WOULD ALLOW US TO CREATE A BROAD RANGE OF INTERESTED SENATORS TO JOIN IN AND SHARE THEIR EXPERTISE WHILE ALSO HIGHLIGHTING THESE ISSUES TO THE PUBLIC. WHAT WE'VE SEEN IN A TERM-LIMITED LEGISLATURE IS THAT WE NEED MORE ATTENTION TO HAVING LONG-RANGE PLANNING AND LONG-RANGE POLICYMAKING, ESPECIALLY ON THESE TWO AREAS, EDUCATION

AND HEALTHCARE, THAT ARE SUCH A CENTRAL RESPONSIBILITY OF US IN THE STATE OF NEBRASKA. AND THE REALITY IS NEITHER ONE OF THOSE ENTITIES, THE GOVERNOR OR THE UNIVERSITY OF NEBRASKA, CAN CREATE PUBLIC POLICY THROUGH THE LEGISLATURE, THAT THEY DO NOT GET TO MAKE AN APPROPRIATION, THEY DO NOT GET TO MAKE A LAW CHANGE. AND THROUGH OUR WORK WITH SENATOR SULLIVAN OVER THE INTERIM OF 2014 IN THE BEGINNING OF LAST YEAR, IT WAS KIND OF A JOINT DECISION THAT WE DIDN'T NEED TO HAVE TWO SEPARATE CONCEPTS BEING FLOATED OUT THERE TO TAKE WHAT ESSENTIALLY IS THE LEGISLATURE'S ROLE OF CREATING LONG-TERM PLANNING AND LONG-TERM POLICY AND PUTTING IT INTO STATE STATUTE. AND I THINK TO SOME EXTENT WITH MY GOOD FRIEND, SENATOR BLOOMFIELD AND SENATOR HUGHES, RAISING CONCERNS ABOUT THIS BILL, THE REALITY IS, WHATEVER THE GOVERNOR, NO MATTER WHO THE GOVERNOR IS, THEY CAN CHOOSE TO DO WHATEVER IT IS THEY WANT TO DO WHEN IT COMES TO WORK FORCE

DEVELOPMENT, EDUCATION PLANNING. AND THE REALITY IS, THE LEGISLATURE MAY OR MAY NOT AGREE WITH THAT PERSON. I RECEIVED AN E-MAIL JUST LATELY FROM OUR COMMUNITY IN OUR DISTRICT SAYING THAT NO ONE IS RUNNING FOR SCHOOL BOARD OTHER THAN INCUMBENTS. IT'S HARD TO FIND SOMEONE ON A LOCAL LEVEL.
