SPEAKER HADLEY: THANK YOU, MR. CLERK. WE WILL NOW PROCEED TO THE FIRST ITEM ON THE AGENDA.

CLERK: MR. PRESIDENT, SENATOR KRIST WOULD MOVE TO WITHDRAW LB917. [LB917]

SPEAKER HADLEY: SENATOR KRIST, YOU'RE RECOGNIZED TO OPEN ON YOUR WITHDRAWAL MOTION. [LB917]

SENATOR KRIST: THANK YOU, MR. PRESIDENT. GOOD MORNING, COLLEAGUES, AND GOOD MORNING, NEBRASKA. MY EFFORT HERE TODAY IS TO ASK FOR A GREEN VOTE TO WITHDRAW LB917 AND IN A WAY OF EXPLANATION IS VERY SIMPLE. LB917 WAS SUPPOSED TO HAVE BEEN THE BILL THAT REPRESENTED THE COMPROMISE BETWEEN THE CHIEF JUSTICE AND THE LEGISLATURE IN TERMS OF HOW TO GO FORWARD REGARDING OUR OVERSIGHT AND THE OFFICE OF INSPECTOR GENERAL. IN FACT, WE FOUND A COUPLE OF ERRORS THAT NEEDED TO BE CORRECTED, AND THEY HAVE BEEN. LB954 WILL TAKE ITS PLACE. SO I WOULD ASK YOU, PLEASE, FOR A GREEN VOTE AND WITHDRAW LB917. THANK YOU, MR. SPEAKER HADLEY: SEEING NO ONE ELSE IN THE QUEUE, SENATOR KRIST, YOU'RE RECOGNIZED TO CLOSE. SENATOR KRIST WAIVES CLOSING. THE QUESTION FOR THE BODY IS THE WITHDRAWAL OF LB917. ALL IN FAVOR SIGNIFY BY VOTING AYE; OPPOSED VOTE NAY. HAVE ALL VOTED THAT WISH? RECORD, MR. CLERK. [LB917]

CLERK: 32 AYES, 0 NAYS, MR. PRESIDENT, ON THE WITHDRAWAL OF LB917. [LB917]

SPEAKER HADLEY: LB917 IS WITHDRAWN. MR. CLERK. [LB917]

CLERK: MR. PRESIDENT, THE FIRST BILL ON GENERAL FILE THIS MORNING IS SENATOR LARSON'S LB113. (READ TITLE.) SENATOR LARSON PRESENTED HIS BILL YESTERDAY. COMMITTEE AMENDMENTS WERE PRESENTED BY THE JUDICIARY COMMITTEE. MR. PRESIDENT, THERE WAS AN AMENDMENT TO THE COMMITTEE AMENDMENTS OFFERED BY...I'M SORRY, SENATOR CHAMBERS HAD MOVED TO RECOMMIT THE BILL TO COMMITTEE. I HAVE A MOTION TO RECONSIDER THAT VOTE, MR. PRESIDENT. [LB113]

SPEAKER HADLEY: SENATOR LARSON, IF YOU WILL JUST TAKE A COUPLE OF MINUTES TO EXPLAIN YOUR LB113. [LB113]

SENATOR LARSON: THANK YOU, MR. PRESIDENT. LB113 WOULD GIVE THE STATE OF NEBRASKA OR COUNTIES WITHIN NEBRASKA THE OPTION--IT IS NOT MANDATORY--TO INSTITUTE A POLICY IN WHICH IT WOULD CHARGE ITS INMATES A COPAY UP TO \$10 ON NONEMERGENCY MEDICAL CARE THAT THERE ARE EXCEPTIONS THAT INCLUDE MENTAL HEALTH, PREEXISTING CONDITIONS, CHRONIC ILLNESSES, EMERGENCY MEDICAL CARE. ALL THESE THINGS WOULD NOT BE OR WOULD NOT REQUIRE A COPAY. THIS BILL WAS BROUGHT TO ME BY A SHERIFF. AND THE COUNTIES SUPPORT IT ON THE CONCEPT THAT THEY UNDERSTAND, THOUGH IT MAY NOT BE A LARGE REVENUE GAINER IN THE SENSE OF THE COPAY WILL BE VERY SMALL, IT WILL CUT AND CURB COSTS BECAUSE IT WILL STOP WHAT THEY CONSIDER -- MANY CONSIDER -- AND HAVE SEEN IN THE COUNTY JAILS FRIVOLOUS VISITS TO THE DOCTOR'S OFFICES OR DENTIST OFFICES JUST TO GET OUT OF JAIL FOR A LITTLE WHILE, IN WHICH THAT TAKES DEPUTIES OFF THE ROAD, COUNTY TAX DOLLARS GOING TO THOSE ... YOU KNOW, THAT TIME, AND THEN THOSE TAX DOLLARS PAYING FOR THESE VISITS THAT SOMETHING MIGHT NECESSARILY NOT BE WRONG. IT WOULD BE UP TO THE MEDICAL PROFESSIONAL TO DETERMINE IF IT WAS EMERGENCY OR NONEMERGENCY OR MENTAL HEALTH RELATED OR WHATNOT BECAUSE NONE OF THOSE DO...CAN HAVE A COPAY. IF A PRISONER CANNOT PAY FOR THE MEDICAL SERVICES THEY STILL GET TO GO TO THE DOCTOR, BUT HALF OF WHAT THEY WOULD RECEIVE INTO THEIR COMMISSARY ACCOUNT IN THE FUTURE WOULD GO TO HAVING TO PAY THE COPAY UNTIL THE COPAY WAS MET. I APPRECIATE THE STRONG SUPPORT THAT I'VE HAD AND WILL CONTINUE TO BE HAPPY TO ANSWER QUESTIONS AND WORK THROUGH LB113. THANK YOU, MR. PRESIDENT. [LB113]

SPEAKER HADLEY: THANK YOU, SENATOR LARSON. SENATOR CHAMBERS, YOU'RE RECOGNIZED TO OPEN ON YOUR RECONSIDER MOTION. [LB113]

SENATOR CHAMBERS: THANK YOU. MR. PRESIDENT, MEMBERS OF THE LEGISLATURE, THIS IS A MOTION TO RECOMMIT THIS BILL TO A COMMITTEE. THERE WAS A VOTE TAKEN ON THE ORIGINAL MOTION, AND THAT VOTE WENT AGAINST THE MOTION AT THAT POINT, SO THAT'S WHY I'M MOVING TO RECONSIDER. WHEN THE VOTE WAS TAKEN THERE WERE FAR MORE VOTES, IF YOU SPEAK COMPARATIVELY, AGAINST RECOMMITTING THAN RECOMMITTING, BUT WE WERE ONE VOTE SHY OF BEING SURE THAT WE CAN PREVENT A CLOTURE VOTE. THERE WERE 16 VOTES. AND OF THOSE WHO WERE NOT HERE, THERE ARE SOME WHO DON'T LIKE THIS BILL. SO NOW, RATHER THAN MY GOING THROUGH ALL OF THE THINGS THAT I DID YESTERDAY WHICH CREATED A RECORD, I BELIEVE, OF MY ATTITUDE TOWARD THIS BILL, I'M GOING TO SEE WHAT OTHERS MAY HAVE TO SAY. AND THE QUESTION NOW IS WHETHER YOU WANT TO CARRY IT TO CLOTURE KNOWING THERE ARE NOT ENOUGH VOTES TO GET IT OR IF YOU WANT TO BE PRACTICAL AND VOTE FOR THIS RECOMMIT MOTION. TWO MEMBERS OF THE JUDICIARY COMMITTEE WHO HAD VOTED TO SEND IT TO THE FLOOR VOTED TO RECOMMIT YESTERDAY. SO THIS BILL. CONTRARY TO WHAT SENATOR LARSON SAID, DOES NOT HAVE OVERWHELMING SUPPORT IF YOU WANT TO APPLY THAT TERM TO THE LIKELIHOOD OF MOVING THIS BILL FORWARD. IF YOU DECIDE THAT YOU WANT TO TAKE IT TO CLOTURE I WILL CONTINUE TO DEBATE THE BILL. I WILL CONTINUE TO OFFER AMENDMENTS. I WILL OFFER MOTIONS, AND THEN WHEN THAT AMOUNT OF TIME HAS ELAPSED AND SENATOR LARSON ATTEMPTS TO INVOKE CLOTURE AND HE FAILS, THEN YOU CAN LOOK BACK ON THIS SPECIFIC BILL. IT HAS THREE DIGITS IN ITS NUMBER: 1-1-3. KNOCK THAT FIRST ONE OFF AND YOU WIND UP WITH 13. NOW THERE'S SOMETHING CALLED TRISKAIDEKAPHOBIA, WHICH MEANS FEAR OF 13. THAT'S WHY 13 IS DEEMED TO BE AN UNLUCKY NUMBER. SOME HOTELS ON THEIR ELEVATOR WILL NOT LIST A 13th FLOOR EVEN WHEN THERE ARE MORE THAN 13 FLOORS IN THE HOTEL BECAUSE THEY KNOW THAT PEOPLE ARE VERY SUPERSTITIOUS. THERE ARE OTHER INSTANCES WHERE 13 WOULD BE A LOGICAL NUMBER TO ATTACH TO SOMETHING, BUT THAT NUMBER IS SKIPPED AND THE NUMBERING WOULD GO FROM 12 TO 14, 13 NOT MENTIONED. YOU'LL BE ABLE TO LOOK BACK ON THIS DAY OR THIS BILL, UNLUCKY 13, WHEN WE GET TO THE PART OF THE SESSION WHERE TIME TRULY IS OF THE ESSENCE BUT THERE IS MORE TO DO THAN THERE IS TIME TO DO IT. AND THE SCRAMBLING WILL OCCUR. THERE WILL BE ATTEMPTS TO WHAT IS CALLED CHRISTMAS TREEING: WHERE YOU PUT EVERY MANNER OF BILL INTO ONE BILL. THIS IS ONE OF THOSE THAT I FEEL VERY STRONGLY AGAINST. BUT BECAUSE OF CONVERSATIONS I'VE HAD WITH SOME OF THE SENATORS ABOUT THE NEGATIVE POSITION THAT THEY HAVE, I WILL JUST, IF I NEED TO GO ON AND ON AND ON, DO SO WITH THE ASSURANCE THAT ULTIMATELY THIS BILL IS

GOING TO FAIL. THERE WAS...THERE IS A CHRISTMAS SONG, AND YOU ALL ARE GOING TO GET TIRED OF ME REFERRING TO SONGS. SENATOR SCHNOOR: THANK YOU, MR. SPEAKER. YESTERDAY I STOOD UP AND TALKED ABOUT A CONVERSATION I HAD WITH MY SISTER WHO HAS WORKED IN A PRISON SYSTEM AS A REGISTERED NURSE. AND SHE TALKED ABOUT ALL THE THINGS THAT HAPPENED MEDICALLY. NOW IT WAS BROUGHT UP BY SENATOR CHAMBERS THAT NONE OF THAT IS IMPORTANT BECAUSE THAT HAPPENED IN CALIFORNIA. WELL, I RECEIVED A CALL IN MY OFFICE WHEN WE WERE DONE YESTERDAY FROM THE PIERCE COUNTY SHERIFF RICK EBERHARDT. AND HE VALIDATED ABSOLUTELY EVERYTHING THAT I SAID. SO THOSE THINGS DO HAPPEN HERE. YOU KNOW, PRISONERS WILL PLAN AND SCHEME AND DO ANYTHING THEY CAN TO I GUESS GET A LITTLE BIT OF FREEDOM. AND WHEN THAT HAPPENS THAT PUTS THOSE HEALTHCARE PROFESSIONALS IN JEOPARDY. AND ALSO, AS SENATOR LARSON SAID, IT NOW TAKES SHERIFFS' DEPUTIES AND LAW ENFORCEMENT OFFICIALS AWAY FROM THEIR DUTIES IN PROTECTING EVERYBODY TO ESCORT PRISONERS. AND SO WHEN WE ADJOURNED I WAS ABLE TO REACH TWO OF OUR THREE COUNTY SHERIFFS. I WANTED TO SPEAK WITH THEM FIRSTHAND AND FIND OUT WHAT THEIR THOUGHTS WERE, AND I LEARNED A LOT OF THINGS. I ENCOURAGE YOU TO REACH OUT TO YOUR SHERIFFS. FIRST OF ALL, THOSE THAT ARE INCARCERATED, MOST, THE MAJORITY, ARE INDIGENT. HOWEVER, THEY CAN SINGLE OUT A FEW CASES, NOT ALWAYS, NOT MANY, AND ONE OF THE THREE SAID THAT IF THEY LOOK OUT THE WINDOW THE PICKUP THEY'RE DRIVING IS BETTER THAN WHAT THE SHERIFF IS DRIVING BUT ON PAPER THEY ARE INDIGENT. I THINK WE NEED A BETTER WAY TO IDENTIFY THOSE WHO ARE INCARCERATED OF THEIR FINANCIAL MEANS. BUT, YES, MANY ARE TRULY INDIGENT AT THE TIME OF THEIR ARREST. MANY HAVE MEDICAL ADDICTION SITUATIONS THAT NEED TO BE ADDRESSED FOR THEM TO BE READY TO GO TO WORK, YOU KNOW, READY TO GO TO WORK. AND SOME ARE HABITUAL CRIMINALS THAT ARE CONSTANTLY INCARCERATED. THAT DOES OCCUR AS WELL. AND I WAS ALSO TOLD THAT IF YOU'RE A VETERAN AND YOU'RE ARRESTED, THAT THE VETERAN'S ADMINISTRATION DOES NOT COVER ANY MEDICAL COST FOR THOSE WHO ARE INCARCERATED, AND THEY ALSO BELIEVE THAT WAS TRUE FOR ANY OTHER GOVERNMENTAL INCARCERATED PERSON. THEY ALSO SAID THAT IF THEY'RE ABLE TO PAY THE \$10 FEE THEY DID NOT THINK THAT WAS GOING TO BE BURDENSOME IF IT WAS OPTIONAL AND THERE...AS THIS BILL DOES OUTLINE CERTAIN SITUATIONS WHERE IT DOES WORK. THERE WAS A CONCERN AND THE CONCERN I RAISED WITH SENATOR BLOOMFIELD. AND SENATOR SCHNOOR, HE MADE NOTE OF THIS ON THE FLOOR: WELL, THEY PAY FOR THEIR OWN PHONE CALLS. BUT, COLLEAGUES, THOSE PHONE CALLS THEY MAKE, THEY'RE NOT LIKE THE PHONE CALLS WE MAKE HERE. AND I BELIEVE SENATOR CHAMBERS BROUGHT IT TO THE TELECOMMUNICATIONS COMMITTEE AT ONE POINT. A FIVE-MINUTE CALL COULD RANGE \$20 OR MORE. A FAMILY'S PHONE BILL COULD BE \$100 OR MORE TRYING TO TALK TO THEIR INCARCERATED PERSON. SO ONE OF THE THREE SHERIFFS HAD MENTIONED THAT THE CANTEEN COSTS AND THE PHONE COSTS ARE NOT THE ACTUAL COST. THERE IS MONEY THAT GOES BACK TO THE JAIL AND PERHAPS WE DO NEED TO LOOK AT LEGISLATION SO WE ARE NOT CREATING A BURDEN ON A FAMILY WHO MAY HAVE A LOVED ONE THAT IS NO LONGER HELPING TO CONTRIBUTE TO THE INCOME AND ADDING ADDITIONAL BURDEN. BUT I BELIEVE THOSE ARE TWO DIFFERENT BILLS TO LOOK AT. IS IT RIGHT TO TRY TO SET UP A CANTEEN IN A JAIL WHERE THE PRISONER PAYS

THREE TIMES THE COST OF WHAT THE JAIL DOES? I MEAN, THAT IN MY VIEW NEEDS TO BE DEBATED HERE. AND I ALSO LEARNED THAT THE SYSTEM, THE NAME FOR THE SYSTEM IS CALLED, AND THIS IS WITH A "K," TO KITE. AND THAT'S WHERE THEY SEND... [LB113]

SENATOR SULLIVAN: ONE MINUTE. [LB113]

SENATOR BRASCH: ...A NOTE OUT THAT I NEED TO GO SEE HERE AND THERE. SOME ARE REAL SITUATIONS. BUT, YES, THERE ARE OTHERS THAT ARE NOT. SO THAT ALSO NEEDS TO BE EVALUATED AS IF IT IS A NONMEDICAL SITUATION. THANK YOU, MADAM PRESIDENT. SO AT THIS POINT--AND I'M READING THE BILL AGAIN--I MAY SUPPORT IT BECAUSE IT IS NOT MANDATORY, BECAUSE THERE ARE EXCEPTIONS, AND ALSO THE SHERIFF CAN GO TO A JUDGE AND GET A MEDICAL BOND WHERE THE COUNTY IS NOT BURDENED WITH THE COST OF A LARGE MEDICAL BILL, AND THAT MANY DO THAT. WE'VE HAD YESTERDAY AND TODAY, I'VE HEARD SEVERAL PEOPLE TALK ABOUT THE FACT THAT WE'RE JUST TALKING ABOUT A \$10 COPAY; AND, WOW, I WOULD LOVE TO HAVE A \$10 COPAY, IS WHAT SEVERAL MEMBERS HAVE SAID, THAT'S NOT UNREASONABLE, SO I WANT TO PUT THAT \$10 COPAY IN CONTEXT FOR YOU. WE LOOKED FOR INFORMATION ABOUT WHAT PRISONERS WHO HAVE THE PRIVILEGE TO WORK--AND SO THIS IS ONLY A SMALL NUMBER OF THE PRISONERS WHO ARE ABLE TO DO THIS -- OF THE PRISONERS IN THE STATE SYSTEM WHO HAVE THE PRIVILEGE TO WORK. AND WE LOOKED AT THE HIGHEST POSSIBLE WAGE FOR THOSE PRISONERS WHO HAVE THAT PRIVILEGE OF BEING ABLE TO WORK. AND THE HIGHEST POSSIBLE WEEKLY WAGE IS \$18.88 A WEEK. A \$10 COPAY FOR THESE PRISONERS THEN IS 52 PERCENT OF THEIR WEEKLY WAGE. THE HIGHEST-PAID JOB THAT WE COULD FIND THAT WAS AN HOURLY JOB YIELDED A PAY OF \$32.40 A WEEK. A \$10 COPAY WOULD BE 31 PERCENT OF THIS PRISONER'S WEEKLY WAGE. AND AS SENATOR BRASCH NOTED, MANY ARE INDIGENT, MANY DO NOT HAVE AN ABILITY TO GET THESE JOBS. AND AGAIN. THESE ARE THE HIGHEST-PAYING JOBS FOR THOSE FEW PRISONERS WHO HAVE THE ABILITY TO WORK. AND SO IT WOULD INSTEAD FALL ON FAMILY OR THERE JUST WOULD BE NO MONEY. SO NOW TO PUT THAT IN CONTEXT, IF YOU ARE HERE AND YOUR ONLY SOURCE OF INCOME IS YOUR LEGISLATIVE SALARY, THEN YOU MAKE \$230 A WEEK. AND IF YOU WERE TO HAVE A COPAY SIMILAR TO THE PRISONERS' COPAY OF \$10 A WEEK, THAT EQUIVALENT WOULD BE \$119.60 COPAY OR \$71.30 COPAY. SO WE'RE TALKING ABOUT A \$10 COPAY FOR A PRISONER. THAT IS PROPORTIONATELY SIMILAR TO A \$70 TO \$120 COPAY FOR SOMEONE WHO IS IN THIS BODY AND ONLY RECEIVES THEIR LEGISLATIVE SALARY. NOW SOME PEOPLE HAVE TALKED ABOUT A \$50 COPAY THAT THEY PAY AND AN EXPECTATION THAT THE AVERAGE TAXPAYER REGULARLY WOULD PAY A \$50 COPAY AND HOW THIS MAKES THE \$10 COPAY FOR THE PRISONERS REASONABLE. AND LET ME PUT THAT INTO CONTEXT. THE MEDIAN INCOME IN NEBRASKA IS \$51,672. A \$50 COPAY IS ONLY 5 PERCENT OF SOMEONE'S WEEKLY WAGE IF YOU MAKE THE MEDIAN SALARY. SO IF WE WANT TO TREAT PRISONERS SIMILAR TO OUR OTHER WORKERS IN THE STATE WHO HAVE COPAYS, THE 5 PERCENT OF WEEKLY WAGE COPAY WOULD BE 94 CENTS. [LB113]

SENATOR CRAWFORD: SO I PROVIDE THAT INFORMATION TO YOU AND I'M HAPPY TO SHARE IT WITH YOU. IF YOU CARE TO COME BY, I CAN SHOW YOU THOSE NUMBERS. BUT I WANT TO SHARE THAT CONTEXT WITH YOU SO YOU UNDERSTAND WHAT A \$10 COPAY MEANS TO A PRISONER. MOST HAVE NO JOBS. THOSE THAT HAVE THE BEST JOBS, A \$10 COPAY IS 52 PERCENT OF THEIR

WEEKLY WAGE OR 31 PERCENT OF THEIR WEEKLY WAGE. THANK YOU, MR. PRESIDENT. [LB113]

SPEAKER HADLEY: THANK YOU, SENATOR CRAWFORD. SENATOR BRASCH, YOU ARE RECOGNIZED. [LB113]

SENATOR BRASCH: THANK YOU, MR. PRESIDENT. I DIDN'T GET A CHANCE TO ALSO TELL OF WHAT ELSE I FOUND. I FOUND THAT THE JAILS, THE COUNTIES, UNLESS THEY HAVE 50 PRISONERS, INMATES, THEN THEY CANNOT HAVE COUNTY INSURANCE FOR THE JAILS, AND THAT'S PART OF THE PROBLEM. YOU KNOW, OUR JAILS IN MY DISTRICT DO NOT HAVE 50. SO WHEN...AND I BELIEVE THAT SENATOR CRAWFORD HAS PRESENTED SOME VERY GOOD FACTS. I WILL SPEAK WITH SENATOR LARSON THAT PERHAPS THAT COPAY SHOULD BE PROPORTIONATE; PERHAPS HABITUAL CRIMINALS, REALIZING THAT MAYBE THAT WOULD HELP ON RECIDIVISM THAT IF THIS IS YOUR FIRST TIME INCARCERATED, THAT IT'S THE MINIMUM. BUT IN SPEAKING WITH TWO OF OUR THREE COUNTIES, ONE OF THE COUNTIES SAID THAT, YOU KNOW, \$10 MAY, YOU KNOW, BE A FAIR SITUATION ONLY IF YOU CAN GET THE \$10. BUT SEVERAL INMATES, SOME, YOU KNOW, THEY ARE ... FIRST OF ALL, THEY GET A BILL. SOME HAVE INSURANCE. OTHERS GO TO THE JUDGE FOR A MEDICAL BOND. SO WHEN SENATOR LARSON WAS CALLING OUT THE SMALLER COUNTIES, YOU KNOW, OUR COUNTIES, YOU KNOW, HAVE DIFFERENT METHODS, AND IT IS PART OF WHAT THEY HAVE BUDGETED. BUT THEY WOULD SUPPORT A \$10 COPAY, YOU KNOW, AS THE LAW...AS IS SET UP. YOU KNOW, A REGULAR MEDICAL VISIT. AND I BELIEVE THE MEDICAL EMERGENCIES HAVE ALREADY BEEN COVERED UNDER THIS BILL. I JUST WANTED TO FINISH WITH THOSE LAST FEW PIECES OF INFORMATION THAT I WAS ABLE TO COLLECT IN A SHORT TIME, SO THANK YOU, COLLEAGUES. THANK YOU, MR. PRESIDENT. [LB113]

SPEAKER HADLEY: THANK YOU, SENATOR BRASCH. SENATOR HANSEN, YOU ARE RECOGNIZED. [LB113]

SO THE STATE OF ACCESS TO HEALTHCARE FOR SOME OF OUR CITIZENS IS SO DIRE OF A SITUATION THAT THEY WOULD RATHER BE HEALTHY IN JAIL THAN SICK IN OUTSIDE WALKING FREE. I JUST WANT EVERYBODY TO HAVE THAT IN MIND WHEN WE TALK ABOUT OTHER OPTIONS AND OTHER AVENUES IN OUR STATE LATER IN SESSION ON HOW WE ARE GOING TO ADDRESS ACCESS TO HEALTHCARE IN OUR STATE, HOW WE'RE GOING TO ADDRESS MANY OPTIONS OF KEEPING OUR CITIZENRY HEALTHY. I FIND MYSELF WONDERING IF WE HAVE ANY WAY TO CONTROL THAT SORT OF THING. MOST PHONE CALLS ANYMORE, WITH THE ADVENT OF OUR CELL PHONES, REALLY DON'T COST ANYTHING. AND IF THE COUNTY IS CHARGING A PREPOSTEROUS PRICE FOR THAT OR IF THEY'RE SELLING THEM A SNICKERS BAR FOR \$4, HOW DO WE CONTROL THAT TO MAKE SURE THE COUNTY IS NOT ABUSING THE SYSTEM AS WELL? I WISH YOU WOULD ANSWER THOSE, SENATOR LARSON. AND, MR. PRESIDENT, I'D LIKE TO YIELD THE REMAINDER OF MY TIME TO SENATOR LARSON. [LB113]

SPEAKER HADLEY: SENATOR LARSON, YOU'RE YIELDED 2:38. [LB113]

SENATOR LARSON: THANK YOU, MR. PRESIDENT. I SUPPOSE WE COULD INTRODUCE A BILL TO SAY THAT NO PRISON INMATE SHOULD BE CHARGED MORE THAN FAIR MARKET VALUE FOR CANDY BARS OR TELECOMMUNICATIONS OR WHATNOT. THAT'S NOT IN LB113. LB113 FOCUSES ON INMATE COPAY. WE SET ABSOLUTE LIMITS TO HOW MUCH THAT CAN BE CHARGED. I HEARD SENATOR CRAWFORD TALK ABOUT, YOU KNOW, POSSIBLY A SLIDING SCALE FOR HABITUAL OFFENDERS. WELL, THE CONCEPT IS, IS WE DO STILL HAVE TO STAY WITHIN THE LIMITS OF THE EIGHTH AND FOURTEENTH AMENDMENTS OF THE UNITED STATES CONSTITUTION IN TERMS OF IT CANNOT BE CHARGED AN EXORBITANT AMOUNT. NOW TEXAS CHARGES \$100 PER YEAR FOR ALL HEALTHCARE SERVICES FOR THEIR PRISONERS. THAT HAS BEEN DEEMED CONSTITUTIONAL. TO SAY THAT IF YOU'RE A HABITUAL OFFENDER YOU OWE MORE THAN THIS OFFENDER THAT ISN'T A HABITUAL OFFENDER I WOULD WORRY ABOUT CREATING DIFFERENT WHAT YOU WOULD ... ARE WE CREATING ... I GUESS YOU'RE NOT CREATING CLOSED CLASSES. BUT YOU WOULD BE TREATING THE SAME CLASS OF PEOPLE THAT ARE IN THE SAME CLASS DIFFERENTLY. WHICH I'M NOT SURE WOULD BE CONSTITUTIONAL. I DON'T KNOW IF THAT'S SENATOR CRAWFORD'S AIM AT THAT. BUT I WOULD SAY THAT THEY--ALL PRISONERS--WOULD BE IN THE SAME CLASS. AND WHEN I SAY CLASS, I MEAN CLASS OF PEOPLE AND YOU HAVE TO TREAT EVERYBODY IN THAT CLASS EQUALLY. [LB113]

SENATOR KRIST: ONE MINUTE. [LB113]

SENATOR LARSON: NOW SOMETHING THAT YOU COULD DO POSSIBLY IS SAY IF A COUNTY WISHES TO INSTITUTE A COPAY THE FIRST SELF-INITIATED VISIT CAN BE NO MORE THAN \$2 AND THE SECOND SELF-INITIATED VISIT CAN BE \$5 AND THE...YOU COULD CREATE THE SCALE THAT WAY, BUT EVERYBODY HAS TO BE THE SAME. YOU CAN'T CREATE WITHIN THAT CLASS BASED ON HOW MANY TIMES YOU'VE OFFENDED BECAUSE THEN YOU ARE TREATING THEM DIFFERENT. SO I APPRECIATE SENATOR CRAWFORD'S CONCERNS, BUT HER SOLUTION...AND SHE'S SHAKING HER HEAD. SHE MIGHT AGREE WITH ME THAT IT MIGHT...HER SOLUTION OR THAT CONCEPT WOULD BE UNCONSTITUTIONAL IN MY MIND. SO WE HAVE TO TREAT ALL PRISONERS THE SAME AND...BUT, SENATOR BLOOMFIELD, WE COULD PROBABLY WRITE A LAW SAYING THAT ALL OF THE THINGS AT THE COMMISSARY AND TELECOMMUNICATIONS HAVE TO BE FAIR MARKET VALUE. SO I THINK IF IT DISCOURAGES THAT AND IT'S DONE PART OF WHAT IT'S SUPPOSED TO DO, SO I SUPPORT THIS LEGISLATION. I THINK IT'S SOLID AND I THINK IT DOESN'T HURT ANYONE THAT LEGITIMATELY NEEDS MEDICAL ATTENTION. THANK YOU, MR. PRESIDENT. I'LL GIVE THE REMAINDER OF MY TIME TO SENATOR LARSON IF HE'D LIKE IT. [LB113]

SENATOR KRIST: THANK YOU, SENATOR KINTNER. SENATOR LARSON, 4:00. AND SENATOR LARSON WAIVES. STILL REMAINING IN THE QUEUE WISHING TO SPEAK: SENATOR CRAWFORD, RIEPE, AND McCOLLISTER. SENATOR CRAWFORD, YOU'RE RECOGNIZED. [LB113]

SENATOR CRAWFORD: THANK YOU, MR. PRESIDENT. I WOULD JUST CLARIFY ON THE RECORD THE IDEA OF A DIFFERENT RATE FOR REPEAT OFFENDER WAS NOT MY IDEA, SO JUST ... THAT'S WHY I WAS SHAKING MY HEAD IS THAT WASN'T MY IDEA AND NOT SOMETHING I WOULD RECOMMEND SO, AND AS SENATOR LARSON TALKED ABOUT, POSSIBLY, PROBABLY UNCONSTITUTIONAL ANYWAY. I WANTED TO COME BACK AND AGAIN REINFORCE THE POINT THAT IF YOU ARE...IF \$10 COPAY FOR THE PEOPLE WHO ARE IN THE BEST JOBS IN OUR STATE PRISONS, THAT IS 52 PERCENT OF THEIR WEEKLY WAGE TO 31 PERCENT OF THEIR WEEKLY WAGE. SO I ENCOURAGE YOU TO CONSIDER WHETHER YOU THINK A COPAY FOR HEALTHCARE THAT WOULD BE 50 PERCENT OF YOUR WEEKLY WAGE OR 30 PERCENT OF YOUR WEEKLY WAGE WOULD BE APPROPRIATE. AND AGAIN, A \$50 COPAY IS ABOUT 5 PERCENT OF A WEEKLY WAGE AND FOR THAT TO BE TRANSLATED WOULD BE LESS THAN A DOLLAR. SO AGAIN WE COME BACK TO THE SITUATION OF, IF IT DOESN'T MAKE SENSE, AND THE FISCAL NOTE TO THE STATE SAID IT DOESN'T MAKE SENSE FOR TO US DO THIS AT \$10, AND THE FISCAL NOTE THAT TALKS ABOUT COUNTIES THAT IT'S, YOU KNOW, NOT LIKELY TO MAKE SENSE FROM ANY COUNTIES TO DO IT AT \$10, IF YOU BRING THAT COPAY DOWN TO LESS THAN \$1 OR EVEN \$1, IT MAKES EVEN LESS SENSE. SO YESTERDAY SENATOR RIEPE TALKED ABOUT THE LOGIC OF COPAYS. AND AGAIN, ONE OF THE GREAT THINGS ABOUT SERVING IN THIS CHAMBER IS THAT WE HAVE PEOPLE FROM ALL DIFFERENT BACKGROUNDS, AND THEY BRING THAT EXPERTISE TO THE BODY. AND SENATOR RIEPE AS A HOSPITAL ADMINISTRATOR TALKED ABOUT THE FACT THAT, WHILE IT MAY NOT MAKE FINANCIAL SENSE, THERE ARE OTHER REASONS TO HAVE COPAYS AS WELL, TRY TO INFLUENCE BEHAVIOR WITH COPAYS. AND SO ONE THING YOU MIGHT BE TRYING TO DO WITH A COPAY IS TO TRY TO REDUCE USE OF CARE THAT YOU THINK IS INAPPROPRIATE. AND HE USED THE EXAMPLE OF SOME CASES WHERE THERE'S A HIGHER COPAY FOR INAPPROPRIATE USE OF THE EMERGENCY ROOM. SO I JUST

WANTED TO ASK A QUESTION OF SOMEONE WHO'S ON THE JUDICIARY COMMITTEE WHO WAS THERE FOR THE HEARING. I WONDER IF SENATOR CHAMBERS WOULD YIELD TO A QUESTION. [LB113]

SENATOR KRIST: SENATOR CHAMBERS, WILL YOU YIELD? [LB113]

SENATOR CHAMBERS: YES, I WILL. [LB113]

SENATOR CRAWFORD: THANK YOU. DID YOU HAPPEN...WERE YOU PRESENT THE DAY THIS BILL WAS HEARD AT THE HEARING? [LB113]

SENATOR CHAMBERS: I BELIEVE I WAS AT THE HEARING, BUT I WASN'T THERE WHEN THEY HAD THE EXEC SESSION. [LB113]

SENATOR CRAWFORD: SURE. SO I THINK ONE OF THE ISSUES THAT WE'VE HEARD RAISED IN THE DEBATE IS A CONCERN THAT PRISON STAFF ARE HAVING TO TAKE TIME TO ESCORT PRISONERS TO THE SICK BAY OR WHEREVER THEY RECEIVE CARE, FRIVOLOUSLY, AND THAT PRISONERS WOULD JUST USE THIS TO GET SOME TIME TO GO SOMEWHERE ELSE AND TALK TO SOMEONE ELSE. I WONDERED IF THERE WAS ANYBODY THAT CAME TO THE HEARING TO TESTIFY THAT THAT WAS A CONCERN THAT THEY HAD. [LB113]

SENATOR CHAMBERS: NOBODY FROM A PRISON SYSTEM OR A JAIL WAS THERE. NACO WAS THERE AND WHOEVER...AND I THINK SENATOR LARSON. THERE WAS NOT A GREAT OUTPOURING OF SUPPORT AT ALL. AND MY ASSUMPTION WAS THAT PEOPLE WOULD SEE WHAT A BAD DEAL IT IS AND IT WILL GO AWAY. NOW THERE WAS A MINISTER WHO WENT INTO SOME DEPTH AS TO WHY THIS WAS NOT A GOOD IDEA. AND I BELIEVE THE ACLU MAY HAVE TESTIFIED AND THEIR TESTIMONY WAS OF SUBSTANCE. NACO, THAT PERSON WAS JUST SPEAKING BECAUSE IT INVOLVED THE COUNTY. THERE WAS NOT ANY KNOWLEDGE OF THE PRISONS, THE JAILS, OR ANY OF THOSE THINGS THAT YOU'RE ASKING ME ABOUT NOW. [LB113]

SENATOR CRAWFORD: OKAY. SO AS A LONG-SERVING MEMBER OF THE JUDICIARY COMMITTEE... [LB113]

SENATOR KRIST: ONE MINUTE. [LB113]

SENATOR CRAWFORD: ...ISN'T IT THE CASE THAT YOU WOULD REGULARLY HEAR IN BRIEFINGS AND IN BILLS CONCERNS THAT ARE BEING RAISED ABOUT PROBLEMS WITH PRISON WORK FORCE AT STATE LEVEL OR THE COUNTY JAIL? IF THERE ARE WORK FORCE KINDS OF ISSUES, THAT WOULD COME TO YOUR COMMITTEE, IS THAT CORRECT? [LB113]

SENATOR CHAMBERS: THEY DO AND WE'RE LOOKING AT SOME WITH REFERENCE TO THE PRISON. BUT THIS WAS NOT AMONG THOSE. [LB113]

SENATOR CRAWFORD: THAT WAS...I WAS GOING TO ASK IF IN ANY OF THOSE DISCUSSIONS PEOPLE WHO WORK IN THE PRISONS HAVE RAISED THE CONCERN THAT PEOPLE ASKING TO GO TO THE SICK BAY HAS CREATED A PROBLEM IN THEIR WORK FORCE. [LB113]

SENATOR CHAMBERS: WHEN YOU COME TO THE WORK FORCE, THEIR COMPLAINT IS THAT THERE ARE NOT ENOUGH EMPLOYEES TO DO THE REGULAR RUNNING OF THE PRISON, CONSEQUENTLY, THEY HAVE TO PUT IN A LOT OF OVERTIME. SO I DOUBT THAT THIS WOULD BE ON THEIR RADAR AT ALL BECAUSE IT WOULD BE SO INCONSEQUENTIAL AND THEY HAVE MUCH BIGGER ISSUES THEY RAISE ON SOMETHING LIKE THIS. [LB113]

SENATOR KRIST: TIME, SENATOR. [LB113]

SENATOR CRAWFORD: THANK YOU. THANK YOU. [LB113]

SENATOR CHAMBERS: OKAY. [LB113]

SENATOR KRIST: THANK YOU, SENATOR CRAWFORD AND SENATOR CHAMBERS. SENATOR RIEPE, YOU ARE RECOGNIZED. [LB113]

SENATOR RIEPE: MR. PRESIDENT, THANK YOU AND MEMBERS OF THIS SENATE. I WAS TAKEN A BIT BY SENATOR CRAWFORD WHO REFERRED TO SICK BAY AND SO SHE OBVIOUSLY HAS A MILITARY DISTRICT FOR THOSE OF US WHO HAVE SERVED IN THE MILITARY. I ALSO WANTED TO REMIND THIS BODY THAT THE COPAY IS NOT NECESSARILY \$10. IT IS UP TO \$10. SO WE ALREADY HAVE SOME SLIDING SCALE THAT IS OR CAN BE APPLICABLE. I THINK ALSO THERE WAS A COMPARISON OF THE COPAYS IN A PERCENTAGE IN RELATIONSHIP TO THE \$15 OR WHATEVER AMOUNT OF MONEY. I'D LIKE TO ALSO REMIND THE BODY THAT

THOSE THAT ARE IN THE GENERAL POPULATION OUTSIDE OF THE PRISON SYSTEM DO PAY PREMIUMS. WE ALSO HAVE DEDUCTIBLES, AS SENATOR KOLTERMAN TALKED ABOUT YESTERDAY, THAT MAY BE UP TO \$5,000, \$6,000 FOR THE INDIVIDUAL, \$12,000 FOR A FAMILY. SO I WOULD HOPE THAT THE MOTIVATION FOR THE INCARCERATION SYSTEM ISN'T THAT WE'RE TRYING TO PROVIDE TOTALLY FIRST-DOLLAR COVERAGE. AND I STILL CONTEND THAT COPAYS ARE THERE NOT FOR THE MONEY BUT, RATHER, TO MAKE PEOPLE THINK TWICE BEFORE THEY WANT TO EXECUTE OR MOVE FORWARD WITH RECEIVING THAT CARE. I WOULD ALSO SPEAK AGAINST THE IDEA OF HAVING SOME FORMULA OVER A \$10 COPAY. I THINK WE'VE HAD SOME EXPERIENCE WITH FORMULAS ON EARLY RELEASE OF PRISONERS AND I THINK THAT WE'RE GOING TO SPEND A LOT MORE MONEY TRYING TO COME UP WITH SOME FORMULA AND THEN SOME COMPUTER SYSTEM TO MONITOR IT AND PEOPLE AND THE COST OF IT IS JUST ... THE VALUE IS NOT THERE. AND SO I WOULD SERIOUSLY WANT TO DISCOURAGE ANY EFFORT IN THAT DIRECTION. THANK YOU, MR. PRESIDENT. [LB113]

SENATOR KRIST: THANK YOU, SENATOR RIEPE. THOSE STILL WISHING TO SPEAK: SENATOR McCOLLISTER, LARSON, AND BLOOMFIELD. SENATOR McCOLLISTER, GOOD MORNING. YOU'RE RECOGNIZED. [LB113]

SENATOR McCOLLISTER: THANK YOU, MR. PRESIDENT. AND GOOD MORNING, COLLEAGUES. I HAVEN'T SPOKEN ON THE MIKE FOR THE LAST COUPLE OF DAYS SO I THOUGHT I'D GET UP AND MAKE YOU KNOW THAT I'M STILL ALIVE. CONCEPTUALLY I SUPPORT LB113. YOU KNOW, IT WOULD BE A GOOD WAY TO CONTROL SOME OF OUR HEALTHCARE EXPENSES AND WOULD PERHAPS ELIMINATE SOME UNNECESSARY TRIPS TO THE DOCTOR. BUT AS IN EVERYTHING, THE DEVIL IS IN THE DETAILS. I WOULD ASK IF SENATOR BRASCH WOULD YIELD TO A FEW QUESTIONS. [LB113]

SENATOR KRIST: SENATOR BRASCH, WILL YOU YIELD? [LB113]

SENATOR BRASCH: I WILL YIELD. [LB113]

SENATOR McCOLLISTER: SENATOR BRASCH, YOU INDICATED THAT YOU HAD TALKED TO THREE OF YOUR COUNTIES WHETHER THEY WOULD SUPPORT THIS BILL, IS THAT CORRECT? [LB113]

SENATOR BRASCH: THAT IS NOT CORRECT. I SAID I SPOKE...WAS ABLE TO REACH TWO OUT OF THREE. [LB113]

SENATOR McCOLLISTER: TWO OF THE THREE? [LB113]

SENATOR BRASCH: YES. [LB113]

SENATOR McCOLLISTER: AND THEY INDICATED SUPPORT FOR THIS LB113? [LB113]

SENATOR BRASCH: THEY INDICATED SUPPORT BUT THEY REALLY QUESTIONED THE REALITY OF IT. THEY SAID IT ALL SOUNDS GOOD, BUT AT THE SAME TIME THEY'RE SAYING THEY BRING IN A LOT OF INDIGENTS. SOME INDIGENTS ARE QUESTIONABLE; OTHERS ARE NOT. [LB113]

SENATOR McCOLLISTER: SO THEIR POINT TO YOU WAS THAT IT MAY NOT BE WORTH THE EFFORT TO KEEP TRACK OF THE RECORDS AND KEEP TRACK OF THE INMATES IN THIS WAY, IS THAT CORRECT? [LB113]

SENATOR BRASCH: THAT WAS NOT THE INDICATION. THE INDICATION WAS THERE ARE PROBLEMS BUT THE PROBLEMS ARE AROUND THEIR...THEY HAVE LESS THAN 50 INMATES, SO THEY CANNOT GET THE INSURANCE. WHAT THEY DO IS THEY CAN GO TO A JUDGE AND GET A MEDICAL BOND. THEY SAID IT SOUNDS GOOD, YOU KNOW, THE SOUND OF IT IS GOOD. BUT IF SOMEONE IS TRULY INDIGENT, THAT'S A PROBLEM. THE PROBLEM THAT THEY DID SEE, WHICH I BELIEVE IS ANOTHER BILL, POTENTIALLY AN AMENDMENT, IS THAT TELEPHONE CALLS AND CANTEENS, THE FAIR MARKET VALUE IS NOT THERE. [LB113]

SENATOR McCOLLISTER: THANK YOU. [LB113]

SENATOR BRASCH: THEY SAW THAT AS AN ISSUE. THANK YOU. [LB113]

SENATOR McCOLLISTER: THANK YOU, SENATOR. I WONDER IF SENATOR LARSON WOULD YIELD FOR A QUESTION OR TWO. [LB113]

SENATOR KRIST: SENATOR LARSON, WILL YOU YIELD? [LB113]

SENATOR LARSON: YES. [LB113]

SENATOR McCOLLISTER: WHAT KIND OF RECORDKEEPING WILL PENAL INSTITUTIONS, COUNTIES AND THE STATE, BE OBLIGATED TO KEEP AS A RESULT OF THIS BILL? [LB113]

SENATOR LARSON: WELL, SHOULD THE STATE CHOOSE TO DO IT OR ANY COUNTY--OBVIOUSLY IT'S PERMISSIVE LANGUAGE--THEY WOULD HAVE TO KEEP A RECORD, AS THEY CURRENTLY DO, OF THE DOCTOR'S VISITS MADE BY THE PRISONERS. WHEN A PRISONER GOES RIGHT NOW, THEY KEEP THAT RECORD. THEY HAVE TO KEEP THE RECORD OF THE VISIT. THEY HAVE TO PAY THE INSTITUTION IN WHICH, WHETHER IT IS THE HOSPITAL OR THE DOCTOR'S OFFICE, TO...FOR THAT VISIT. SO AT THE COUNTY LEVEL I DON'T THINK IT WILL BE THAT BIG OF AN ISSUE. I MEAN HOLT COUNTY AT ANY ONE TIME HAS ANYWHERE BETWEEN, YOU KNOW, PROBABLY FOUR TO TEN PRISONERS. PIERCE COUNTY IS KIND OF THE SAME WAY AND A NUMBER OF THEM. THE STATE IS A LITTLE DIFFERENT ISSUE, AND THAT'S WHY THE STATE SAID THAT THEY FELT LIKE THEY...IT MIGHT NOT BE WORTH IT TO THEM BECAUSE THEY HAVE ANYWHERE BETWEEN 4,600 AND 5,000 PRISONERS AT ONE TIME. SO THE RECORDKEEPING WOULD BE A LITTLE MORE COST INTENSIVE, THEREFORE, THEY DIDN'T THINK IT WOULD BE WORTH IT. [LB113]

SENATOR McCOLLISTER: THANK YOU. THANK YOU. HAVE YOU INDICATED HOW MUCH MONEY A TYPICAL COUNTY WOULD SAVE ON THIS KIND OF PROGRAM? [LB113]

SENATOR LARSON: YOU KNOW, IN THE STATE OF NEBRASKA IT'S A LITTLE MORE DIFFICULT. OBVIOUSLY THE COPAY ISN'T GOING TO BRING IN A LOT OF MONEY. OTHER STATES HAVE SEEN, YOU KNOW, ANYWHERE BETWEEN 15, 20 PERCENT DECREASES IN THE AMOUNT OF COST THAT THEY'VE HAD ASSOCIATED WITH THE HEALTHCARE, SOME MORE. SENATOR McCOLLISTER: THANK YOU. THANK YOU. WELL, AS I HEAR THIS BILL, I AM THINKING IT MAY NOT BE WORTH THE TIME AND MONEY THAT SOME COUNTIES WOULD HAVE TO DEVOTE TO IT. I'M LOOKING AT SENATOR CRAWFORD'S COMMENTS THAT, YOU KNOW, MOST OF OUR COUNTIES AND THE OTHER INSTITUTIONS THAT HAVE PRISONS WON'T BOTHER TO KEEP THE RECORDS. SO THIS BILL SIMPLY IN CONCEPT IS A GOOD BILL. BUT I THINK IN TERMS OF WORKABILITY IT JUST ISN'T THERE. SO I WOULD SUPPORT AN EFFORT TO RECOMMIT THIS TO A COMMITTEE. LASTLY, IT HAS VERY LIMITED PROPONENT SUPPORT. IF A NUMBER OF COUNTIES HAD COME AND SUPPORTED THE BILL, I WOULD FEEL A LOT BETTER ABOUT SUPPORTING IT AS WELL. THANK YOU, MR. PRESIDENT. [LB113]

SENATOR KRIST: THANK YOU, SENATOR McCOLLISTER, SENATOR BRASCH, AND SENATOR LARSON. SENATOR LARSON, YOU ARE RECOGNIZED. [LB113]

SENATOR LARSON: THANK YOU, MR. PRESIDENT. SENATOR McCOLLISTER SHOULD UNDERSTAND THAT NEBRASKA COUNTY OFFICIALS...OR THE COUNTY ASSOCIATION CAME TO SUPPORT IT, MEANING ALL THE COUNTIES CAME TO SUPPORT IT. HIS ASSERTION THAT THE MORE TESTIFIERS THE BETTER MAKES IT A GOOD THING ISN'T NECESSARILY GENUINE. I WOULD SAY THAT EVERY COUNTY SUPPORTS IT. IF THEIR ASSOCIATION OR MANY COUNTIES SUPPORT IT, AT LEAST A MAJORITY OF THE COUNTIES SUPPORT IT, AND THE BOARD OF THE COUNTY OFFICIALS ASSOCIATION SUPPORT IT, SO WHY WOULD THE INDIVIDUAL COUNTIES HAVE TO COME AND DO IT? AND IF A COUNTY DOESN'T WANT TO HAVE IT, IF SENATOR MCCOLLISTER AND SENATOR CRAWFORD ARE WORRIED THAT, YOU KNOW, IT MIGHT JUST BE TOO MUCH FOR SOME COUNTIES ON THE EXTRA COST, WELL, FOR THOSE COUNTIES THEY WON'T DO IT. BUT FOR OTHER COUNTIES IT WON'T BE TOO MUCH. FOR OTHER COUNTIES THIS WILL BE A TOOL. I KNOW NEITHER SENATOR CRAWFORD OR SENATOR McCOLLISTER WERE HERE WHEN WE CUT STATE AID TO CITIES AND COUNTIES. HAVING MADE THAT DECISION TO CUT THE AID, THE STATE AID TO THE CITIES AND COUNTIES, I WANT TO GIVE THEM A TOOL SHOULD THEY CHOOSE TO USE IT. I KNOW WE HAVE A NUMBER OF FORMER COUNTY COMMISSIONERS OR SUPERVISORS IN THIS BODY. SENATOR CAMPBELL IS ONE OF THEM. OH, JUST ONE. LANCASTER COUNTY MIGHT NOT USE IT. BUT WOULDN'T A COUNTY ENJOY AT LEAST THE OPPORTUNITY TO HAVE THAT TOOL? DON'T THE COUNTIES WANT AS MANY TOOLS AS POSSIBLE? WILL SENATOR CAMPBELL YIELD? [LB113]

SENATOR KRIST: SENATOR CAMPBELL, WILL YOU YIELD TO A QUESTION? [LB113]

SENATOR CAMPBELL: YES, CERTAINLY. [LB113]

SENATOR LARSON: NOW LANCASTER, I KNOW...YOU WERE A FORMER LANCASTER COUNTY COMMISSIONER OR SUPERVISOR? WHAT ARE THEY CALLED? [LB113]

SENATOR CAMPBELL: I WAS A COUNTY COMMISSIONER. [LB113]

SENATOR LARSON: COMMISSIONER, POLK COUNTY SUPERVISOR, SO IT'S...HAVE TO LEARN WHICH ONE. EVERYONE IS DIFFERENT. SO FOR LANCASTER COUNTY, LB113 MAY NOT HAVE MADE SENSE FOR YOU GUYS TO IMPLEMENT BECAUSE OF THE ADDED ADMINISTRATIVE COSTS THAT SENATOR CRAWFORD OR SENATOR McCOLLISTER BROUGHT UP, CORRECT? [LB113]

SENATOR CAMPBELL: THAT IS CORRECT. ALSO, WE PUT INTO OUR JAIL FACILITY A SMALL MEDICAL OFFICE AND SO... [LB113]

SENATOR LARSON: THEY DON'T HAVE TO TAKE THEM TO THE DOCTOR. THEY DON'T HAVE THOSE OTHER COSTS ASSOCIATED THAT THE SMALLER COUNTIES MIGHT ESSENTIALLY. [LB113]

SENATOR CAMPBELL: UNLESS IT WAS A SITUATION IN WHICH WE COULD NOT HANDLE IT THERE. [LB113]

SENATOR LARSON: AN EMERGENT, MORE OF AN EMERGENCY SITUATION IN WHICH LB113... [LB113]

SENATOR CAMPBELL: RIGHT. [LB113]

SENATOR LARSON: ...WOULD NOT REQUIRE A COPAY BECAUSE IT WOULD HAVE BEEN MORE OF AN EMERGENCY SITUATION. [LB113]

SENATOR CAMPBELL: I CHECKED WITH LANCASTER COUNTY AND THEY HAVE NO OFFICIAL POSITION. THE DIRECTOR OF THE CORRECTIONAL FACILITY SAID THEY WILL NOT BE USING IT BECAUSE IT WOULD BE NOT COST EFFECTIVE FROM AN ADMINISTRATIVE STANDPOINT. [LB113]

SENATOR LARSON: FROM THE ADMINISTRATIVE STANDPOINT, LANCASTER COUNTY, THAT MAKES SENSE. DO YOU THINK SMALLER COUNTIES...DO YOU THINK A COUNTY SHOULD HAVE THE OPTION? DO YOU THINK COUNTIES ENJOY OPTIONS GIVEN TO THEM BY THE STATE SINCE THE STATE OFTENTIMES...WE HEAR ALL THE TIME FROM COUNTIES THAT THE STATE IS PUTTING ADDED BURDENS ON THEM, THE STATE IS REQUIRING THIS FROM THEM. [LB113]

SENATOR KRIST: ONE MINUTE. [LB113]

SENATOR LARSON: NOT JUST LB113, DO COUNTIES IN GENERAL ENJOY IT WHEN THEY HAVE THE OPPORTUNITY TO GO GET...OR FLEXIBILITY IN THE WAY THEY CAN CARRY OUT THEIR OPERATIONS? [LB113]

SENATOR CAMPBELL: I WOULD GUESS ANY LOCAL POLITICAL SUBDIVISION WOULD ENJOY SOME FLEXIBILITY. [LB113]

SENATOR LARSON: THANK YOU, SENATOR CAMPBELL. THAT'S WHAT LB113 IS. IT IS FLEXIBILITY FOR THE COUNTIES. THEY DO NOT HAVE TO DO IT. THEY MAY NOT DO IT. THE CONCEPT THAT SENATOR McCOLLISTER AND SENATOR CRAWFORD BROUGHT FORWARD THAT THE ADMINISTRATIVE COST WOULD JUST BE TOO HIGH, WELL, FOR A FEW COUNTIES MAYBE THEY'RE RIGHT. BUT WHY TELL EVERY COUNTY THAT THEY CAN'T DO IT? WHY NOT GIVE THEM THAT TOOL IN THE TOOLBOX... [LB113]

SENATOR KRIST: TIME, SENATOR. [LB113]

SENATOR LARSON: ...IF THEY CHOOSE TO USE IT? THANK YOU, MR. PRESIDENT. [LB113]

SENATOR KRIST: THANK YOU, SENATOR LARSON AND SENATOR CAMPBELL. SENATOR BLOOMFIELD, YOU ARE RECOGNIZED. [LB113]

SENATOR BLOOMFIELD: THANK YOU, MR. PRESIDENT. I WOULD HAVE A COUPLE MORE QUESTIONS FOR SENATOR LARSON IF HE WOULD YIELD. [LB113]

SENATOR KRIST: SENATOR LARSON, WILL YOU YIELD? [LB113]

SENATOR LARSON: YES. [LB113]

SENATOR BLOOMFIELD: THANK YOU, SENATOR. MY UNDERSTANDING IS THAT NO COUNTY IS OBLIGATED TO DO THIS IF WE PASS THIS, IS THAT CORRECT? [LB113]

SENATOR LARSON: CORRECT. [LB113]

SENATOR BLOOMFIELD: THANK YOU. SO THERE IS NO CONTINUITY BETWEEN COUNTIES; THERE'S NO CONTINUITY WHETHER THEY CHARGE \$1 FOR THE TRIP OR \$10? [LB113]

SENATOR LARSON: CORRECT. [LB113]

SENATOR BLOOMFIELD: NO MORE THAN \$10? [LB113]

SENATOR LARSON: NO MORE THAN \$10. [LB113]

SENATOR BLOOMFIELD: OKAY. I STILL HAVE NOT DECIDED WHERE TO GO WITH THIS, BUT YOU CAME AWFULLY CLOSE TO LOSING ME WHEN YOU QUOTED NACO AS REPRESENTING ALL COUNTIES. [LB113]

SENATOR LARSON: I WAS CORRECTED ON THAT THAT... [LB113]

SENATOR BLOOMFIELD: AND YOU NEED TO BE CORRECTED MORE, SENATOR. I WONDER IF AN AMENDMENT THAT WOULD ALLOW A PRISONER ONE TRIP EVERY 60 DAYS WITHOUT HAVING TO BE PENALIZED FOR IT MAYBE WOULDN'T BE IN LINE. I WONDER ABOUT AN AMENDMENT, AND MAYBE IT WOULD NOT BE GERMANE, THAT WOULD ALLOW

FOR FAIR MARKET VALUE ON COMMISSARY ISSUES. I'VE GOT A WAYS TO GO ON THIS YET. BUT THANK YOU FOR YOUR RESPONSE TO THE QUESTIONS I HAVE, AND PLEASE DON'T BRING NACO INTO THIS ANYMORE. [LB113 LB106]

SENATOR KRIST: THANK YOU, SENATOR BLOOMFIELD AND SENATOR LARSON. SENATOR BRASCH, YOU ARE RECOGNIZED AND THIS IS YOUR THIRD TIME. [LB113]

SENATOR BRASCH: THANK YOU, MR. PRESIDENT. AND THANK YOU ONCE MORE, COLLEAGUES. BECAUSE THERE IS AN OPTION HERE. BECAUSE IT IS UP TO \$10. I WILL SUPPORT THIS. I WOULD BE MORE EXCITED ABOUT IT IF WE WERE ADDRESSING PHONE CALLS AND COMMISSARY FAIR MARKET VALUE, AND MAYBE THAT WILL BE SOMETHING TO CONSIDER LOOKING AT FURTHER. AGAIN, TO BE CLEAR, THE SHERIFF SAID THAT'S GOOD IF YOU CAN DO IT. THE OTHERS SAID, TWO OUT OF THREE, THAT THERE ARE WAYS, BECAUSE THEY ARE UNDER 50 INCARCERATED INDIVIDUALS, TO GO TO A JUDGE FOR A MEDICAL BOND. AND THIS IS FOR NONEMERGENCY. AND LIKE SENATOR BLOOMFIELD, WHEN NACO CAME TO SPEAK AGAINST THE 75 TO 65 PROPERTY TAX REDUCTION, I HAD TWO OF MY COUNTIES COME TESTIFY IN SUPPORT OF MY LB350. SO FOR THE NEW COLLEAGUES IS: DO CHECK WITH YOUR COUNTIES. I'M VERY FORTUNATE THAT I DO HAVE SOME CELL PHONE NUMBERS FOR SHERIFFS IN MY AREA. SO THAT'S SOMETHING SENATOR BLOOMFIELD MAY WANT TO ALSO REQUEST FOR A MORE EXPEDIENT DIALOGUE. THANK YOU, MR. PRESIDENT. AND THANK YOU, COLLEAGUES. [LB113 LB350]

SENATOR KRIST: THANK YOU, SENATOR BRASCH. SENATOR CRAWFORD, YOU ARE RECOGNIZED AND THIS IS YOUR THIRD TIME. [LB113]

SENATOR CRAWFORD: THANK YOU, MR. PRESIDENT. AND THANK YOU, COLLEAGUES. SO I WANT TO TALK A BIT MORE ABOUT THE LOGIC OF COPAYS AND WHAT THAT MEANS. AND ALSO WE'VE TALKED ABOUT THE FACT THAT, WELL, THIS BILL JUST CREATES AN OPTION; IT DOESN'T REQUIRE THE STATE TO DO ANYTHING; IT DOESN'T REQUIRE THE COUNTIES TO DO ANYTHING. SO

WHAT'S THE HARM? SO I'LL TRY TO ADDRESS BOTH OF THOSE ISSUES IN THIS TURN. SO AS WE'VE SAID BEFORE, SOMETIMES A COPAY IS USED TO TRY TO DISCOURAGE ACCESS TO CARE THAT YOU THINK MIGHT BE UNREASONABLE. NOW ON THE FLIP SIDE, WHAT YOU FIND IN MOST OF YOUR PRIVATE PLANS IS WHEN THERE IS A KIND OF CARE THAT YOU WANT PEOPLE TO GET. YOU TAKE OFF THE COPAY. SO MOST OF YOU HAVE PLANS. PROBABLY THEY DON'T CHARGE A COPAY FOR YOUR PREVENTIVE CARE. AND WHAT'S IMPORTANT TO RECOGNIZE IN A PRISON SETTING IS IT'S A CROWDED SETTING WHERE INFECTIONS CAN SPREAD. WE WANT PRISONERS TO GET HEALTHCARE, NOT ONLY FOR THEMSELVES, BUT HAVING A COPAY HAS BEEN IDENTIFIED AS A CONTRIBUTING FACTOR FOR OUTBREAKS OF ANTIBIOTIC-RESISTANT STAPH INFECTIONS. SO ASKING THE PRISONER TO THINK TWICE ABOUT WHETHER TO REQUEST A TRIP TO GET TO RECEIVE MEDICAL CARE TO GET SOMETHING CHECKED, ASK THEM TO THINK TWICE DOES NOT JUST PUT THAT PRISONER AT RISK, IT PUTS THE OTHER PRISONERS IN THAT BAY AT RISK AS WELL. AND THEY ARE INCARCERATED FOR THEIR CRIMES. IT IS NOT THE CASE THAT THEY SHOULD NECESSARILY BE AT HIGHER RISK FOR ANTIBIOTIC-RESISTANT INFECTION BECAUSE WE WANT SOMEONE TO THINK TWICE ABOUT WHETHER THEY SHOULD RECEIVE HEALTHCARE. SO THE SECOND POINT IS TALKING ABOUT, WHY DOES IT MATTER IF WE GIVE THIS TOOL AND IT DOESN'T MAKE SENSE FOR THE STATE TO USE IT AND IT DOESN'T MAKE SENSE FOR MOST COUNTIES TO USE IT, SO WHAT, WE'RE JUST SAYING HERE'S THE TOOL, IT'S UP TO YOU? THE HARM IS THAT IF WE PASS LB113 IT DOES HAVE PERMISSIVE LANGUAGE. SO WE ARE NOT REQUIRING THE STATE OR ANY COUNTY TO DO THIS. HOWEVER, WE ARE SAYING, WITH OUR VOTE, THAT THIS IS A TOOL THAT WE THINK HAS VALUE FOR YOU TO USE. THAT STATEMENT IS THERE. SO I DON'T THINK THAT YOU CAN SAY, DOESN'T MATTER, YOU CAN JUST VOTE FOR LB113, EVEN IF YOU DON'T THINK IT'S A GOOD IDEA FOR THE STATE, EVEN IF YOU DON'T THINK IT WILL REALLY WORK IN ANY COUNTY, WE'RE JUST GIVING THEM A TOOL SO GIVE THEM THE TOOL, BECAUSE PEOPLE HAVE EXPECTED THAT WE HAVE RESEARCHED THIS ISSUE AND THAT OUR VOTE TO PROVIDE THIS TOOL MEANS THAT WE THINK IT'S A GOOD TOOL AND THAT THE STATE SHOULD POSSIBLY USE IT OR COUNTIES SHOULD POSSIBLY USE IT. AND HERE'S A SCENARIO THAT I CAN IMAGINE HAPPENING: PEOPLE GO BACK TO THEIR DISTRICTS AND THEY SAY, I VOTED FOR LB113 BECAUSE I WANT TO MAKE SURE PRISONERS ARE PAYING FOR THEIR HEALTHCARE. AND SOMEONE SAYS, WOW, THAT'S GREAT, IS THAT HAPPENING NOW? AND YOU WOULD HAVE TO HONESTLY SAY, NO, IT'S NOT HAPPENING IN THE STATE. AND YOU MIGHT BE SAYING, NO, WELL, YOU KNOW, OUR COUNTY HASN'T DECIDED TO DO THAT BUT I DID MY PART, I VOTED FOR LB113. THAT WILL THEN CREATE A LOT OF POLITICAL PRESSURE ON THE GOVERNOR, ON THE DEPARTMENT OF

CORRECTIONS TO IMPLEMENT THIS BILL EVEN THOUGH THEIR ANALYSIS SHOWS IT DOES NOT MAKE FINANCIAL SENSE. [LB113]

SENATOR CRAWFORD: THANK YOU, MR. PRESIDENT. THE PEOPLE WILL SAY, WELL, I HEARD FROM MY SENATORS THAT THEY PASSED THIS BILL THAT LETS THE DEPARTMENT OF CORRECTIONS CHARGE THIS FEE SO I THINK THEY SHOULD BE DOING THAT AND SO I'M GOING TO PUT PRESSURE ON THE GOVERNOR, PRESSURE ON THE DEPARTMENT OF CORRECTIONS TO MAKE THAT HAPPEN. SO I JUST ASK YOU TO THINK CAREFULLY ABOUT WHAT YOUR VOTE FOR LB113 SAYS. EVEN THOUGH IT'S PERMISSIVE LANGUAGE IT STILL IS AN ENDORSEMENT OF THE IDEA. AND IF THIS DOESN'T MAKE SENSE FOR THE STATE, IF IT DOESN'T MAKE SENSE FOR MOST COUNTIES TO REALLY DO IT, IS IT A TOOL THAT WE SHOULD BE ENDORSING? THANK YOU, MR. PRESIDENT. [LB113]

SENATOR KRIST: THANK YOU, SENATOR CRAWFORD. SENATOR BLOOMFIELD, YOU ARE RECOGNIZED AND THIS IS YOUR THIRD TIME. [LB113]

SENATOR BLOOMFIELD: THANK YOU, MR. PRESIDENT. WE'VE BEEN DOING A LITTLE MORE STUDYING ON THIS AND WE HEARD BACK FROM ONE OF OUR SHERIFFS AND THEY ARE CONFUSED AS TO WHAT THE STATUTE IS NOW. AS CLOSE AS HE CAN FIGURE OUT, UNDER THE AFFORDABLE CARE ACT EVERYONE SHOULD ALREADY HAVE INSURANCE. AND HE WENT TO SECTION 47-701 THROUGH 47-705 AND IT APPARENTLY STATES--AND I HAVE NOT HAD TIME TO PULL IT UP AND LOOK AT IT YET--THAT FIRST, THE PROVIDER WOULD PAY...OR WOULD BILL THE INSURANCE COMPANY, WHICH YOU'RE REQUIRED TO HAVE THROUGH OBAMACARE. YOU SHOULD HAVE INSURANCE. THE REMAINDER GOES TO THE INMATE. AND THEN, AFTER 180 DAYS, IF THEY HAVE NOT COLLECTED FROM THE INMATE, THEN IT GOES TO THE COUNTY. SO I BELIEVE WE'RE DEALING WITH A CONFUSED AREA ALREADY, AND THIS MIGHT JUST MAKE IT WORSE. AND I ANTICIPATE SENATOR LARSON'S RESPONSE BEING THAT THIS REALLY DOESN'T GO TO THAT STATUTE BECAUSE IT'S JUST ALLOWING THE COUNTIES TO DO SOMETHING, BUT I DON'T KNOW THAT YET. THIS IS ANOTHER

ONE OF THOSE AREAS THAT I WILL HAVE TO LOOK AT BETWEEN NOW AND SELECT. BUT I THINK IT'S AN AREA WE NEED TO BE CAREFUL OF WHERE WE GO. I TALKED TO SENATOR SEILER JUST BRIEFLY ON IT AND HE HAS NOT HAD AN OPPORTUNITY TO LOOK AT IT EITHER. BUT I DO THINK WE HAVE ISSUES GOING FORWARD. I'M GOING TO YIELD TO SENATOR LARSON. SENATOR KRIST: SENATOR LARSON WAIVES. SENATOR LARSON, YOU'RE NEXT IN THE QUEUE. [LB113]

SENATOR LARSON: THANK YOU, MR. PRESIDENT. A FEW THINGS I WANTED TO DISCUSS A LITTLE BIT. I HEARD A FEW COMMENTS FROM SENATOR CRAWFORD TALKING ABOUT HOW MUCH OF A PRISONER'S INCOME WOULD THOSE THAT WORK IN THE STATE FACILITIES -- AGAIN, WE ARE ASSUMING THAT ONE OF THE STATE FACILITIES WOULD IMPLEMENT THIS AND I CAN TALK ABOUT THAT FOR A SECOND--BUT HOW MUCH OF THEIR INCOME WOULD GO TO THAT. WELL, WHAT SHE NEGLECTS TO FIGURE IN IS, HER AND I, AS INDIVIDUALS THAT ARE NOT IN PRISON, THE COPAY ISN'T JUST THE ONLY PORTION WE PAY. WE PAY PREMIUMS: WE PAY DEDUCTIBLES; AND WE PAY A COPAY. SO TO SAY THAT ONLY 5 PERCENT OF OUR WEEKLY WAGE GOES TO A COPAY AND 50 PERCENT OF THEIR WEEKLY WAGE IS GOING TO GO TO A COPAY, THEREFORE, IT IS DISPROPORTIONATE, ISN'T GIVING EVERYONE THE WHOLE PICTURE. LET'S DISCUSS WHAT INDIVIDUALS ON A FIXED INCOME, SOCIAL SECURITY WITH MEDICARE--YOU KNOW, THAT'S NOT COMPLETELY FREE--OR INDIVIDUALS UNDER THE CURRENT MARKETPLACE AND AFFORDABLE CARE ACT WITH THOSE RISING HEALTH INSURANCE PREMIUMS--FOR A FAMILY OF FOUR NEARLY \$500 A MONTH AT LEAST, AND THAT'S WITH A \$10,000 DEDUCTIBLE AND A COPAY--SO WHAT PERCENT OF OUR INCOME, PROPORTION OF OUR INCOME, IS THAT? ABUSING THIS. AND THAT CAN CERTAINLY COME FROM FEEDBACK FROM THE DOCTORS OR PHYSICIANS' ASSISTANTS, WHOEVER THEY GO TO SEE. SENATOR KRIST: THANK YOU, SENATOR HAAR. SENATOR SMITH, YOU ARE RECOGNIZED. [LB113]

SENATOR CHAMBERS: THANK YOU. MR. PRESIDENT, MEMBERS OF THE LEGISLATURE, IF YOU HAD SMART POLITICIANS, THEY WOULD HAVE READ THAT VOTE. SENATOR COASH IS SMART, BUT SOMETIMES SMART PEOPLE DO THINGS THAT ARE NOT SMART. CLEAR IN THE LEGISLATION WHO MAKES THAT DETERMINATION. AND WHEN THESE PRAYERS CAN BE UTTERED AND THEN THE CONDUCT DOESN'T SQUARE WITH WHAT THE PRAYER WAS, THEN I FEEL THOSE PRAYERS ARE IN VAIN BASED ON WHAT I WAS TAUGHT WHEN I WAS A CHILD ABOUT PRAYER. AND THEY GAVE ME A MEASURING ROD, BUT I'LL GIVE THAT THE NEXT TIME I SPEAK. IS THAT MY THIRD TIME, MR. PRESIDENT? [LB113]

SPEAKER HADLEY: NO, IT'S NOT. THAT WAS YOUR FIRST TIME, I BELIEVE, SENATOR. THANK YOU, SENATOR CHAMBERS. SENATOR BRASCH, YOU'RE RECOGNIZED. [LB113]

SENATOR BRASCH: THANK YOU, MR. PRESIDENT, AND THANK YOU, COLLEAGUES. I AM LISTENING VERY CLOSELY TO ALL OF THE THINGS THAT ARE BEING SAID HERE ON THE FLOOR. AS I MENTIONED, I CALLED AND SPOKE WITH TWO OF MY THREE SHERIFFS IN OUR DISTRICT. THERE ARE SOME GOOD ARGUMENTS BEING MADE ON WHY TO DO THIS, AND GOOD ARGUMENTS BEING MADE WHY NOT TO DO THIS. AND I'M SITTING HERE THINKING OVER MY LAST PAST SIX YEARS, I HAVE SERVED WITH SENATOR CHAMBERS FOUR OF THOSE YEARS. AND WE USED TO HAVE SOME CONVERSATIONS ON THE FLOOR ABOUT WHETHER HE HAS A HEART OR NOT. SENATOR CHAMBERS, WILL YOU YIELD TO A QUESTION, PLEASE? [LB113]

SPEAKER HADLEY: SENATOR CHAMBERS, WILL YOU YIELD? [LB113]

SENATOR CHAMBERS: EVEN THOUGH I'M A HEARTLESS PERSON, YES, I WILL. [LB113]

SENATOR BRASCH: THANK YOU, SENATOR CHAMBERS. AND I'M NOT SPEAKING OF THE HEART IN THE PHYSICAL PRESENCE. I KNOW ALL OF YOUR PHYSICAL BEING IS THERE. BUT I AM TALKING ABOUT HEART IN THE SENSE OF FEELINGS,

COMPASSION, TENDERNESS, CARING. SO DO YOU BELIEVE IN THAT SENSE YOU HAVE A HEART? [LB113]

SENATOR CHAMBERS: NO. [LB113]

SENATOR BRASCH: YOU DO NOT. [LB113]

SENATOR CHAMBERS: NO. [LB113]

SENATOR BRASCH: NO. AND SO ANY ACTIONS YOU DO FOR OTHERS, EVEN FOR THESE INMATES, IS IT A MATTER OF...CAN YOU DESCRIBE WHY YOU ARE PLEADING FOR THEM? I HEARD YOU MENTION GRANDMOTHERS, THOSE... [LB113]

SENATOR CHAMBERS: INTELLECT. MY INTELLECT TELLS ME THAT WHEN THINGS ARE OUT OF KILTER SOMETHING SHOULD BE DONE TO BRING IT BACK INTO KILTER. AND WHEN PEOPLE HAVE STUMBLED OR FALLEN, THEN THE ONLY WAY THEY'RE GOING TO BE PUT BACK IN KILTER IS TO HELP THEM BE UPRIGHT AND GIVE THEM A CHANCE TO START ALL OVER AGAIN. SENATOR CHAMBERS: THERE IS A DIFFERENT PART OF MY BRAIN THAT COMES INTO PLAY WHEN CHILDREN ARE INVOLVED BECAUSE CHILDREN ARE ONLY CHILDREN, NO COLOR, NO RELIGION, NO IDEOLOGY, AND THEY REMAIN SO UNTIL THEY BECOME CORRUPTED BY ADULTS. SO I SEE ALL CHILDREN AS THE SAME, AND I WANT TO DO WHAT I CAN TO MAKE SURE, TO THE EXTENT I CAN, THAT THEY REMAIN IN KILTER. [LB113]

SENATOR BRASCH: SENATOR CHAMBERS, PLEASE ANSWER YES OR NO. DO YOU LOVE CHILDREN? [LB113]

SENATOR CHAMBERS: THE WORD "LOVE" IS A WORD I DON'T APPLY TO MYSELF. [LB113]

SENATOR BRASCH: IN THE SENSE THAT THE REST OF THE WORLD USES THE WORD "LOVE," WOULD YOU... [LB113]

SENATOR CHAMBERS: NO, I DON'T APPLY THE... [LB113]

SENATOR BRASCH: YOU DO NOT. [LB113]

SENATOR CHAMBERS: ...ANYTHING THAT THE REST OF THE WORLD DOES. [LB113]

SENATOR BRASCH: I JUST NEEDED SOME CLARITY ON THAT. BECAUSE WHEN I LOOK AT THIS SUBJECT I'M THINKING, WHEN IT COMES TO INCARCERATION, THE CRIME AND THE PUNISHMENT, THAT'S...AND WITHOUT BEING AN ATTORNEY, I BELIEVE THEY SHOULD BE IN BALANCE, THAT THAT IS WHAT OUR JUSTICE SYSTEM IS DESIGNED TO DO. AND ALSO WHEN I LOOK AT INCARCERATION, THAT'S PART OF THE PUNISHMENT. PEOPLE HAVE LOST THEIR FREEDOM. THERE'S A HIGH PRICE FOR FREEDOM. THEY'VE ALREADY LOST FREEDOM. AND THEN WHEN I ALSO LOOK AT INCARCERATION, I HAVE CONSTITUENTS WHO HAVE CONTACTED ME REGARDING THEIR... [LB113]

SPEAKER HADLEY: ONE MINUTE. [LB113]

SENATOR BRASCH: ...INCARCERATED LOVED ONES, AND THE BURDEN THAT THE FAMILY BEARS, THE BURDEN THAT THE INCARCERATED INDIVIDUAL BEARS. AND IN LOOKING AT THIS LEGISLATION, KNOWING THAT IT IS VOLUNTARY FOR THE COUNTIES TO IMPLEMENT IT, THERE IS A \$10 MAXIMUM, AND IF IT'S BEING USED AS A TOOL TO MAKE SURE THAT THE INMATES ARE NOT AS...AND I BELIEVE IT'S THE INMATES THAT DESCRIBE THIS. ACCORDING TO THE SHERIFF, THEY KITE. THEY WRITE A NOTE TO FLY OUT OF THE JAIL AND THEN TO FLY BACK IN. AND THAT'S A METHOD THAT MAY BE USED TO PREVENT THAT. AT THIS POINT I'M STILL LOOKING AT...I BELIEVE THAT IT IS HARMLESS LEGISLATION IN THE SENSE THAT IT MAY NOT BE IMPLEMENTED. [LB113]

SPEAKER HADLEY: TIME, SENATOR. [LB113]

SENATOR BRASCH: THANK YOU, MR. PRESIDENT. [LB113]

SPEAKER HADLEY: THANK YOU, SENATOR BRASCH. SENATOR KRIST, YOU ARE <u>RE</u>COGNIZED. [LB113]

SENATOR KRIST: THANK YOU, MR. PRESIDENT, AND ONCE AGAIN GOOD MORNING, COLLEAGUES, AND GOOD MORNING, NEBRASKA. I JUST WANTED TO PUT SOMETHING ON THE RECORD. THERE'S BEEN A DISCUSSION ABOUT INMATES AND BEING PAID OR NOT BEING PAID. INMATES WHO ARE ON WORK RELEASE GET PAID AT LEAST THE MINIMUM WAGE. AND IN SOME CASES IT COULD BE MORE. WORK RELEASE INMATES MUST WORK AT LEAST 32 HOURS A WEEK AND PAY RENT TO THE STATE OF \$300 A MONTH. INMATES WHO ARE ON WORK DETAIL GET PAID \$1.21 TO \$3.78 AN HOUR, AND MANY OF THE COUNTIES DO NOT HAVE A WORK PROGRAM. AND THAT, ESSENTIALLY, IS WHAT I HEARD IN COMMITTEE AND YOU'LL NOTICE THAT MY VOTE WAS NOT TO ADVANCE OUT OF THE COMMITTEE. AT LAST REPORT, AND I THINK THIS IS IMPORTANT NOT JUST FOR THIS SUBJECT MATTER BUT ALSO FOR YOU TO TAKE IN MIND WITH THE OVERCROWDED PRISON SITUATION THAT WE HAVE, SOME OF OUR COUNTIES ARE PICKING UP A LOAD IN TERMS OF OUR PRISONERS, STATE PRISONERS, BEING IN THE COUNTY. AND I THINK YOU'D BE SURPRISED TO KNOW THAT IN THAT CONTRACT THAT THEY'RE PAID \$3.78 A DAY. SIX DAYS A WEEK. MAXIMUM AMOUNT, JUST TO BE PLACED IN THOSE COUNTY JAILS. I THINK YOU'D ALSO BE SURPRISED TO KNOW THAT THAT AMOUNT OF MONEY IS APPROXIMATELY A QUARTER OF A MILLION, \$235,000 AND CLIMBING. SO THERE IS A PUSH, I THINK, IN MY MIND, TO TRY TO RECTIFY THAT SITUATION IN TERMS OF THE JAIL POPULATION, THE PRISON POPULATION. THESE INMATES ARE PAID THE HIGHEST AMOUNT IN PART BECAUSE THE PHONE CALLS, COMMISSARY ARE SO MUCH HIGHER. FOR EXAMPLE, A CALL IN LANCASTER COUNTY COSTS AN INMATE \$1.50, \$1.50 TO MAKE A CALL IN LANCASTER COUNTY, WHILE IN HALL COUNTY IT COSTS \$15, \$15 TO MAKE A CALL IF YOU'RE AN INMATE. COUNTY JAILS ARE PAID \$75 TO \$88 A DAY. IT DEPENDS UPON THE SIZE OF THE COUNTY. AND THAT AMOUNT OF MONEY WOULD EQUAL \$6.5 MILLION, \$6,424,000. I THOUGHT THAT WOULD BE INTERESTING DETAIL TO INJECT INTO THE SITUATION. I, AGAIN, DID NOT SUPPORT THIS COMING OUT OF COMMITTEE, AND I WILL CONTINUE TO SUPPORT FOR WHATEVER MOTION TAKES THIS OFF THE SCHEDULE SO WE CAN GET ON TO SENATOR JOHNSON'S BILL, WHICH IS NEXT ON THE AGENDA. AND WITH THAT, I'D YIELD THE BALANCE OF MY TIME TO SENATOR CHAMBERS. [LB113]

SPEAKER HADLEY: SENATOR CHAMBERS, YOU'RE YIELDED 2:00. [LB113]

SENATOR CHAMBERS: THANK YOU. THANK YOU, SENATOR KRIST. THANK YOU, MR. PRESIDENT. WHAT'S HAPPENING HERE IS NOT ANYBODY'S FAULT. SENATOR LARSON HAD A SHERIFF TELL HIM SOMETHING WAS GOING ON, ONE SHERIFF. SO WE, AS A LEGISLATURE, ARE ASKED TO FORMULATE A POLICY FOR ONE SHERIFF

WHO COMPLAINED, AND THAT SHERIFF DIDN'T EVEN SHOW UP AT THE COMMITTEE.
