The State Patrol, Lancaster County Sheriff's Office, and the City of Imperial all estimate no fiscal impact from this bill.

The City of Lincoln also estimates no fiscal impact if the city is able to utilize its Public Service Officers to tow vehicles from private property, as it does now. The city notes that the bill requires law enforcement officers to tow vehicles and this would result in a fiscal impact of approximately \$80,000 for one police officer. Explanation of Estimate:

LPD estimates this bill would have no fiscal impact if the City could utilize its Public Service Officers, rather than law enforcement officers, as the City does now to tow vehicles from private property. The bill, however, requires law enforcement officers to do so, which LPD estimates will result in a fiscal impact of approximately \$80,000 for one police officer. If the language were revised to allow a commissioned or non-commissioned police employee to tow vehicles from private property, there would be no fiscal impact on the City of Lincoln.
