- A BILL FOR AN ACT relating to the Interstate Civil Defense and Disaster
 Compact; to amend sections 81-829.47, 81-829.52, and 81-829.56,
 Reissue Revised Statutes of Nebraska; to change provisions relating
- 4 to emergency response agreements with other states; to withdraw from
- 5 the Interstate Civil Defense and Disaster Compact; to harmonize
- 6 provisions; to repeal the original sections; and to outright repeal
- 7 section 1-109, Appendix, Reissue Revised Statutes of Nebraska.
- 8 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 81-829.47, Reissue Revised Statutes of Nebraska,

- 2 is amended to read:
- 3 81-829.47 (1) If the Governor finds that two or more adjoining
- 4 counties would be better served by an interjurisdictional emergency
- 5 management arrangement than by maintaining separate emergency management
- 6 organizations and services, the Governor he or she may delineate by order
- 7 or regulation an interjurisdictional area adequate to plan for, prevent,
- 8 or respond to a disaster, emergency, or civil defense emergency in that
- 9 area and direct such steps to be taken as are necessary, including the
- 10 creation of an interjurisdictional emergency management relationship, a
- 11 joint emergency operations plan, mutual aid, or an interjurisdictional
- 12 emergency management organization. A finding of the Governor pursuant to
- 13 this subsection shall be based on one or more factors related to the
- 14 difficulty of maintaining an efficient and effective disaster prevention,
- 15 mitigation, preparedness, response, and recovery and emergency management
- 16 system without such interjurisdictional arrangement, such as:
- 17 (a) Small or sparse population;
- 18 (b) Limitations on public financial resources severe enough to make
- 19 maintenance of separate emergency management organizations and services
- 20 unreasonably burdensome;
- 21 (c) Unusual vulnerability to disaster, emergency, or civil defense
- 22 emergency as evidenced by past history, topographical features, drainage
- 23 characteristics, potential for disaster, emergency, or civil defense
- 24 emergency, and presence of facilities or operations prone to disaster,
- 25 emergency, or civil defense emergency;
- 26 (d) The interrelated character of the counties in a multicounty
- 27 area; or
- 28 (e) Other relevant conditions or circumstances.
- 29 (2) If the Governor finds that a vulnerable area lies only partly
- 30 within this state and includes territory in another state or states and
- 31 that it would be desirable to establish an interstate relationship,

- 1 mutual aid, or an interstate emergency management organization, the
- 2 Governor he or she shall take steps to that end as desirable. If this
- 3 action is taken with jurisdictions that have enacted the **Emergency**
- 4 Management Assistance Compact Interstate Civil Defense and Disaster
- 5 Compact, any resulting agreements may be considered supplementary
- 6 supplemental agreements pursuant to Article VII 6 of that compact.
- 7 (3) If the other jurisdictions with which the Governor proposes to
- 8 cooperate pursuant to subsection (2) of this section have not enacted the
- 9 compact, the Governor he or she may negotiate special agreements with the
- 10 jurisdictions. Any agreement, if sufficient authority for the making
- 11 thereof does not otherwise exist, shall become effective only after its
- 12 text has been communicated electronically to the Legislature and if the
- 13 Legislature has not disapproved it prior to adjournment of the next
- 14 session competent to consider it or within thirty days of its submission,
- 15 whichever is later.
- Sec. 2. Section 81-829.52, Reissue Revised Statutes of Nebraska, is
- 17 amended to read:
- 18 81-829.52 Upon orders of the Governor, the Adjutant General is
- 19 authorized to establish such number of state emergency response teams as
- 20 may be necessary to reinforce emergency management organizations in
- 21 stricken areas and with due consideration of the plans of the federal
- 22 government and of other states. The Adjutant General shall appoint a team
- 23 leader for each team who shall have primary responsibility for the
- 24 organization, administration, and operation of such team. The team leader
- 25 shall keep and maintain a roster of members of the team, and only such
- 26 persons whose names appear on the roster shall be deemed members of such
- 27 team and entitled to the benefits provided by section 81-829.53. No
- 28 political subdivision shall be entitled to reimbursement as provided in
- 29 section 81-829.54 unless the individual on whose behalf reimbursement is
- 30 sought was duly enrolled on the roster as provided in this section at the
- 31 time the obligation was incurred. State emergency response teams shall

- 1 perform their functions in any part of the state or, upon the conditions
- 2 specified in mutual aid plans and emergency management agreements, in
- 3 accordance with the Emergency Management Assistance Compact Interstate
- 4 Civil Defense and Disaster Compact, and in this section, in other states.
- 5 Sec. 3. Section 81-829.56, Reissue Revised Statutes of Nebraska, is
- 6 amended to read:
- 7 81-829.56 (1) The State of Nebraska This state hereby withdraws from
- 8 enacts into law and enters into the Interstate Civil Defense and Disaster
- 9 Compact pursuant to Article 13 of such compact with all states bordering
- 10 this state which have enacted or shall hereafter enact the compact in the
- 11 form substantially as adopted in this state.
- 12 (2) The Governor may enter into the compact with any state which
- 13 does not border this state if he or she finds that joint action with the
- 14 state is desirable in meeting common intergovernmental problems of
- 15 emergency disaster planning, prevention, response, and recovery.
- 16 (3) Nothing in subsections (1) and (2) of this section shall be
- 17 construed to limit previous or future entry into the Interstate Civil
- 18 Defense and Disaster Compact of this state with other states.
- 19 (2) (4) If any person holds a license, certificate, or other permit
- 20 issued by any state or political subdivision thereof evidencing the
- 21 meeting of qualifications for professional, mechanical, or other skills,
- 22 the person may render aid involving that skill in this state to meet an
- 23 emergency or disaster, and the State of Nebraska this state shall give
- 24 due recognition to the license, certificate, or other permit.
- 25 (3) The (5) In addition to the Interstate Civil Defense and Disaster
- 26 Compact, the Governor may enter into, and execute on behalf of the State
- 27 of Nebraska, mutual aid agreements or emergency preparedness compacts
- 28 with other states. Any such agreement or compact shall provide for
- 29 reimbursement of all costs incurred by the State of Nebraska for actions
- 30 taken in another state, for indemnification of the State of Nebraska and
- 31 its employees against all claims, costs, or fees arising from actions

- 1 taken in another state, and for termination of the agreement or
- 2 assistance as necessary to meet disasters, emergencies, or other needs of
- 3 the State of Nebraska. Any mutual aid agreement or emergency preparedness
- 4 compact other than the Emergency Management Assistance Compact that
- 5 Interstate Civil Defense and Disaster Compact which does not meet the
- 6 requirements specified in this subsection shall be submitted
- 7 electronically to the Legislature for approval by the Legislature before
- 8 <u>such agreement or compact</u> it can become effective.
- 9 Sec. 4. Original sections 81-829.47, 81-829.52, and 81-829.56,
- 10 Reissue Revised Statutes of Nebraska, are repealed.
