After the opening statement, you will hear from supporters of the bill; then from those in opposition, followed by those speaking in a neutral capacity. LOWE: Welcome, Senator Aguilar, to your Executive Board.

AGUILAR: Good afternoon, Vice Chair Lowe and members of the Executive Board. My name is Senator Ray Aquilar, R-a-y A-g-u-i-l-a-r. I represent the 35th Legislative District. I introduced LB909 in my capacity as Chair of Exec Board, and the bill is designed to clarify agency reports filed with the Executive Board's Chair Office. In 2018, the Legislature passed the Occupational Board Reform Act, commonly referred to as the OBRA. The goal of OBRA was to create a process for ongoing review and analysis of occupational regulations, which reviews assigned to the 14 standing committees of the Legislature. One aspect of OBRA that members may not-- may be aware-- unaware of is the fact that if there is any occupational regulations pending before a state agency, they must have been adopted and promulgated -- the state agency must report these regulations to the Exec Board on or before July 1 of each year. The current language in statute is somewhat confusing, with agencies regularly interpreting the language to require reporting all pending regulations, not just occupational regulations under OBRA. LB909 would clarify the language so that only those rules and regulations considered an occupational regulation under OBRA must be reported to the Exec Board. I would be happy to answer any questions at this time.

LOWE: Thank you, Chair Aguilar. Are there any questions at this time? Seeing none, you got off easy. Are there any proponents? Any opponents? Anybody in the neutral? Senator Aguilar waives closing. Senator Aguilar, welcome back. We're now going to hear-- oh, sorry. There was no online testimony. Senator Aguilar, you're welcome to open on LB908.

AGUILAR: Good afternoon, Vice Chairman Lowe and members of the Exec Board. My name is still Ray-- Senator Ray Aguilar, and I represent the 35th Legislative District. I introduce LB908 in my capacity as Chair of the Exec Board. And the bill is designed to clean up the statutes governing the Legislature. Before cell phones, it was common practice for members of the Legislature to need a way to contact their home or office without running afoul of the prohibition on improper use of government resources. In 1994, the then-Chair of the Exec Board brought a bill to authorize the Exec Board to adopt policies for the installation of private phone lines and fax machines in senators' offices and Executive Board policy on private phone lines was in place starting in 1994. But no senator has elected to install a private phone or fax machine since 2007. In December of 2022, the Exec Board adopted a series of cleanup changes to the Legislative Policy Manual, including repealing the private phone lines policy. LB908 would outright repeal the section of statute authorizing the Exec Board to adopt a private phone line policy, as this authorization is no longer necessary. I would be happy to answer any questions at this time.
