KELLY: Good morning, ladies and gentlemen. Welcome to the George W. Norris Legislative Chamber for the first day of the One Hundred Eightieth [SIC] Legislature, Second Session. Our chaplain for today is Speaker Arch. Please rise.

ARCH: Let us pray. Dear God, our father, you have written in Psalm 90, verse 12 through your prophet Moses: So teach us to number our days that we may get a heart of wisdom. Our days are numbered, Father. We have 60 days as we approach this session. So we ask that you would give us a heart of wisdom that we might make decisions that please you and do what is best for the citizens of Nebraska. Father, we also pray, as you have written in Psalm 90, verse 17: Let the favor of the Lord, our God, be upon us and establish the work of our hands upon us. Yes, establish the work of our hands. We are totally dependent upon you to accomplish this. In your son's holy name, amen.

KELLY: Thank you, Speaker Arch. We'll now have the presentation of the colors from the Nebraska State Patrol Headquarters Troop Honor Guard.

KELLY: Thank you, Mr. Clerk. Senator Hughes would like to recognize the physician of the day, Dr. Hotovy of York, Nebraska. Please stand and be recognized by your Nebraska Legislature. Mr. Clerk, other messages, reports, or announcements?

President: Senator Jacobson has prioritized LB31. Senator Conrad has prioritized LB16 as a personal priority. Senator Kauth has prioritized LB575 as a personal priority. Senator Arch has designated LB461 as his personal priority. Senator Brandt has designated LB61 as his personal priority. And LB78, LB308 and LB664 are three of the Speaker priority bills for this session, Mr. President.

KELLY: Thank you, Mr. Clerk. We will now proceed to the election of the Chairperson of the Executive Board. The Chair recognizes Senator Holdcroft.

HOLDCROFT: Mr. President, I move to proceed to the election of the Chairperson of the Executive Board of the Legislative Council.

KELLY: Members, please find your seats. The motion before you is the motion to proceed with the election of the Chair of the Executive Board. All those in favor say aye. All those opposed say nay. The motion is adopted. Senator Aguilar, you're recognized to speak.

AGUILAR: Good morning, colleagues. I rise today to nominate myself to serve as Chair of the Executive Board. As the longest tenured member of the body, I believe that I have the experience and insight necessary to continue serving as Executive Board Chair. I have previously served as Vice Chair of the Executive Board and have been serving as Acting Chair following Senator Brieese's departure. During my previous service in the Legislature, I also served as Chair of the Government, Military and Veterans Affairs Committee. The Executive Board, and specifically the Executive Board Chair, is tasked with supervising all legislative services and employees and basically serves as the internal management of the Legislature. As Acting Chair for the past two months, I have been working directly with Executive Board and division staff, and I am committed to continuing to support and lead the institution in a nonpartisan manner going forward. I humbly ask for your vote and your support.

KELLY: Thank you, Senator. Are there any further nominations? Senator Cavanaugh, you're recognized to speak.

M. CAVANAUGH: Thank you, Mr. President. Good morning, colleagues. As we all know, an uncontested chairmanship race means we vote by unanimous consent. And so there's been a lot of conversation about how we want to have clear and transparent elections of chairmanships. And I think not voting by unanimous consent is a good start. So the only way to force that this morning is to run for Chair of the Executive

Board. While I do think that I have the qualifications to run for Executive Board and to be the Chair of the Executive Board, I am purely nominating myself so that we actually have a vote for the chairmanship. It is not because I don't believe in Senator Aguilar's qualifications. I just don't believe in us continuing to vote for these crish-- critical positions without taking an actual vote. Thank you, Mr. President.

KELLY: Thank you, Senator Cavanaugh. Are there any additional further nominations? Seeing none, the Chair declares that nominations are closed. Seeing no further nominations, members will be distributed ballots. Members, please mark your ballots. The Clerk and Assistant Clerks will come and collect those ballots. Senator Sanders, Senator Lowe, and Senator Holdcroft, would you be counters? Members, members, could you find your seats and assist the Clerks? Please return to your seats and assist the Clerk and staff in collecting the ballots. Thank you. Senator Aguilar has been elected Chair of the Executive committee by a majority of the members. Congratulations. We'll move on to the election of the Vice Chair of the Executive Board. Senator Bostelman, you're recognized. Senator Bosn, you're recognized for a motion.

BOSN: Thank you, Mr. President. I move to proceed to the election of the Vice Chair of the Executive Board of the Legislative Council.

KELLY: The motion before you is to proceed with the election of the Vice Chair of the Executive Board. All those in favor say aye. All those opposed say nay. The motion is adopted. Senator Lowe, you're recognized.

LOWE: Thank you, Mr. President. I rise today to ask for your vote to be the next Vice Chair of the Executive Board. I have served on the Executive Board for the last three years in, in the Legislature. During my time on the Executive Board, I have helped the board deal with numerous challenging circumstances. I have been deliberative member of the board, as we con-- consistently dealt with management of the institution and its processes. I have appreciated the work of the legislative staff who have provided guidance through the bill referencing process, legal challenges, and administrative matters. I have always and will continue to work to protect the institution of the Legislature and ensure that we will faithfully represent the interests of the people of Nebraska. As Chair and Vice Chair of the General Affairs Committee over the past five years, I have learned how important it is to work with my committee members and all senators, as well as other entities to come to the decision that will work for all.

During my time as Vice Chair, we passed many pieces of meaningful legislation that promote and protect the state's concerns, as well as promoting private businesses. I always strove to be fair and impartial with all my colleagues and will continue to be dedicated to these principles if chosen as Vice Chair of the Executive Board. Because the committee meets over the lunch hour, it will not interfere with my duties in the General Affairs Committee. If elected as Vice Chair of the Executive Board, I am firmly and committed to making Nebraska Legislature the best in the country. I ask for your vote at this time.

KELLY: Thank you, Senator Lowe. Are there any further nominations? Senator McKinney, you're recognized to speak.

McKINNEY: Thank you, Mr. President. I rise to nominate myself as Vice Chair of the Executive Board. I rise because I believe that we should have a diversity of voices on the Executive Board, especially considering that if Senator Lowe was elected, the eastern side of the state wouldn't have a voice as far as president and vice, vice pres-- Chair and Vice Chair of the Executive Board. Also think that going into this year, the Executive Board is going to deal with a lot of important issues that I think affect many of us. And I think especially around issues with the Inspector General and Ombudsman we should have diversity of voices because a lot of those issues impact communities like mine more than others disproportionately. And I'm committed to holding up this institution as best as possible and doing what's right for Nebraskans and I ask for your vote. Thank you.

KELLY: Thank you, Senator McKinney. Are there any further nominations for Vice Chair? Senator Wayne, you're recognized.

WAYNE: Thank you. I'd like to nominate myself for Vice Chair.

KELLY: Thank you, Senator Wayne. Are there any further nominations for Vice Chair of the Executive Board? Seeing no hands, we'll proceed to the vote and the Clerk will distribute ballots. And the three nominees: Senator Lowe, Senator McKinney. Senator Wayne.

WAYNE: I didn't know that was my time to give a speech. We closed nominations first and then Aguilar spoke. But that was my-- so do I get to give a speech or not?

KELLY: Yes, Senator. You-- you're recognized to speak.

WAYNE: Thank you. Sorry. Colleagues, my first year here, there was an uncontested hearing or a chair. And that senator talked for about an

hour. So go ahead and relax. I brought my binder and we'll start with the early parts of my life here in Nebraska. I'm just joking, Senator Arch. Don't worry about it too much yet. But I do think it's important when we're talking about leadership, that we talk about people who can study the issues and work tirelessly. And for the conservatives in the room, I want to remind you that Senator Lowe and Senator Chambers sang a duet back and forth on the floor my first freshman year so I think that disqualifies him automatically. I do believe you should have somebody who will work tirelessly, who will spend hours after hours working on the issues. And to me, the most important thing about this institution is to make sure that you can build relationships across party lines, different ideologies can come together to make sure we can manage this institution. And that is why I'm supporting Senator McKinney. I withdraw my nomination.

KELLY: The nomination is withdrawn. Are there any further nominations for Vice Chair of the Executive Board? Seeing no hands, I'll ask the Clerk's Office and staff to distribute the ballots. The nominees are Senator Lowe and Senator McKinney. Senators Hughes, Dungan and John Cavanaugh, could you come forward and serve as the vote counters? Senator Lowe has been elected Vice Chair of the Executive Board. Congratulations. Speaker Arch, you're recognized.

ARCH: Thank you, Mr. President. Next on the agenda is the Third District Caucus appointment for the replacement. And so to facilitate that, the body will stand at ease for just a few minutes while the Third District Caucus meets and identifies their appointment. Thank you.

KELLY: Thank you, Speaker Arch.

KELLY: Senator Walz, you are recognized for a motion.

WALZ: Thank you, Mr.-- thank you, Mr. President. I move to proceed to the election of the Third Caucus member of the Executive Board of the-- of the Legislative Council.

KELLY: Mr. Clerk.

CLERK: Mr. President, a communication from Senator Lowe. The Third District Caucus has elected Senator Mike Jacobson as the newest member of the Third District Caucus representation on the Executive Board.

KELLY: All those in favor of the nominee say aye. Those opposed say nay. The nominee is elected. Senator Bostar for a motion.

BOSTAR: I move the approval of the nominee to the Executive Board of the Legislative Council.

KELLY: All those in favor say aye. Those opposed, nay. Motion carries. Proceed-- we'll proceed to the introduction of new bills. Please bring your new bills forward. Speaker Arch, you're recognized for an announcement.

ARCH: Well, good morning, colleagues. If I could have your attention for just a moment. I want to welcome everybody to the Second Session of the One Hundred Eighth Legislature and a special welcome to Senator Fred Meyer. You have the prime seat up front in the middle. So congratulations and welcome. Well, I hope everyone's interim was restful and you come back with batteries recharged, ready to go. And for those of you who are experiencing your first short session, I am-- I have been asked, what's the difference? What's the difference between a long session and a short session? And I remember my first short session, I asked Senator Howard, who was my mentor at that time, I said, So what's the difference? And she laughed. And she says, you now have 60 days to complete 90 days of work. And that's what we'll be doing. It's a short session. We have a lot of work to do. But honestly, I'm looking at this as an opportunity, 60 days of opportunity. That's what we have in front of us. There's only 49 of us in a state of 2 million that has the opportunity that we have. So I want to enumerate some of those opportunities that we have. Number one, we have the opportunity to strengthen the institution. This is a real-- a real opportunity in front of us. I presented some proposals at our Legislative Council that I think would strengthen the institution. Some of you have ideas as well on how we can strengthen the institution, and I'm very interested in hearing those. We'll have more discussions about that over this session. We certainly have the opportunity to work together to make the state of Nebraska stronger. That is-- that is the prime opportunity that we have and our agenda will be set by your priority bills. Choose them wisely to have the greatest impact on the greatest number of people. We only have 60 days. We can't do everything so we need to consider the greatest impact. Third, to those of you who are in your last year before you term limit out, I would encourage you to mentor those who are following you. Term limits have a real impact on our Legislature. Some of you have developed a high level of skill as a senator and hopefully we've all gathered some wisdom along the way. Please purposefully pass

that on to those who will need to step into leadership quickly. Others did that for us and it was extremely valuable. And next, the other opportunity is to show the nation how a legislature can function. In my meetings over the summer with speakers from other states, we're all dealing with similar dynamics in our legislatures. As a representative form of government, we should not be surprised that we find division within our body. Our society is divided. But what we must develop is the ability to have passionate but civil discourse on very difficult subjects. That's going to take everyone's commitment to work together to craft legislation that allows the majority to govern, however you define majority, with respecting minority input, however you define minority. My observation is that we've become too simple in our definitions of majority and minority. We always default to party affiliation, but we know that there are other definitions, not the least of which is urban and rural. Please keep this especially in mind when we come to our rules debate. Every time we vote no and a bill passes, we are in the minority by definition. We all find ourselves there. So the opportunity, I would say, to create a model for other states to study that demonstrates an effective and efficient political process that produces quality debate and a quality product. I believe the majority of our citizens are longing for this kind of leadership, and I believe we're capable of doing this. But what's it going to take? And I have four components. First, hard work. You know that being a legislator is hard work and it takes that, good legislative work. First of all, the bills; please work your bills. Go to the opposition to see if their concerns can be addressed before the bills get to the floor. Make the bill better. No one individual or one group, however you define the group, possesses all of the good ideas. Build support for your bills. Don't just roll it out and hope for the best. Know your bills. If you're the principal introducer, study your bills and content to be prepared to answer questions in committee and on the floor. Go find the answers. Your staff can educate you, but it's our responsibility to know the bill. Committees, work the bills in committee. Don't simply pass them out to the floor to work out the details. Private conversations can occur in committee, but when it comes to the floor. It's very difficult, nearly impossible to negotiate on the microphone. Debates: It's hard work to focus on the merits rather than devolving into personal attacks. Do your homework. Be prepared to clearly articulate your opposition or your support. It's hard work. Second, relationships. Spend time talking to each other, not just about each other, not just about policy. Find out each other's stories. Learn about each other as human beings. Go sit with people that you wouldn't normally relate to and welcome others when

they come to sit with you. Some of you spent time over the interim building more relationships, and I think that will pay off. And thank you for doing that. Third, respect for each other. As fellow travelers who don't possess all of the answers to our society's issues, we should-- we should respect our right to think differently from each other. Respect for the process: committee structure, rules, floor debate, personal priorities. And we know that the personal priorities is what sets our agenda so choose those carefully. For the institution: We have a treasure that is much easier to tear down than to build up. Our society must look to this institution to govern wisely with thoughtful professionalism and decorum. We must set the example so that our society respects the institution. Without respect for this institution, our society will eventually be ungovernable. Fourth, sacrifice. We've all sacrificed to be here. Some of you left careers. Some of you have made major financial sacrifices. Some of you left your homes and relocated to Lincoln during the session. We've all left families and relationships during the sessions, but there's even more sacrifice required. Sacrifice is defined as the loss of something valuable for the sake of a greater cause. As we debate policy this session, we may be asked to give up some of what we want for a greater cause, and that greater cause may be the institution itself. So my vision for this session, seize the opportunities before us. We have 60 days to do that. Let's work hard, build relationships, show respect for each other as we build a better Nebraska over the next 60 days. Thank you, Mr. President.

KELLY: Thank you, Speaker Arch. Mr. Clerk, are there any messages, reports, or announcements?

New bill, LB821 is by Senator Blood, a bill for an act relating to students; amends Sections 79-215 Revised Statutes Cumulative Supplement, 2022; change provisions relating to the preliminary enrollment in a school district by children of military families; requires any preliminary or advanced enrollment provisions of a school district apply to students with an individualized education program or students receive special education as prescribed; repeals the original section. LB822 introduced by Senator Blood is a bill for an act relating to public health; amend
