1           1. Strike the original sections and insert the following new  
2 sections:

3           **Section 1.** DEFINITION OF APPROPRIATION PERIOD.

4           For purposes of this act and any other legislative bill passed by  
5 the One Hundred Ninth Legislature, First or Second Session, which  
6 appropriates funds, FY2025-26 means the period July 1, 2025, through June  
7 30, 2026; FY2026-27 means the period July 1, 2026, through June 30, 2027;  
8 FY2027-28 means the period July 1, 2027, through June 30, 2028; and  
9 FY2028-29 means the period July 1, 2028, through June 30, 2029.

10          **Sec. 2.** APPROPRIATION LANGUAGE.

11          There are hereby appropriated, for FY2025-26 and FY2026-27, the sums  
12 set forth in this act to each agency for each program from the respective  
13 funds for the general operations of state government, postsecondary  
14 education, and state aid, except as otherwise appropriated.

15          **Sec. 3.** UNEXPENDED BALANCES AND CERTIFIED ENCUMBRANCES.

16          All General Fund appropriations existing on June 30, 2025, in excess  
17 of expended and certified encumbrance amounts are hereby lapsed unless  
18 otherwise provided. All Cash Fund and Revolving Fund appropriations  
19 existing on June 30, 2025, in excess of expended and certified  
20 encumbrance amounts are hereby lapsed unless otherwise expressly  
21 provided. All certified encumbrance amounts on June 30, 2025, and June  
22 30, 2026, are hereby reappropriated for FY2025-26 and FY2026-27,  
23 respectively, which amounts shall be in addition to the amounts shown in  
24 this act.

25          **Sec. 4.** REAPPROPRIATION OF BALANCE, FY2025-26 to FY2026-27.

26          In addition to the appropriations set forth in this act, there are  
27 hereby reappropriated all unexpended appropriation balances existing on

1 June 30, 2026, for FY2026-27, to the respective agencies, programs, and  
2 funds listed in this act, except as otherwise provided in this act.

3 **Sec. 5.** There are hereby reappropriated for each agency, program,  
4 and fund for FY2025-26 and FY2026-27, any appropriation by the One  
5 Hundred Seventh Legislature, First or Second Session, of the unexpended  
6 and unencumbered appropriation balances of the Federal Funds allocated to  
7 the State of Nebraska from the federal Coronavirus State Fiscal Recovery  
8 Fund pursuant to the federal American Rescue Plan Act of 2021, 42 U.S.C.  
9 802, as amended, unless otherwise indicated in this act and any other  
10 legislative bill passed by the One Hundred Eighth Legislature, First or  
11 Second Session. Such reappropriation shall retain any provided  
12 limitations established by the appropriating legislative bill unless  
13 otherwise indicated within this act and any other legislative bill passed  
14 by the One Hundred Eighth Legislature, First or Second Session.

15 **Sec. 6.** NEBRASKA ACCOUNTING SYSTEM MANUAL DEFINITIONS.

16 The definitions contained in the Nebraska Accounting System Manual,  
17 and any amendments thereto, on file with the Clerk of the Legislature,  
18 are hereby adopted by the Legislature as the definitions for this act,  
19 except as provided in section 7 of this act.

20 **Sec. 7.** LIMITATION ON SALARIES, WAGES, AND PER DIEMS.

21 (1) For purposes of this act, (a) SALARY LIMIT shall mean total  
22 expenditures for permanent and temporary salaries and per diems and (b)  
23 total expenditures for permanent and temporary salaries and per diems  
24 shall mean all remuneration paid to employees treated as taxable  
25 compensation by the Internal Revenue Service or subject to social  
26 security coverage, specifically including payments accounted for as  
27 vacation, holidays, sick leave, military leave, funeral leave, maternity  
28 leave, administrative leave, compensatory time, deferred compensation, or  
29 any other similar form, and amounts withheld pursuant to law, but  
30 excluding state contributions for social security, retirement, and  
31 employee insurance plans.

1           (2) Total expenditures for permanent and temporary salaries and per  
2 diems shall be limited to the amount shown except when federal funds in  
3 excess of the amount shown are available and approved by the Governor.  
4 Expenditures for permanent and temporary salaries and per diems from such  
5 grants shall be in addition to the limitation on permanent and temporary  
6 salaries and per diems otherwise shown in this act. No agency shall  
7 request any state funds for continuation or replacement of any such  
8 personnel or activities in future budget requests. To the extent  
9 feasible, requests for increases in the limitation on permanent and  
10 temporary salaries and per diems shall be addressed to the Appropriations  
11 Committee of the Legislature when the Legislature is in session.

12           (3) Expenditures for permanent and temporary salaries resulting from  
13 awards made to employees under sections 81-1346 to 81-1354 shall be in  
14 addition to the limitations on permanent and temporary salaries and per  
15 diems otherwise shown in this act.

16           (4) The limitation on expenditures for permanent and temporary  
17 salaries and per diems for FY2026-27 as enumerated in this act shall be  
18 the basis for continuation funding for each fiscal year of the succeeding  
19 biennium.

20           (5) The limitation on expenditures for permanent and temporary  
21 salaries and per diems for FY2025-26 shall be increased by certified  
22 encumbrance amounts from FY2024-25 for permanent and temporary salaries  
23 and per diems. The limitation on expenditures for permanent and temporary  
24 salaries and per diems for FY2026-27 shall be increased by certified  
25 encumbrance amounts from FY2025-26 for permanent and temporary salaries  
26 and per diems. Encumbered amounts shall be calculated in accordance with  
27 section 81-138.01.

28           (6) The limitation on expenditures for permanent and temporary  
29 salaries and per diems shall only apply to remuneration paid to state  
30 employees or per diem payments made to members of state boards or  
31 commissions.

1       (7) The budget administrator of the budget division of the  
2 Department of Administrative Services may administratively increase the  
3 limitation on expenditures for permanent and temporary salaries and per  
4 diems upon receipt of a request for such increase from the director of a  
5 state agency certifying the actual amount of the payment to a former  
6 employee of such agency, or such employee's beneficiary upon the death of  
7 the employee, of accumulated vacation and sick leave pursuant to section  
8 81-1325 and the rules and regulations of the State Personnel System  
9 governing such payments.

10       **Sec. 8. DRAWING AND PAYING WARRANTS.**

11       The Director of Administrative Services shall draw warrants upon the  
12 proper fund in the state treasury for an amount not to exceed the  
13 appropriations set forth in this act upon presentation of proper  
14 documentation. The State Treasurer shall pay the warrants out of the  
15 appropriate funds.

8           It is the intent of the Legislature that the total amount  
9 appropriated for medicaid nursing facility rates for Program No. 348,  
10 specified as \$449,351,518 for FY2025-26 (\$196,186,873 General Funds and  
11 \$253,164,645 Federal Funds) and \$449,351,518 for FY2026-27 (\$199,467,139  
12 General Funds and \$249,884,379 Federal Funds), shall be used in the  
13 medicaid nursing facility rate calculation for Program No. 348, including  
14 the calculation of the annual inflation factor.

15           The total amount appropriated for medicaid nursing facility rates  
16 for Program No. 348 includes amounts for rate enhancement and any other  
17 purpose related to medicaid nursing facility services. The Department of  
18 Health and Human Services shall file a report electronically with the  
19 Legislative Fiscal Analyst and the Clerk of the Legislature no later than  
20 August 1, 2025, on how the inflation factor was calculated for FY2025-26  
21 rates and no later than June 15 ~~August 1~~, 2026, on how the inflation  
22 factor was calculated for FY2026-27 rates.

23           The Department of Health and Human Services shall file a report  
24 electronically with the Legislative Fiscal Analyst and the Clerk of the  
25 Legislature between December 15 and December 31 of each year of the  
26 biennium ending June 30, 2027, identifying the amount of any unspent  
27 remaining appropriation from the prior fiscal year's appropriations  
28 earmarked for nursing facility payments. The report shall include an  
29 identification of encumbrances and retroactive payments.

30           There is included in the amount shown as aid for this program  
31 \$1,500,000 Cash Funds for FY2025-26 from the Hospital Quality Assurance

1 and Access Assessment Fund to the Department of Health and Human Services  
2 for the medical assistance program to provide reimbursement to mental  
3 health providers who do not practice in a hospital and who provide  
4 services to medicaid-eligible participants who are eligible for both  
5 medicaid and medicare, if there is a lower rate paid under medicare  
6 compared to rates paid at the time for medicaid rates for behavioral  
7 health services. It is the intent of the Legislature to sustain the  
8 medicaid rates for mental health providers serving medicaid-eligible  
9 participants who are eligible for both medicaid and medicare and are  
10 receiving behavioral health services under Program No. 348, Medical  
11 Assistance.

12 There is included in the amount shown as aid for this program  
13 \$1,408,364 Cash Funds for FY2025-26 and \$1,408,364 Cash Funds for  
14 FY2026-27 from the Medicaid Managed Care Excess Profit Fund for medicaid  
15 assisted-living facility rates for Program No. 348, to be used  
16 specifically by the Department of Health and Human Services to increase  
17 the current medicaid assisted-living facility rates, which are included  
18 in Program No. 348 and paid as a service as part of Nebraska's aged and  
19 disabled home and community-based medicaid 1915(c) waiver program, to the  
20 daily rate of \$73.91 for FY2025-26 and \$73.91 for FY2026-27, for both  
21 rural and urban assisted-living single occupancy waiver days.

22 It is the intent of the Legislature that phased-down state

27 Services may certify to the budget administrator of the budget division
