3           **Section 1.** Section 26-118, Revised Statutes Supplement, 2025, is  
4 amended to read:

5           26-118 (1) Any person, except the petitioner, who knowingly violates  
6 a protection order issued pursuant to the Protection Orders Act, after  
7 service or notice as described in subsection (4) of section 26-114, or a  
8 valid foreign protection order recognized pursuant to section 26-123 or  
9 26-124, shall be guilty of an offense and punished as provided in this  
10 section.

11           (2) For a violation involving a domestic abuse protection order, a  
12 sexual assault protection order, a valid foreign domestic abuse  
13 protection order recognized pursuant to section 26-123, or a valid  
14 foreign sexual assault protection order recognized pursuant to section  
15 26-124, a violation of this section is a:

- 16           (a) Class I misdemeanor for a first offense; and a  
17           (b) Class IV felony for a any second or subsequent offense; -  
18           (c) Class IIIA felony for a third offense; and  
19           (d) Class IIA felony for any fourth or subsequent offense.

20           (3) For a violation of a harassment protection order or a valid  
21 foreign harassment protection order recognized pursuant to section  
22 26-124, a violation of this section is a Class II misdemeanor for a first  
23 offense and a Class I misdemeanor for any second or subsequent offense.

8 the first aggressor. In a sexual assault case, reputation, opinion, or

13 (2) Evidence of other crimes, wrongs, or acts is not admissible to  
14 prove the character of a person in order to show that he or she acted in  
15 conformity therewith. It may, however, be admissible for other purposes,  
16 such as proof of motive, opportunity, intent, preparation, plan,  
17 knowledge, identity, or absence of mistake or accident.

18 (3) When such evidence is admissible pursuant to this section, in  
19 criminal cases evidence of other crimes, wrongs, or acts of the accused  
20 may be offered in evidence by the prosecution if the prosecution proves  
21 to the court by clear and convincing evidence that the accused committed  
22 the crime, wrong, or act. Such proof shall first be made outside the  
23 presence of any jury.

9 sexual arousal or gratification of either party. Sexual contact also  
10 includes the touching of a child with the actor's sexual or intimate  
11 parts on any part of the child's body for purposes of sexual abuse by a  
12 school worker under section 28-316.01 or sexual assault of a child under  
13 sections 28-319.01 and 28-320.01;

14 (6) Sexual penetration means sexual intercourse in its ordinary  
15 meaning, cunnilingus, fellatio, anal intercourse, or any intrusion,  
16 however slight, of any part of the actor's or victim's body or any object  
17 manipulated by the actor into the genital or anal openings of the  
18 victim's body which can be reasonably construed as being for nonmedical,  
19 nonhealth, or nonlaw enforcement purposes. Sexual penetration shall not  
20 require emission of semen;

21 (7) Victim means the person alleging to have been sexually  
22 assaulted;

23 (8) Without consent means:

24 (a)(i) The victim was compelled to submit due to the use of force or  
25 threat of force or coercion, or (ii) the victim expressed a lack of  
26 consent through words, or (iii) the victim expressed a lack of consent  
27 through conduct, or (iv) the consent, if any was actually given, was the  
28 result of the actor's deception as to the identity of the actor or the  
29 nature or purpose of the act on the part of the actor;

24 personnel, who is in a position to assist a person who is apparently  
25 experiencing or who is likely to experience an opioid-related overdose,  
26 other than an emergency responder or peace officer, is not subject to

28 criminal prosecution if the person, acting in good faith:

13 opioid-related overdose, unless the emergency responder caused damage or

8 elements and penalties for the offense of domestic assault and the  
9 penalties for the offense of assault by strangulation or suffocation; to  
10 transfer and change provisions relating to sexual abuse of an inmate or  
11 parolee; to provide immunity to probation employees for administration of  
12 opioid overdose reversal medication; to change provisions relating to the  
13 offense of possession of burglar's tools; to change provisions related to  
14 the offense of incest; to change the penalty for impersonating a police  
15 officer; to provide requirements relating to Brady-Giglio lists; to  
16 prohibit retaliation; to provide confidentiality for officers; to provide  
17 duties for prosecuting agencies and public safety agencies; to require  
18 registration under the Sex Offender Registration Act; to require courts  
19 to appoint county conflict counsel when the public defender is  
20 unavailable as prescribed; to change provisions relating to allowance of  
21 fees for counsel; to require courts to consider certain evidence in  
22 determining the best interest of the child; to change offenses included  
23 with certain victim notification requirements; to harmonize provisions;  
24 to provide operative dates; to provide severability; and to repeal the  
25 original sections."
