KELLY: Good morning. Welcome to the George W. Norris Legislative Chamber for the first day of the One Hundred Ninth Legislature, Second Session. Our chaplain for today is Senator Arch. Please rise.

ARCH: Let us pray. Father God, as your servants, we approach this session once again with great humility before you. We bow our heads in reverence to you, for you are God and we are not. We know that we will be discussing issues that will affect the lives of many, and we know that we do not possess within ourselves all that we need to fulfill our responsibilities to the citizens of this state. But we know you possess all that we need and that you are a giver of gifts, having sent your son to die on the cross for our sins. We can pray to you in faith, knowing that you are both a good God and one who hears the prayers of those who humble themselves before you. So we ask that you pour out your blessings on us by giving us all that we need to accomplish your will in our deliberations and our decisions throughout this session. Please, Father, as your humble servants, hear and answer this prayer. In Christ's name. Amen.

KELLY: Thank you, Senator Arch. We'll now proceed to have the presentation of colors from the Nebraska State Patrol Headquarters Troop Honor Guard. I recognize Senator Murman for the Pledge of Allegiance.

MURMAN: Please join me in the Pledge. I pledge allegiance to the Flag of the United States of America, and to the Republic for which it stands, one Nation under God, indivisible, with liberty and justice for all.

Senators Juarez and Guereca would like to announce some guests in the balcony today from the Black, Brown, and Red Coalition in Omaha. Please stand and be recognized by the Nebraska Legislature. Mr. Clerk, please record.

KELLY: Senator Conrad, you're recognized for an announcement.

CONRAD: Good morning, colleagues, and happy new year. On this first day of our historic legislative session, I am pleased to reaffirm our commitment to existing state law and to the observance of George W. Norris Day. Pursuant to Nebraska Revised Statutes, Statutes 84-104.04, which has been on the books since 1981 and was brought forward by my friend, Senator Tom Vickers, the state of Nebraska has designated this day as George Norris Day to hold suitable exercises and recognize his incredible contributions not only to our state, to this Unicameral, but to our country. As such, we have established a tradition wherein members who embody the spirit of nonpartisanship that George Norris and our citizens envisioned when creating this august institution, we've developed an opportunity to reaffirm our commitment to this by reciting selected portions of Norris's address to the first Unicameral Legislature. With that, I'd like to yield the remainder of my time to my good friend, Senator Merv Riepe, to do just that. Thank you.

KELLY: Thank you, Senator Conrad. Senator Riepe, you're recognized to speak.

RIEPE: Mr. President and members of this Legislature, Legislature: I congratulate you on being members of the first Unicameral Legislature. The opportunity that will come to you officially to better the conditions of our people by improving of the legislative machinery are very great. Your work will attract the attention not only of people of our great commonwealth, but of the entire country. Upon you and your work will be focused the eyes of all students of government all over the nation, and every professional lobbyist, every professional politician, and every representative of greed and monopoly is hoping and praying that your work will be a failure. Everything that special interest can do to embarrass you and to misrepresent or mispresent your actions will be attempted. On the other hand, every lover of his fellow man and every person who wants to place our state on a higher standard of efficiency, every person who is anxious to bring about improvement in our state affairs, every patriot, every wants-- to be-- who wants to be-- place our government on a higher level of good and ever-loving human liberty and equal justice, and every believer in the business administration of state affairs, as distinguished from political machine control, is hoping, praying, and believing that your official work will be crowned with limited success to the satisfaction and approval of believers in good government everywhere. Unicameral legislation amendment was adopted by an overwhelming majority of our people. The adoption of the amendment was opposed by lobbyists, by professional politicians of all parties, and by every person or corporation who expected to get an advantage, financial or otherwise. In securing the passage of legislation favorable to their ideas. Many honest people voted against the adoption of the amendment for one reason or another, which appeared adequate and sufficient, but they do expect and have the right to expect absolute honesty, unlimited courage, and reasonable degree of efficient and-- efficiency and wisdom. The people of Nebraska will not condemn you even if they do not agree with you or all of your official actions. We realize that honest men and women, patriotic men and women-- I've added those-- and wise men and women do not always agree. In fact, disagreement on things which are not fundamental is an-- is evidence of courage and independence. We expect an economic and efficient administration, and above all, an honest administration free from any partisan bias, political prejudice, or improper motives. You have an opportunity to render a service to your fellow citizens that no other legislature has ever had. I believe you will meet your responsibilities with courage and ability. From now on, Nebraska has a right to expect a business administration. Your work, your work will be watched to a great extent-- greater extent than the work of any legislature in the past. When you carry out the theory and the principles of the new amendment, it will be easy to observe everything you do. Publicly, to all, our acts will help to renew the faith and to punish those who do not follow the true spirit of the new amendment. That your work may be successful and it may receive the approval of all honest-minded citizens is not only my personal wish, but I believe it is the hope and desire of a great majority of the local citizens of Nebraska. Thank you, Mr. President.

KELLY: Thank you, Mr. Clerk. We'll proceed. Senator Hansen, you're recognized for a point of personal privilege.

HANSEN: Thank you, Mr. President. Mr. President, colleagues, I rise today to address a serious matter regarding the conduct of the Senator from the 41st Legislative District. As you're aware, a special personnel panel was formed to investigate a formal complaint of workplace harassment lodged against Senator McKeon. That investigation, conducted by outside counsel Tara Paulson, has concluded. Today, consistent with the unanimous recommendation of the Executive Board, we are taking several procedural steps. First, the full report detailing the findings of the investigation is being formally released to the Legislature at the conclusion of my remarks. Immediately following the release, the Executive Board is introducing a resolution to expel Senator McKeon from the Nebraska Legislature pursuant to Article 3, Section 10 of the Nebraska Constitution. I want to note for the record that Senator McKeon was provided with ample formal notice of these findings, the report, and this legislative process via letter, sent on January 5, 2026. It is the intention of the Referencing Committee to meet and refer this resolution to the appropriate committee prior to adjournment today. Assuming the resolution is referred to the Executive Board, it is our intent to hold a hearing on the resolution on Monday, January 12, 2026. This hearing will be limited to invited testimony only, specifically from Senator McKeon or his legal representative and the outside counsel who conducted the investigation, consistent with past practice. Because this timeline requires prompt action, if the resolution is referred to

the Executive Board, I intend to introduce a motion today to suspend the rule regarding 7 days' notice for a public hearing. This suspension is necessary to ensure the hearing can proceed on January 12 as scheduled. Thank you, Mr. President.
