**KELLY:** Thank you, Mr. Clerk. Senator Holdcroft would like to recognize some guests seated under both the north and south balcony. They're Nebraska Olympic, Paralympic, and Special Olympic athletes. Please stand and be recognized by the Nebraska Legislature. Senator Holdcroft, you're recognized for an announcement.

**HOLDCROFT:** Thank you, Mr. President. This morning, the Governor signed a proclamation for Nebraska-- all Nebraska to recognize our Olympians with the-- for-- in July and February, in preparation for the Olympics coming up, particularly the Winter Olympics that will be held in Italy. So today, I'm going to read briefly who is here today with us. Olympians: we have Thane Baker, who is the oldest living male United States Olympian medalist in track; we have Curt, Curt Tomasevicz, who is a gold and silver medalist in bobsledding; Dylan Travis, Team USA 3x3 basketball, in Paris in 2024; Paralympian Natalie Schneider, gold, silver, and bronze medalist in wheelchair basketball; and Special Olympians Wyatt Spalding and Haley Wagner. Thank you very much.

It requires reflection, listening, and learning. Accountability is not only acknowledging a mistake, but committing to grow from it. I take that responsibility seriously. I respect this institution and gravitating of the decision you are about to make. Each of you cares not only on your own judgment, but the trust of constituents and the integrity of this Legislature. This is a responsibility I hold in the highest regard. With deep prayer and careful discernment, I have come to the decision that I am resigning my position at this time. I do so with appreciation in this body and profound gratitude for the people of Nebraska whom I have been honored to serve. This decision is not made lightly, but with respect for the institution, my colleagues, and the responsibility that accompanies the public service. I leave with humility, reflection, and sincere hope that my departure allows this Legislature to move forward with unity, purpose, and integrity. Thank you for the privilege of serving and for the most seriousness with each of you care-- carry your duties on behalf of our state. God bless every which-- and one of you. And we need to make this state a great state, so let's do the right thing. Thank you.
