PRESIDENT: LB 621 passes on Final Reading. In order to ... we had the problem of that "A" bill not going along. The Chair understands that there is sentiment that it doesn't need an "A" bill. We'll go to General File then. The Chair would entertain a motion on 545A. Senator Kennedy.

SENATOR KENNEDY: I would move that we kill the "A" bill on 545A. We do have a copy here that there is no fiscal impact.

PRESIDENT: Alright. Any discussion? We're on General File now. We hope to go right back to Final Reading. The question is shall LB 545A be indefinitely postponed. Record your vote. Record.

CLERK: 29 ayes, 0 nays, 20 not voting, Mr. President.

PRESIDENT: The bill is indefinitely postponed. Mr. Clerk, we go back now to Final Reading. Please stay in your chairs for this final bill, Senators. Mr. Clerk, read, for the final time, LB 545. Would the Senators please take their chairs. This is the last bill on Final Reading.

CLERK: Read title to LB 545.

PRESIDENT: All provisions of law relative to procedure having been complied with, the question is, shall LB 545 pass. Record your vote. Record.

CLERK: Voting aye Senators Anderson, Barnett, Bereuter, Burbach, Burrows, Cavanaugh, Chambers, Clark, Cope, DeCamp, Dickinson, Dworak, Fowler, Goodrich, Hasebroock, Johnson, Kelly, Kennedy, Koch, Kremer, F. Lewis, R. Lewis, Luedtke, Mahoney, Maresh, Marvel, Mills, Moylan, Nichol, Rasmussen, Rumery, Simpson, Skarda, Stoney, Stull, Swigart and Warner.

Voting nay none.

Not voting Senators Carsten, Duis, Fitzgerald, George, Keyes, Kime, Marsh, Savage, Schmit, Syas and Wiltse.

Senator Syas voting aye. Senator Wiltse voting aye. Senator Savage voting aye. 41 ayes, 0 nays, 8 not voting, Mr. President.
