CLERK: I have no amendments to 635A, Senator.

SPEAKER WITHEM: Senator Bruning.

SENATOR BRUNING: I move LB 635A to E & R for engrossing.

SPEAKER WITHEM: You've heard the motion. All of those in favor say aye. Opposed. It is advanced. Mr. Clerk, do you have any items for the record?

CLERK: I do, Mr. President. Your Committee on Business and Labor, Chaired by Senator Abboud, reports LB 32, (LB) 548, (LB) 834, to General File; and (LB) 854 to General File with amendments. Government Committee reports (LB) 360, (LB) 361, (LB) 591, (LB) 636, (LB) 726, (LB) 768 to General File; and (LB) 378, (LB) 379 as indefinitely postponed. Those are signed by Senator Robinson. Judiciary Committee reports (LB) 23 to General File with amendments; (LB) 204, (LB) 373, to General File with amendments; (LB) 167, (LB) 217, (LB) 430, (LB) 480, (LB) 677 as indefinitely postponed. In addition, Mr. President, your Committee on Enrollment and Review reports they have examined and engrossed LB 128 and find the same correctly engrossed; (LB) 397, correctly engrossed. Enrollment and Review reports (LB) 248 to Select File. Judiciary Committee reports (LB) 465 to General File with committee amendments attached. New A bill, (LB) 248A, by Senator Schellpeper. (Read title.) I have a hearing notice from the Government, Military, and Veterans Affairs Committee. Health and Human Services reports (LB) 279 to General File with amendments attached. And amendments to be printed: Senator Janssen to (LB) 116; Senator Brashear to (LB) 362; Senator Chambers to (LB) 362; Senator Beutler to (LB) 273; Senator Beutler to (LB) 226; and Senator Beutler to (LB) 256, and to (LB) 887. Mr. President, Senator Coordsen would move to place LB 519 on General File notwithstanding the action of the Business and Labor Committee. That will be laid over. And a series of adds: Senator Witek to LB 23; Senator Jensen to (LB) 182; Senator Wesely, 182; Senator Hilgert, Stuhr, and Jensen would like to add their names to LB 23; Senator Abboud to (LB) 853; Senator Suttle would like to withdraw her name from (LB) 232.
