- 1 1. Insert the following new section:
- 2 "Sec. 3. Section 44-5242, Reissue Revised Statutes of
- 3 Nebraska, is amended to read:
- 4 44-5242. (1) Health benefit plan shall mean any hospital
- 5 or medical policy or certificate, major medical expense insurance,
- 6 or health maintenance organization subscriber contract.
- 7 (2) Health benefit plan shall not include one or more, or
- 8 any combination, of the following:
- 9 (a) Coverage only for accident or disability income
- 10 insurance, or any combination thereof;
- 11 (b) Coverage issued as a supplement to liability
- 12 insurance;
- 13 (c) Liability insurance, including general liability
- 14 insurance and automobile liability insurance;
- 15 (d) Workers' compensation or similar insurance;
- 16 (e) Automobile medical payment insurance;
- 17 (f) Credit-only insurance;
- 18 (g) Coverage for onsite medical clinics; and
- 19 (h) Other similar insurance coverage, specified in
- 20 federal regulations, under which benefits for medical care are
- 21 secondary or incidental to other insurance benefits.
- 22 (3) Health benefit plan shall not include the following
- 23 benefits if they are provided under a separate policy, certificate,
- 24 or contract of insurance or are otherwise not an integral part of

1 the plan:

2 (a) Limited-scope dental or vision benefits;

3 (b) Benefits for long-term care, nursing home care, home
4 health care, community-based care, or any combination thereof; and

5 (c) Such other similar, limited benefits as are specified
6 in federal regulations.

7 (4) Health benefit plan shall not include the following
8 benefits if the benefits are provided under a separate policy,
9 certificate, or contract of insurance, there is no coordination
10 between the provision of the benefits and any exclusion of benefits
11 under any group health benefit plan maintained by the same plan
12 sponsor, and such benefits are paid with respect to an event
13 without regard to whether benefits are provided with respect to
14 such an event under any group health plan maintained by the same
15 plan sponsor:

16 (a) Coverage only for a specified disease or illness; and

17 (b) Hospital indemnity or other fixed indemnity
18 insurance.

19 (5) Health benefit plan shall not include the following
20 if it is offered as a separate policy, certificate, or contract of
21 insurance:

22 (a) Medicare supplemental health insurance as defined
23 under section 1882(g)(1) of the Social Security Act;

24 (b) Coverage supplemental to the coverage provided under
25 10 U.S.C. ~~5501 et seq.~~ chapter 55, as such chapter existed on
26 January 1, 2003; and

27 (c) Similar supplemental coverage provided to coverage
