LB 569 amends Nebraska Statutes Section 4-114, dealing with use of the federal immigration verification system (e-verify).

The bill changes the statute to require all employers under the Nebraska Workers' Compensation Act to register with and use the everify system to determine work eligibility within the state. The Nebraska Workers' Compensation Act by statute (48-106) does not apply to certain employers therefore it is assumed the requirements of LB 569 would also not apply to those same employers.

Any employer who violates this requirement is guilty of a Class III misdemeanor.

The bill has an operative date January 1, 2012.

There is no fiscal impact to the state as a result of LB 569.
