This bill makes changes to a form for divorces and annulments that is required to be filed by county clerks with the Department of Health and Human Services. When information cannot be obtained, the county clerk would be able to indicate the information as being unknown. A payment of \$25 that the state may require the county to pay for incomplete forms is eliminated.

The state would have a loss of a minimal amount of revenue with the repeal of the \$25 payment that the state may assess for incomplete forms. The department indicates that a half-time position to obtain the information designated as unavailable. However, this bill would make it acceptable for the unavailable information to be designated as unknown and the form to be considered complete. It may be that Section 71-602 also needs to be amended to clarify that the changes to the form for annulments and divorces is considered as final and complete.
