LB 824 changes provisions related to certified renewable export facilities and exemption of certain privately developed renewable energy generation facilities.

Section 1 limits the power of eminent domain for power districts.

Section 2 eliminates definitions for "Certified renewable export facility" and "Stranded asset". The section also adds definitions for "Private electric supplier" and "Privately developed renewable energy generation facility".

Section 3 provides for exemption from sections 70-1012 to 70-1027 for privately developed renewable energy generation facilities and qualifications for such exemption.
