Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

This bill would require guidelines to ensure safety of minor or dependent whose parent or guardian is arrested.

The Department of Correctional Services (NDCS) estimates that the provisions of this bill will require a dedicated family services coordinator to develop the policies at a cost of \$69,974 per year. Implementing expanded physical contact for children during visits would also require NDCS to expand visiting hours from the current 5 days per week to 6 or 7 days per week to allow for separate family visiting hours. It is estimated this will require additional staff to cover the expanded visitation at an estimated cost of \$428,127 in FY18 and \$423,507 in FY19. Adding this estimated cost to the cost of the family services coordinator of \$69,974 equals a total cost of \$498,101 in FY18 and \$493,481 in FY19. See the agency response attached for additional details.

NDCS received additional funding in 2013 (\$250,000), increased in 2015 (\$315,000), for duties similar to what this bill requires. While this bill does expand those duties, it is not clear that such expansion requires the addition of all the staff that NDCS estimates it needs to comply with the provisions of this bill. If these additional costs do occur, they can be evaluated and considered for funding when the agency's budget is developed. No additional appropriation is provided at this time.

The Supreme Court estimates minimal fiscal impact to update training courses.

The State Patrol, Crime Commission, and the Department of Health and Human Services all estimate no fiscal impact from this bill.

The city of Imperial estimates a workload increase to establish the guidelines of \$1,000 in FY18. They estimate ongoing costs of \$200 per year for updates and review.

The City of Omaha estimates no fiscal impact from this bill.

The City of Lincoln estimates FY18 costs of \$120,000, and FY19 costs of \$126,000 for 1.5 Police Officers. See their response attached for additional details not included in this fiscal note.

COMMENTS: The City of Lincoln fiscal note on LB 108 indicates the potential need for 1.5 additional Police Officers to accommodate the impact from the provisions of the bill, at an annual cost of approximately \$120,000. Conversely, the City of Imperial only indicates potential cost of \$1,000 and the City of Omaha indicates No Fiscal Impact from LB 108. The City of Lincoln estimate appears high by contrast.

## **Explanation of Estimate:**

LB 108 requires the Department of Correctional Services to adopt policies related to children with incarcerated parents, including:

- Classification decisions shall consider the incarcerated person's ability to maintain contact with the child
- Adopting child friendly visitation policies, including permitting age appropriate physical contact throughout visitations for children under 13
- Encouraging communication between children and incarcerated parents
- To support visitation of an incarcerated parent by state wards

NDCS estimates that the provisions of LB 108 will require a dedicated family services coordinator to develop the policies required by LB 108 at a cost of \$69,974 per year. Implementing expanded physical contact for children during visits would also require the Department to expand visiting hours from the current 5 days per week to 6 or 7 days per week at our secure facilities (NSP, TSCI, LCC, OCC, NCCW) to allow for separate family visiting hours. It is estimated this will require 1-2 additional staff per facility to cover the expanded visitation at a cost of \$428,127 in FY18 and \$423,507 in FY19.
