Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 260 would establish a state food insecurity nutrition incentive grant program to be administer by the Department of Agriculture. The program would award state grants under the federal food insecurity nutrition incentive grant program to offset project startup and operational costs.

LB 260 provides legislative intent that \$150,000 General Funds be appropriated to the Department of Agriculture to carry out the program. The Department of Agriculture assumes an annual \$150,000 General Fund expense, plus cash funds derived from outside monetary support and federal funds. There is no basis to disagree with the agency estimate of \$265,669 in total program costs for FY17-18 and \$399,458 total program costs in FY18-19.

Explanation of Estimate:

This bill will amend existing statute for the Department to establish and administer an incentive based program intended to increase the purchase of fresh fruits and vegetables by low-income consumers participating in SNAP by providing a point of purchase match in retail stores and farmers' markets. The program budget and activities are based on a proposal submitted by the Department in December 2016 for a USDA-NIFA FINI grant in direct cooperation with the University of Nebraska's Extension system and supported by 15 other industry and community partners. This program, with the federal funds requested and outside monetary support pledged in the amount of \$85,834 in 2017-18 and \$121,667 in 2018-19, will provide policy, system, and environmental interaction with the target Nebraska audience to ensure ongoing, measurable success. The Department's Administrative cost is estimated to be .15 FTE Agriculture Promotion Coordinator and .075 FTE Federal Aid Administrator and would be a realignment of existing staff.

LB 260 creates the legislative intent to appropriate \$150,000 from the General Fund to NDA to increase the amount of Aid payment to active participants.
