Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

This bill would create offense of assault on a peace officer, firefighter, or out-of-hospital emergency care provider by ambush. This new offense would be a Class IB felony (Maximum - life imprisonment, Minimum - twenty years imprisonment). The bill imposes a minimum term of forty years' imprisonment, and additionally it provides that the person may be fined up to one hundred thousand dollars.

The Department of Correctional Services (NDCS) states that this bill has the potential to lengthen sentences of individuals convicted after the effective date of the act, but the fiscal impact of the longer sentence would be felt at the end of the sentence. As a result, NDCS estimates no fiscal impact from this bill during FY18 or FY19.

Explanation of Estimate:

LB 577 creates the offense of assault on a peace officer, firefighter or out of hospital emergency care provider by ambush, punishable as a Class IB felony with a 40 year minimum sentence.

The crime is defined as knowingly attacking a peace officer, firefighter or out of hospital emergency care provider engaged in their official duties by either:

- (1) attacking without warning from a concealed position; or
- (2) approaching and attaching such an individual unexpectedly; and

Intentionally and knowingly causes serious bodily injury to the peace officer, firefighter or out of hospital emergency care provider.

The conduct prohibited by LB 577 is rare and individuals charged with assault of a peace office by ambush can currently be charged with other charges such as assault on an officer or attempted murder. LB 577 has the potential to lengthen sentences of individuals convicted of assault by ambush after the effective date of the act, but the fiscal impact of the longer sentence would be felt at the end of the sentence. As a result, NDCS estimates no fiscal impact from this legislation during the FY17-8, FY 18-19 biennium.
