Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 748 would revise six sections of law to allow the most recent federal decennial census <u>or</u> the most recent revised certified count by the United States Bureau of the Census to be used when determining the population of a municipality. Current law allows only the most recent federal decennial census to be used to determine municipal population.

Section 3 of LB 748 would amend the language for minimum population thresholds set for categories under the Civic and Community Center Financing Act. The words "at least" would replace the words "more than" when designating the minimum population eligible for a grant category.

LB 748 would also amend references to municipal governing bodies under Section 19-3052.

It is estimated that there would be no fiscal impact to the Department of Economic Development to make the adjustment to the population thresholds under the Civic and Community Center Financing Act. Any fiscal impact to municipalities is estimated to be minimal in nature.
