LB 734 amends the Nebraska Liquor Control Act, Section 53-124.11 regarding special designated licenses.

The bill inserts new language that would restrict certain sales under a special designated license. Holders of a farm winery license, a craft brewery license, a microdistillery license, or a manufacturer's license would be authorized to sell only the product produced by the licensee under the provisions of the special designated permit.

The Nebraska Liquor Control Commission indicates no fiscal impact as a result of the provisions of LB 734.

We agree with the Nebraska Liquor Control Commission's estimate of fiscal impact.
