Explanation of Estimate:

LB1058 creates the Faithful Delegate to Federal Article V Convention Act. Following the calling of an Article V convention, the Legislature shall elect five delegates and five alternate delegates from the members of the Legislature, unless the number of delegates is changed by Congress. The delegates and alternate delegates are to be reimbursed for actual expenses in the performance of their official duties. Because an Article V convention has not yet been convened and the actual number of delegates has not yet been determined, an actual cost estimate cannot be determined at this time.
