**Explanation of Estimate:**

LB 1027 relates to the restoration of voting rights for electors convicted of felonies. It removes the 24 month waiting period after the completion of the felon's sentence. The statewide voter registration system will need two enhancements in order to comply with this requirement. Our vendor will have to re-code the system at a cost of \$3,940.
