Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

This bill removes the requirement that the Department of Health and Human Services contract with one or more recovery audit contractors.

Most Medicaid services that the recovery audit contracts apply to are now paid through managed care and managed care contracts are exempt from the recovery audit contract provisions. When the recovery audit contract provisions became law, managed care provided a much smaller amount of services. With the expansion of managed care, the amount of payments the provisions apply to are relatively small and it's no longer feasible for contractors to bid on the contracts. There is no fiscal impact.
