Sec. 8-602 directs the Department of Banking and Finance to charge and collect various fees. Among these is a \$15 annual fee for renewal of executive officer's and loan officer's licenses. LB258 would eliminate this annual license renewal fee. The Department indicates that 926 related licenses are currently active and that elimination of the license renewal fee is estimated to result in an annualized reduction to cash fund revenue in the amount of \$13,890.
