Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 486 is the Veteran and Active Duty Supportive Postsecondary Institution Act. The bill requires the Department of Veterans Affairs (DOVA) to establish a process for a postsecondary institution to apply to be designated as Veteran and Active Duty Supportive. Institutions must meet five of eight criteria specified in the bill to receive the designation for a three year period. The DOVA is to develop a process for institutions to apply for the designation and maintain a list of institutions with the designation on its web site. Rules and regulations may be adopted for the act.

<u>DOVA Expenditures</u>: The Department of Veterans Affairs indicates the bill will increase the workload of the department and may minimally increase expenditures by an unknown amount. The agency indicates it can handle the increased workload and possible expenditures with existing staff and resources.

<u>Postsecondary Institutions</u>: The University of Nebraska, state colleges and technical community colleges indicate the bill will have no fiscal impact for these entities.
